Convention 2019: Chairman O'Kelley read his report. (Atch X)

Certified National Recruiter: PDC Lyons announced the names of DPA Recruiters receiving 3-5 Recruiting Pins and those receiving Gift Certificates. These recruiting awards were presented by Junior Vice Commander-in-Chief Roesch and DPA Commander Verville. (Atch Y) Commander Verville recessed the Convention at 1100 hours for lunch. Convention reopened at 1300 hours.

A short recess in Convention business was taken at 1320 hours and DPA Quartermaster Callaghan introduced the Honorable Gregorio "Kilili" Sablan, Representative to the U.S. Congress, House of Representative, for the Commonwealth of the Northern Mariana islands, who gave our Convention an update on Veterans issues within the U.S. Congress and other issues affecting Veterans and his work within the Congressional sessions.

Commander Verville announced that all nominations would remain open until tomorrow's business session, (12 June 2019). He then had the Sergeant at Arms prepare the room to salute the colors and called a recess at 1430 hours to reconvene tomorrow, 12 June 2019, at 0900 hours.

Adjutant Chaplin reminded the Convention Members of the "Membership Training" to be conducted by National Director, Membership, Rick Butler, starting at 1500 hours.

Commander Verville reconvened the convention at 0900 hours, 12 June 2019.

Commander Verville reopened Nominations of Officers for 2019-2020:

For each of the above Officer positions, Commander Verville asked if there were any other nominations. No further nominations were made for any of the above positions. For each position, motions were made and seconded to close the nominations for those positions and the Adjutant was directed to cast one unanimous vote for the nominated Member. **All Motions Passed.**

Commander Verville announced the new DPA elected officers as those listed above and the Convention extended their congratulations to the newly elected DPA officers.

New Business:

• Adjutant Chaplin presented a National Resolution, "Equitable Education Benefits For Dependents". He briefed that Anthony Lowe, Associate Director, Economic Opportunity, National Veterans Service, VFW Washington Office, had requested that Department of Pacific Areas resubmit this Resolution. (Atch Z)

This Resolution was approved by Post 2485, Angeles City, and District VII (Philippines). Motion was made and seconded to submit the Resolution to VFW National. **Motion Passed.**

• Adjutant Chaplin made a motion, which was seconded, for proposed Amendments to DPA By-Laws. These proposed amendments were previously presented at the Mid-Term C of A, December 2018, by PDC Gilbert. (Atch AA)

Add Section 504; Section 504 – Residence Requirement: All members of the Council of Administration must reside within the Geographic area of the Department of Pacific Areas. Those changing their primary residence during the year will forfeit their position and the position declared vacant. Section 604- Term of Office: paragraph a; add section 504 to sentence

Section 702 – Removal of Elective Officers or Committee Members: add paragraph

3 - Forfeited their position through change of primary residence outside the Department area.

Section 1404 – Consolidation of Posts: add into the sentence "following consultation with and concurrence of DPA Commander".

Following brief discussion. Motion Passed.

• Adjutant Chaplin made a motion, which was seconded, for proposed Amendments to DPA By-Laws. These proposed amendments were made by DPA Quartermaster Callaghan. (Atch BB)

These changes in wording involve Article VIII, Section 803 – Duties of the Quartermaster; and changes in Article XII, Section 1202 – Audits No discussion. **Motion Passed.**

• Adjutant Chaplin made a motion, which was seconded, for proposed Amendments to DPA By-Laws. These proposed amendments were made by District V Convention. (Atch CC)

These proposed amendments involve Article IV, Section 401 – Composition; Article V, Section 501 – Elected Officers; Section 502- Appointed Officers; and Article IX, Section 901 – Composition

Following much *spirited* discussion, it was decided to take each proposed Section amendment separately for clarity as to what amendment was being voted upon.

Section 401: Motion was made and seconded to add the Department Service Officer to the Composition and add paragraph (f) in the absence of the DSO. **Motion Passed.**

Section 501 and 502: Motion was made and seconded to remove the Judge Advocate and Surgeon from Section 501 "Elected Officers" and place them in Section 502 "Appointed Officers". **Motion Failed.** Judge Advocate and Surgeon positions will remain as "Elected Officers".

Section 901: Motion was made and seconded to leave the Inspector and Surgeon in the C of A Composition and to add the Department Service Officer to the Composition. **Motion Passed.**

• District V Senior Vice Commander, Randy Riggs, gave an outstanding power point presentation bid for Post 9951 and District V to host the June 2020 DPA Convention, at the Windsor Suites Hotel, Bangkok, Thailand, June 2020. No other Convention bids were presented. Motion was made and seconded to accept the bid from District V and Post 9951 to host the DPA Convention in Bangkok, Thailand. **Motion Passed**.

Good of the Order:

- Adjutant Chaplin announced the District Commanders/Quartermasters and Post Commanders/Quartermasters to receive their All-State VFW caps. Six (6) Districts and eighteen (18) Posts received their caps at this time, which were presented by Junior Vice Commander-in-Chief Roesch and DPA Commander Verville.
- Adjutant Chaplin acknowledged the outstanding performance by Convention appointed Sergeant at Arms, Justin Howe.
- QM Callaghan, Convention Chairman O'Kelley, and District III Commander Maxson gave some closing comments.
- Commander Verville invited Junior Vice Commander-in-Chief Roesch for any remarks or comments. JVCinC Roesch thanked the Department for a commendable year and emphasized the need to continue all efforts. He mentioned a recent change (in the past few days) to the VFW All American program.

There being no further business to come under the Good of the Order, Commander Verville called a recess at 1045 hours to reconvene at 1800 tonight for the Installation Ceremony and dinner banquet.

Commander Verville reconvened the Convention at 1800 hours. Following dinner, Commander Verville called upon Adjutant Chaplin to be Master of Ceremonies for the Evening Session. Junior Vice Commander-in-Chief Roesch and DPA Commander Verville presented the DPA Awards. Adjutant Chaplin called upon Commander Verville for his final words as Department Commander. Commander Verville addressed those gathered and then called upon Junior Vice Commander-in-Chief Roesch to perform the Installation of officers for the ensuing year. JVCinC Roesch then installed Ricky Farris as the new Department of Pacific Areas Commander. Commander Farris was introduced

and provided his opening remarks, expectations, and words of encouragement.

There being no further business to come before the Department of Pacific Areas Convention, Commander Farris asked the newly installed officers to remain in order to conduct some final business then he conducted the closing ceremonies according to VFW Ritual.
