Nominations and Elections 2021-2022



We are now in the nomination and election season for all posts and districts in the VFW for the 2021-2022 term.

Nominations are opened at the post general membership meeting in March and remain open until elections at the post general membership meeting in April. Section 216 & 217 of the National Bylaws and Manual of Procedure provides guidance.

District nominations are opened at the meeting prior to the District Convention and remain open until the election during the District Convention. Section 416 & 417 of the National Bylaws & Manual of Procedure provides guidance.

In April posts will be electing those officers as well as the delegates for districts and department conventions. It is important to carefully consider your nominations and elect worthy leaders for all officer and delegate positions. Remember, you are electing the leaders of your post or district and they set the tone for your organization. It is also helpful to elect a Commander who is familiar with the chain of command within our organization and if possible, someone who is known at the Department level to be an honest, thoughtful, and dedicated comrade.

The process of electing delegates is laid out in the National Bylaws and Manual of Procedure, as well as in your District and Department Bylaws. If you have questions or are unsure of the process, go to the District or Department JAG and they will provide answers or get you an answer as required.

To quote from Sec 222 of the Manual of Procedure: Delegates and alternates for the District Convention and Meetings, Department and National Conventions shall be elected at a regular meeting in April. Delegate strength shall be based on members in good standing as of March 31st. The National Bylaws Section 222 further directs that Delegate strength shall be one for every thirty members or fraction thereof in good standing. Delegates and alternates shall be elected in accordance with the Manual of Procedure. Delegates elected under this section shall not be considered instructed and may exercise full authority in the duty to be performed.



UPCOMING COMMEMORATIVE DATES



1 May Loyalty Day - Loyalty Day originally began as "Americanization Day" in 1921 as a counter to the Communists' May 1 celebration of the Russian Revolution. On 1 May 1930, 10,000 VFW members staged a rally at New York's Union Square to promote patriotism. Through a resolution adopted in 1949, May 1 evolved into Loyalty Day. Observances began in 1950 on April 28 and climaxed May 1 when more than five million people across the nation held rallies. In New York City, more than 100,000 people rallied for America. In 1958 Congress enacted Public Law 529 proclaiming Loyalty Day a permanent fixture on the nation's calendar.



May 8 V-E Day - On May 8, 1945 - known as Victory in Europe Day or V-E Day - celebrations erupted around the world to mark the end of World War II in Europe. The war had been raging for almost five years when U.S. and Allied forces landed on the beaches of Normandy, France, on June 6, 1944. The invasion signaled the beginning of the end for Adolf Hitler and Nazi Germany. In less than a year, Germany would surrender, and Hitler would be dead.



31 May 2021 Memorial Day - Memorial Day is an American holiday, observed on the last Monday of May, honoring the men and women who died while serving in the U.S. military. Originally known as Decoration Day, it originated in the years following the Civil War and became an official federal holiday in 1971. Many Americans observe Memorial Day by visiting cemeteries or memorials, holding family gatherings and participating in parades. Unofficially, it marks the beginning of the summer season.



6 June 1944 D-Day - On 6 June 1944, more than 160,000 Allied troops landed along a 50-mile stretch of heavily-fortified French coastline, to fight Nazi Germany on the beaches of Normandy, France. Gen. Dwight D. Eisenhower called the operation a crusade in which, "we will accept nothing less than full victory." More than 5,000 Ships and 13,000 aircraft supported the D-Day invasion, and by day's end, the Allies gained a foot-hold in Continental Europe.



14 June Flag Day - Flag Day is celebrated by Americans on June 14 each year and commemorates the adoption of the Stars and Stripes as the official flag of the United States. Many Americans celebrate Flag Day by displaying the Red, White and Blue in front of homes and businesses. Some communities, schools and veterans' organizations hold Flag Day parades, essay contests, ceremonies and picnics.

17th of January 2008,
VFW Post 12074 was originally named after
the Squadron Leader John "Scarsdale Jack"
Newkirk who was killed near Chiang Mai,
while assigned to the AVG during WWII.

The newspapers called him "Scarsdale Jack,"
though he was actually a native of New York
City, he had worked as a copy boy for Time
magazine. He also served a three-year hitch in
the U.S. Army as an infantry lieutenant, before
switching to the Navy and flying. Somewhere
in there he apparently also flew for American
Airlines.



“Scarsdale Jack” was a fighter pilot aboard the Yorktown when he volunteered for the AVG. At the age of 27, with his leadership and training, he was already a dominant figure in the group before he arrived in Burma. When he flew his final mission on the Chiang Mai raid he had been credited with 7 air-to-air victories.

“SSGT Brooks as a Station Chief provided direction and supervision for 44 Firefighters , managed an 18 million dollar vehicle fleet, responsible for five districts , and protected the Air Force largest Combat Wing . His superb skill set was vital in the extinguishment of a 350 thousand dollar military family housing fire. He employed fire ground tactics, techniques and procedures protecting 28 responders, four families and saved three adjacent units. He battled United States Forces Japan largest Hazmat fire. As Lead Firefighter he directed members during a nine hour blaze, salvage and overhaul. His actions halted the chlorine release safeguarding seven thousand base populace and 134 First Responders “



Department leadership would like to tip our caps to all of our Posts/Districts for the efforts given to our membership program this year. With the continued lockdowns and restricted travel, the numbers we show at National is phenomenal and thanks to our great recruiters!!!

We also understand that we have Posts who because of the pandemic cannot do the recruiting drives they are known for this year. Because of this, Commander Stein recently has authorized a modification of the membership program. Effective immediately through the end of the Term (June 2021), Posts are encouraged to contact their unpaid annual members with the intent to have them go Life! Under this modification, the Department will pay \$100 to all Posts when an unpaid/expired Comrade upgrades to Life Membership. Details have been sent to the District Commanders. As of this time there are Posts participating with this change.

Comrades, the Department is in a very unique position as it relates to the Award Program this year. I am sure everyone understands with this pandemic. Of course, traditionally April 15th is the cutoff date for Posts to meet the All State requirements to have their Caps presented at the Department Convention. We may have to make adjustments if we are not able to hold our Convention. We also still must present Awards from the 2019-20 year. So please be patient as we work to find a solution that will best handle this unique situation for both years.

All State/All American Caps: Again, at this time, the plan is to have them presented at the Department Convention in June 2021. Annual Awards Plaques will also be presented at that time. Same for the 2019-20 term.

Attached is the All State Spreadsheet as of this date. As you can see we have several Posts in position to make All State very soon! A big question right now is Posts wanting to know status of the Action Corp Weekly. Comrade Jonathan Brazee, our Legislature Chairman has sent out emails to the Districts to have forwarded to the Post Commanders requesting an email be sent to him for credit. He will then forward to me and I'll update the Spreadsheet. Officially, he has only heard from three Posts at this point this year. Congratulations to D4/D7 for meeting the requirements of All State! The Spreadsheet will be posted on the DPA Website.

8 STEP VA CLAIMS PROCESS

STEP 1

VA CLAIM SUBMITTED AND RECEIVED PHASE

- In Step 1, the VA will let you know they've received your disability claim.
- If you file your disability claim online, you'll get an on-screen message from the VA after you submit the online application.
- If you mail your application, the VA will send you a letter to let you know they've received your claim.
- You should get this letter in 1-2 weeks. It should show-up in eBenefits within 7-14 days.
- Any questions, please call the VA hotline phone number at 1-800-827-1000 and speak to a VA representative. This step normally takes around 7-14 days.

STEP 2

VA INITIAL REVIEW PHASE -UNDER REVIEW

- In Step 2 of the VA claim process, a Veteran Service Representative (VSR) will review your claim (Under Review)
- The process will move to Step 3 if the VA doesn't need any more evidence to support it.
- This is unlikely unless you submit a Fully Developed Claim, which is highly recommended.
- Do NOT submit a standard claim unless you have to.
- This step normally takes around 7-21 business days.

STEP 3

VA GATHERING OF EVIDENCE

- In Step 3, the VSR will do three things:
 - 1) Ask for evidence from you, health care providers, governmental agencies, or others.
 - 2) Review the evidence.
 - 3) Move the claim to an RVSR for decision.
- If the VA needs more evidence during this phase, your claim may return to this step more than once. It is very common to see your VA claim move back and forth between these phases, no need to worry!
- This step normally takes around 30-60 business days.

STEP 4

VA REVIEW OF EVIDENCE

- In Step 4, all required evidence has been received and is now being reviewed by the VSR assigned to your claim.
- If upon further review it is determined that additional evidence is required, the claim will be sent back to Step 3.
- Don't worry! This is a very normal part of the VA claim process.
- This step typically takes around 7-14 business days.

STEP 5

PREPARATION FOR DECISION

- In Step 5 of the VA claim process, your entire VA disability claim file gets sent to the RVSR.
- The RVSR will review your entire claim application, medical records, supporting documents, personal statements, buddy letters, any other supporting information, and C&P exam results to make a decision on your VA disability claim.
- The RVSR then recommends a decision and begins the process of preparing the necessary documents to detail the decision they have made.
- This step normally takes 7-14 business days.

STEP 6

PENDING DECISION APPROVAL

- In Step 6, the RVSR's decision recommendation documents are reviewed, and a final award approval on your claim is made.
- Usually sent to a second tier reviewing authority for final approval.
- This step typically takes 7-14 business days.

STEP 7

PREPARATION FOR NOTIFICATION

- Your VA Disability Claim decision packet, in its entirety, is now prepared to be mailed to you.
- This step usually takes around 7-14 business days.

STEP 8

DECISION NOTIFICATION SENT

- The final step of the VA claim process is where the VA will send you a packet by U.S. mail that includes details of the decision on your claim.
- Decision Notification Sent
- You should receive this in 7 to 10 business days.
- You can always call 1-800-827-1000 and ask to speak to a VA representative about your VA disability claim status.

Who We Are

The Veterans of Foreign Wars of the United States is a nonprofit veterans service organization comprised of eligible veterans and military service members from the active, guard and reserve forces.

We trace our roots back to 1899 when veterans of the Spanish-American War (1898) and the Philippine Insurrection (1899-1902) founded local organizations to secure rights and benefits for their service. Many arrived home wounded or sick. There was no medical care or veterans' pension for them, and they were left to care for themselves.

In their misery, some of these veterans banded together and formed organizations that would eventually band together and become known as the Veterans of Foreign Wars of the United States. After chapters were formed in Ohio, Colorado and Pennsylvania, the movement quickly gained momentum. Today, membership stands at more than 1.5 million members of the VFW and its Auxiliary.

Our voice was instrumental in establishing the Veterans Administration, development of the national cemetery system, in the fight for compensation for Vietnam vets exposed to Agent Orange and for veterans diagnosed with Gulf War Syndrome. In 2008, we won a long-fought victory with the passing of a GI Bill for the 21st Century, giving expanded educational benefits to America's active duty service members, and members of the guard and reserves, fighting in Iraq and Afghanistan. We were the driving force behind the Veterans Access and Accountability Act of 2014, and continually fight for improved VA medical centers services for women veterans.

Besides helping fund the creation of the Vietnam, Korean War, World War II and Women in Military Service memorials, in 2005 the VFW became the first veterans' organization to contribute to building the new Disabled Veterans for Life Memorial, which opened in November 2010. And in 2015, we became the first supporter of the National Desert Storm War Memorial which is planned for construction at our nation's capital.





Greetings Comrades,

Roberts Rules of Order Newly Revised, on transacting business at “electronic meetings,” [when electronic meetings are authorized] – always requires a bylaw provision. In our case, sections 203 and 403 of the national bylaws provides us with that option – provided additional rules have been adopted to govern their conduct. Such additional rules, may be placed in the bylaws, adopted as special rules of order or standing rules, or contained in instructions from a superior body.

Until we know what guidelines is forthcoming with the rewrite of the National Bylaws and Manual of Procedures. It is recommended you hold off on changing your bylaws and for now adopt special guidelines for conducting electronic meetings.

Nomination and Election of Post Delegates; In April each year, every post is required to nominate and elect delegates. A person authorized to represent you and your post at not only the annual convention but also regular and special meetings held throughout the ensuing year. You elect these delegates to give you a voice on important issues that may be introduced. Which includes, the election of officers.

Each post is authorized one delegate and one alternate for every 30 members in good standing according to the VFW Membership Stats posted on 31 March each year.


In Accordance with The National, VFW Bylaws and Manual of Procedures delegates shall not be considered instructed and may exercise full authority in the duty to be performed. When this decision is not unanimous each delegate, (present and voting) is entitled to cast their pro-rata share of the delegate strength. It is permissible for one (1) delegate to cast the entire delegate strength and one delegate can also cast a split delegate vote.

Nominate and elect your delegates wisely. Canvas your members on important issues and ensure your delegates express what’s in the best interest of you and your post.



You've all heard that membership is the lifeblood of our organization. If that's the case, then Life Membership is what keeps the heart healthy. With the changes made by Commander Stein to the DPA Membership Program, there are significant reasons to increase your Post's Life membership. Especially when you convert annual members to life members. So where do you start?

In the Online Membership System, every Post Quartermaster has the ability to print out a roster of all your members. He simply goes to "Reporting" on the left side of his computer screen, and then opens "Post Query". Select All as the option and a list of every member will appear. In the Print view, the size is reduced for easy printing.

This list gives you all the information National has in their database on every member of your Post: Card Number; Name; Address; City, State and Zip Code; Type membership; Pay date; email address, phone number; and if they are an annual member, how many days are left before the membership expires. This is everything you need to contact the member and encourage him to convert to life membership by offering him \$100 or \$200 off to convert, depending on your Post contribution. Our Post voted to add an additional \$100 discount as Commander Stein suggested. We have already had one member who lives in Florida and another who lives here take us up on the offer. 

Therefore, I am asking for your support to become the Department Surgeon for the 2021-2022 term. I would like to work on important health issues affecting veterans in our department.
