Comrades,

I hope you have all been successful in keeping your New Year's resolutions. As we move past the holiday season, we can heave a sigh of relief with VOD; Patriots Pen; Teachers; and Public Servant National Awards behind us. Now we move on to the second half programs and activities.



<u>Thailand Disaster Relief.</u> The fundraising to assist VFW members is ongoing. Area Coordinators, Jim Oden and Al Serrato, should soon be able to give an assessment of the damage. After that, we will give a notice to all Commanders and request that all donations be sent to the Department QM. After that we will submit a request for matching funds to National. Then we will begin the process of providing financial relief to our members. The Department QM reports around \$4,000.00 in donations already received.

<u>Member Recognition</u>. Every Post knows who their outstanding members and supporters are. Begin preparing nominations soon. The nominating letters are the key to the selection process.

<u>National Programs</u>. Here are some of the National programs deadlines: Scout of the year nominations must be submitted to the Post by 1 March. Post winners must be submitted to Department by 1 April; National Certificates of Recognition must be submitted to National by 1 March so that certificates can be ready for distribution at our Convention. Your list of awardees should be submitted to Department at the earliest possible time; the deadline for the Department submission of the Fred C. Hall Post Special Project is 30 April. We have a number of Posts with outstanding projects that fall within this category.

<u>Recruiting</u>. If one of your resolutions this year was to move forward with recruiting I would have to say that you were definitely successful. In January the Department added 225 members to the roster. This was the best month (so far) for recruiting.

As of 1 February we had nine Posts and one District at, or over, 100%. Fifteen Posts are in the 90th percentile. Seven Posts are within 10 members of reaching 100%. Only two Posts are in the 80th percentile and I feel confident that they will get over that hump very soon.

In the National standings we are still doing well, holding on to the number two position. Nevada sprinted ahead of us and is holding a 1.5% lead. If we can keep up our current level of recruiting we still have a good chance at the top spot.

Thank you all for everything that you are doing. Keep up the good work. God Bless America

Department Elections

It is that time of the year to begin thinking about the coming Department elections in June. There are elected and appointed positions to be filled each year. So, think it over. Talk to others about your interests. Many of us never thought we would have served in some of the positions we have held when we first joined the VFW. Some comrades are content with serving at the Post level, which is where the real support for our organization comes from.



Tradition

Some positions are filled through tradition in our Department. Rarely would a comrade just come out and run for Commander without first working through the other top chairs of Jr. Vice and Sr. Vice Commander.

At times there seems to be no one interested or having time to serve. Perhaps they think too many others will be running and they do not have a chance to win election. Put this aside and if interested, run for office.

I mentioned tradition and that has a lot of meaning in our organization. It is the unwritten custom that unofficially guides an organization from year to year. It is seen in some of our ceremonial activities and blends into some of our official functions. One way that it blends into an organization is as I mentioned in the election of Sr. Vice Commander and Commander. Over the years it also was unofficially applied to other elected positions such as Quartermaster and Judge Advocate. As long as they were serving us well and had the desire to keep on, basically it was theirs by a unanimous vote. Once in a while someone would run against them. Periodically over the years as it came time for our Department to elect a District 16 Councilman, we would by tradition look to the senior Past Department Commander who had not yet served in that position. If not available, then we would go down through the line to the next senior PDC until one was identified who was available and willing to serve. It is done the same way in the MOC Grand of Pacific Areas for the Supreme District 15 Councilman from Past Grand Commanders.

These examples are not written in our bylaws. They are not official, but have evolved over many years and came to be a tradition we went by. At times the Department has had to reach out and elect comrades who had not given it consideration at first. But the need was there when tradition could not be followed for reasons that the anticipated comrade was not available for significant reason, other dedicated comrades accepted the call and served us well.



Comrades, in a few months it will be time to consider nominations and election of officers for both Posts and Districts for 2012-13 term of office. So, in this month's issue I will present questions and render answers on some by-laws and parliamentary procedures concerning the forthcoming elections.





101 NOMINATIONS AND ELECTIONS

The following are questions with answers that may come up at nominations and election time:

Question: When do nominations commence and for how long?

Answer: Nominations for Posts normally shall start in March and end in April at election time. Districts may open nominations in the meeting prior to their Convention and then continue at the annual Convention prior to elections.

Question: Does a member have to be at a meeting or Convention to be nominated?

Answer: No, if the comrade making the nomination of an absentee for any office presents to the Adjutant, in writing, the consent of the member being nominated prior to the opening of nominations.

Question: If I'm nominated for office do I have the right to decline the position for which I was nominated?

Answer: Yes, any nominee may have the opportunity to decline the position for which he has been nominated before the close of nominations.

Question: Who determines what form of elections shall be used?

Answer: The membership at the March Post meeting prior to opening nominations or governing body to a Convention shall decide the form of election to use, unless By-Laws indicate the manner of elections. Normally, balloting for officers may be conducted by open or written secret ballot. Another method of balloting that may be used is the poll system and preprint ballots.

Question: If the Post decides at the March meeting to use the poll system with preprint ballots, are nominations held open until the April meeting? Answer: No, in the poll system, nominations are closed at the March meeting. Then the Post shall determine certain procedures used to conduct polling of the vote.

Question: What kinds of procedures are used in the poll system?

Answer: The Post may determine procedures such as date, time and where polling shall take place, who does the tallying and what happens in case of a tie. A Notice and preprinted ballots shall be distributed to members in good standing within a reasonable time prior to the date of voting. The notice shall contain the names of the candidates and a space for write-in candidates. There shall be no absentee or proxy votes when the poll system is used. Also, the greater number of votes rules when using the poll system.

Question: What's the difference between a majority vote and plurality vote?

Answer: A majority vote at election time is considered more than half of all votes actually cast. Whereas, a plurality vote means a person having more votes than any other person is the winner. (Note: National By-Laws call for majority vote of all votes cast, except where otherwise designated, shall be necessary to elect.)

Question: Who is eligible to vote at election time?

Answer: In Posts any member in good standing at the time of elections and at District Conventions those members in good standing that are part of the governing body defined in the District and/or National By-Laws.

Question: When is a member considered to be in good standing to vote at elections?

Answer: All Life members and annual members who have paid current annual dues to December 31 the year of elections.

Question: If I'm an elected two year Post House Committee member can I be elected to another Post office?

Answer: Yes, as elected committee members are not considered Post Officers, so you may concurrently hold an elected Post office.

Question: What happens when more than two candidates are nominated and there is no majority vote realized?

Answer: You would drop the comrade with the lowest amount of votes and continue successive ballots until the election is made.

Question: If the final vote is deadlocked, how is it decided?

Answer: There are two ways to decide a tie which are; 1) the units by-laws specify that in event of a tie vote, the candidates or their nominator or designated representative shall determine the result by lot or toss of the coin, or 2) if the by-laws are silent, a motion can be adopted in advance of vote stating in the event of a tie vote for a final choice, the candidates or their representatives or nominator shall decide the result by lot, or toss of the coin. (Note: Normally at conventions, the Rules of Order for the convention will state the second choice and shall be voted at start of the convention.)

Question: What happens if the By-Laws are silent and no motion was made in advance of voting concerning a deadlock and the vote is tied?

Answer: Pursuant to Demeter's Manual the Chair can't break a tie in elections, however, the Chair can call for <u>unanimous consent</u>, which means everyone in the meeting or delegates to a convention must be in favor for the candidates or their representatives or nominator to decide the election by lot, or toss of the coin. E.g., the Chair should normally ask; "is there any objection to having the method of deciding the election by lot, or toss of the coin in case of a tie". If there is <u>one</u> objection then a motion shall have to be made in advance of election for the method of breaking a tie and then re-election at the current meeting or convention shall be held.

Question: Who do I submit my grievances' to as I want to challenge the Post elections for irregularities?

Answer: Any challenge must be made in writing containing specific details concerning the irregularities, signed, and forwarded to the <u>District Commander by mail no later than three (3) days</u> after the election. (Note: If District election is challenged for irregularities the procedures are similar except an appeal shall be to the Department Commander.)

Question: What if I'm elected to a Post officer's position and can't make the installation?

Answer: If you're an <u>officer-elect</u> and absent for good reason you may be installed at any regular or special meeting prior to the convening of the Department Convention. If not installed your office is automatically vacant. Then after the Department Convention the Post shall go through the election process to fill the position and if elected you would be installed.

Question: What happens if a District officer-elect can't be at the District installation?

Answer: In the case of a District <u>officer-elect</u> not being installed for good reason shall be installed at any succeeding regular or special meeting of a unit of the organization, within sixty (60) days of the date of installation. If not installed, the office will automatically become vacant.

As you can see comrades there are various questions that may come up during the course of nominations and voting during election time that can be answered by reviewing the various by-laws at different levels of command, as well as consulting Demeter's Manual of Parliamentary Law and Procedure. COLD WEATHER HEALTH TIPS



The dangers of cold weather and how to stay warm.

In some areas of the Department of Pacific Areas, Comrades are experiencing some very cold weather. I would like to remind everyone of the health dangers of extreme low temperatures and tips on how to stay warm.

Frostbite / Hypothermia:

Without heat, exposure to cold temperatures can lead to frostbite and/or hypothermia. Parts of the body most commonly affected by frostbite include the face, ears, hands and feet. Frostbitten skin is whitish and stiff, and the area will feel numb rather than painful. To treat frostbite, warm the affected part of the body gradually. Wrap the frostbitten area in blankets, sweaters, coats, etc. and seek medical attention immediately. Do not rub frostbitten areas because the friction can damage the tissue.

Hypothermia is caused by a drop in body temperature to 95 degrees Fahrenheit (F) or less and can be fatal if not detected promptly and treated properly. The condition usually develops over a period of time, anywhere from a few days to several weeks. Even mildly cool indoor temperatures of 60 degrees to 65 degrees F can trigger hypothermia. Infants and the elderly are particularly at risk of hypothermia. Signs of hypothermia include:

- Forgetfulness

- Drowsiness
- Slurred Speech
- Weak Pulse
- Slow Heartbeat
- Very Slow, Shallow Breathing

Do not give a hypothermia victim a hot shower or bath because it could cause shock and do not try to treat hypothermia at home. The condition should be treated in a hospital.

Dressing for the cold:



If you need to be outside, the following suggestions will help keep you warm and protect your body from excessive heat loss.

- Wear several layers of lightweight clothing rather than one or two layers of heavy garments. The air between the layers of clothing acts as insulation to keep you warmer.
- Cover your head. You lose as much as 50 percent of your body heat through your head.
 - Wear mittens rather than fingered gloves.
- Wear warm leg coverings and heavy socks or two pairs of lightweight socks.
- Wear waterproof boots or sturdy shoes that give you maximum traction
- Cover your ears and the lower part of your face. The ears, nose, chin and forehead are most susceptible to frostbite. Cover your mouth with a scarf to protect the lungs from directly inhaling extremely cold air.

Shoveling:



Cold weather itself, without any physical exertion, puts an extra strain on your heart so know your limits when shoveling snow, especially if you do not exercise regularly. If you have a history of heart trouble or any chronic health concerns, talk to your health care provider before

shoveling snow. You should rest frequently and pace yourself when shoveling. Remember to lift the snow with your legs, not your back. If you use a snow blower, never use your hands to unclog the machine. If you become breathless, stop, go indoors and warm up before continuing. If you experience chest or arm pain or numbness, stop immediately and go indoors; you may need to call 911. Overexertion can cause sore muscles, falls and heart attacks.

Heating Safety:



For people still needing to use alternative sources of heat, here are a few reminders:

- Any heater that uses wood, coal, natural gas or kerosene produces carbon monoxide (CO), so adequate ventilation is essential.

- Never use a generator indoors, even with open doors or windows.
- Do not use charcoal or gas grills indoors.
- Do not use a gas oven to heat your home.

You cannot see or smell carbon monoxide, but at high levels it can kill a person in minutes. Symptoms of mild to moderate CO poisoning include headaches, dizziness, nausea and lethargy. Higher levels of CO exposure can cause fainting, confusion and collapse and if exposure continues, death can result.






- Are heat producing electrical appliances unplugged when you are not using them?
- Are electrical cords in good condition, not frayed or cracked?
- Are electrical outlets overloaded in your home?
- Are electrical cords kept out from beneath furniture and rugs?
- Do all outlets and light switches work?

Never use water on an electrical fire, you could get shocked. If the fire is small, turn the power off and use a multi-purpose (ABC) dry-chemical extinguisher to put out the fire. If you can't turn the power off, or the fire is large, evacuate your home and the emergency number for your location from a safe phone.

Service Officer Bits... News you may not be aware of...

- 1. House VA Discusses VA Rating Schedule: A little over a week ago ... the House Veterans Affairs' Subcommittee on Disability and Memorial Affairs discussed VA's Schedule for Rating Disabilities (VASRD). The Subcommittee members questioned witnesses on the differences between DOD and VA ratings systems, ratings they feel are often in direct conflict with each other, causing confusion for the veteran. VSO representatives highlighted equitable compensation for like injuries and that the VASRD has not been reviewed or updated to ensure that disability categories, rating percentages and compensation levels remain accurate. Other areas discussed by all included possible restructuring of the Individual Unemployability (IU) benefit, accuracy of claims and measuring quality of life payments. - 2. VA Extends Emergency Care Policy: A change in regulations the second week of January this year (2012), extends VA's authority to pay for emergency care provided to eligible veterans in non-VA facilities. More than 100,000 veterans are estimated to benefit by the new rule. "This provision helps ensure eligible veterans continue to get the emergency care they need when VA facilities are not available," said VA Secretary Eric Shinseki. VA currently operates 121 emergency departments across the country that are open 24 hours a day, seven days a week, plus 46 urgent care units, which provide care for patients without scheduled appointments. - 3. Retirement Changes Threaten All-Volunteer Force: In an opinion editorial just posted on the Stars & Stripes website, Our Commander, Richard DeNoyer is very concerned that negative qualify-of-life changes on a military still at war will destroy the all-volunteer force. He said constantly comparing civilian programs with military pay, retirement and health care plans --- while calling the military programs "too generous" --- is insulting, and so is any proposal that requires those who sacrifice the most for our nation to sacrifice even more. He said the VFW opposes all plans to change the military retirement system, and "we reject any proposal that would require military retirees to pay more for their earned healthcare programs."

- **4. VA Adds 47 Ships to Agent Orange List:** The VA has added 47 vessels to its list of Navy and Coast Guard ships whose crews may have been exposed to the defoliant Agent Orange. Former service members who served aboard these "blue water" ships as well as the more than 200 others listed in VA's database from 1962 to 1975 may be eligible for disability compensation. According to The Military Times, vessels recently added to the roster include the hospital ship Repose, which operated in close coastal waters from 1966 to 1970, and the transport ship General R.M. Blatchford, which landed elements of the 1st Infantry Division at Vung Tau in October 1965. Read more at: http://www.publichealth.va.gov/exposures/agentorange/shiplist/index.asp.
- 5. Physical Disability Board Review Update: Congress established a Physical Disability Board Review (PDBR) in 2008 to review disability determinations of veterans discharged between September 11, 2001, and December 31, 2009. Those with a combined disability rating of 20 percent or less who did not retire can apply for a review. Since the programs creation, only 5 percent of those eligible have applied to have their status reviewed. DOD is partnering with VA to reach out to others to notify them about the PDBR by sending letters to veterans this year. While the collaboration will help ensure that veterans have access to their benefits, eligible veterans can also directly contact the PDBR immediately through website. TRICARE PROVIDER LIST PHILIPPINES: The 1 February 2012 TMA and ISOS provided Certified Provider list available at http://www.tricare.mil/tma/pacific/pacificCertifiedProviders.aspx still does not offer any mechanism to easily identify added or removed providers nor is there any way to determine when existing previously certified provider's addresses or cities have changed. This is of concern to beneficiaries who have submitted or will be submitting claims because:

- Providers that have changes made to their addresses or city are of some importance as the changes may trigger disapprovals of previously approved claims for a provider when the receipts may no longer match the new addresses.
- Beneficiaries should be able to easily identify providers that have been decertified without having to check every provider on the list in their provider base every two weeks.
- Beneficiaries should be able to easily find added providers for those that have claims pending certification of a provider.
- There should be a convenient way for beneficiaries to determine new additions to the provider base in their area without having to review each and every provider in the entire list every two weeks.

Because of these concerns and to assist TRICARE beneficiaries residing in the Philippines the U.S. Military Retirees of the Philippines organization has provided a supplemental list to the 1 February 2012 Certified Provider List. The supplement is in 7 sections:

- Introduction
- Data Caveats

Department of Pacific Areas

- Providers Added Since 17 January 2012
- Providers Removed Since 17 January 2012
- Providers with Changed Addresses Since 17 January 2012
- Providers with Changed Cities Since 17 January 2012
- Providers with Phony Singapore addresses changed since 17 January 2012

This listing with each TMA/ISOS update of the certified provider list and the updates can be accessed at http://db.tt/3fROsC4T or viewed by opening the attachment to this message. Questions or comments regarding the updates list should be sent to us mil ret of the pi@fastmail.fm.

When the names or addresses of your providers do not match the "official" list, WPS must send ISOS a request to conduct a "new provider" certification, which has and will slow the reimbursement of the claim. It is recommended that beneficiaries verify the name, (spelling), and how it is listed on the certified provider list. Some examples of variance of the official receipts verses the certified provider list that have caused delays in the past are;

• Santos, John R., MD instead of Santos, John R., MD, (the missing space after the comma between the last and first name has caused the claims processor to request a new certification); • Santos, John Reyes, MD instead of Santos, John R., MD, which will also cause the claims processor to request a new certification.

The same problem will occur with addresses that are not identical on the "official receipt" as to that of the official certified provider list. Beneficiaries are encouraged to check the newest certified provider list for any provider that they have or are going to use and ensure that the official receipt name and address is identical to the certified provider list. If they find that it is not identical they should request the provider to give them a receipt that is identical. If that is not possible, then it is suggested they annotate the variances on the copy of the receipt sent with the claim and explain that this is the same provider as listed on the certified provider list. 89 Service Members Accounted For in 2011

In 2011, 89 service members were accounted for from past conflicts. Of those accounted for, 26 were from World War II, 39 were from the Korean War, and 24 were from the Vietnam War. A service member becomes "accounted for" only after their remains have been identified and the next of kin have been notified. For the past four years, there has been an increase in the number of service members accounted-for, a trend we hope will continue as the accounting community begins to increase its capacity in 2012.

Fiscal Year 2012 Budget for the Accounting Community

In FY2012, Secretary Panetta and the Department of Defense remain fully committed to supporting the accounting mission for all past conflicts. With the passage of the recent Defense budget, the DoD has increased funding for JPAC to meet statutory requirements to increase accounting from all past conflicts, including the emergent North Korea requirement.

Remains Recovery Operations in Laos

JPAC operations are temporarily suspended in Laos due to JPAC's decision not to renew the contract with the Lao company providing helicopter support to its operations there, and the Lao Government's subsequent rejection of JPAC's request to move the teams by vehicle. The decision not to renew the contract was prompted by safety concerns created when the Lao company began using helicopters not meeting Department of Defense safety standards for the JPAC mission. The Lao denied the subsequent JPAC request to move teams by vehicle, claiming road safety and security issues. If JPAC is able to renegotiate a helicopter contract with the Lao company for only those helicopters meeting U.S. Government safety standards, they may be able to resume operations later this spring. Alternately, Lao approval to move teams by vehicle will enable JPAC to resume limited operations in the country. The rugged terrain and lack of road network in areas where Americans went missing during the war make helicopter support to the JPAC mission in Laos critical. U.S. Ambassador Karen Stewart is fully engaged in these discussions with Laos, and the issue will be on the agenda during the Comprehensive Bilateral Dialogue with Laos, scheduled for February, in Washington.

Joint Personnel Recovery Agency Opens Training Facilities

In December, DASD Newberry traveled to Spokane, Wash. to participate in the ribbon cutting of the Joint Personnel Recovery Agency's (JPRA) three newest training facilities. These facilities provide more than 40,000 square feet of space for conducting specialized survival, evasion, resistance and escapes training (SERE). The unique design, tailored environmental conditions, and support areas of the facilities will allow instructors to create teaching environments, both academic and experiential, that are vital to specialized SERE training for U.S. personnel. The new facilities will also help JPRA provide research and development for SERE courses, curriculum design, and a myriad of additional support products to the Services and the Combatant Commands to meet their training requirements. These new structures are model examples that will meet current and emerging training requirements well into the 21st century.

Comrades remember our Nations fullest possible accounting mission is a sacred obligation to never leave a fallen service member behind. There is no compromise in fulfilling that mission. It is also a national priority that the President is committed to, a mission that other Nations wish they could emulate, and a mission in which success can only be measured by recovering, indentifying, and returning those we send to war back to their families and their country.

May God Bless Our Great Nation and please pass on the word let our voices be heard to help bring our Veterans Home!
