VFW CELEBRATES 115 YEARS OF SERVICE FROM 1899-2014 NO ONE HAS DONE DOES MORE FOR VETERANS



September 25, 2014 - On the evening of September 29, 1899, thirteen men — veterans who had fought on Cuba during the Spanish-American War — gathered at a tailor shop in Columbus, Ohio. They shared their accounts of what was then, the most popular war in America's history, but further, to discuss how they could assist their fellow veterans and the dependents of their fallen comrades.

These men could not have known then what would grow from such humble beginnings.

The simple and selfless desire to care for those who share in the common bond forged by war, laid the foundation for what has grown to become the multifaceted organization that is the Veterans of Foreign Wars of the United States.

Arguably the most recognized veterans service organization in America — and certainly the oldest and most accomplished — the VFW has evolved into nothing short of a powerhouse for veterans. It's the veterans service organization that has positively impacted the life of each American veteran, or at the least, helped to provide them the promise of opportunity and a better future.

Since its inception so long ago, the VFW has been a determined advocate for all veterans, service members and military families. Generations upon generations have joined in its cause, each as steadfast and determined to help fulfill the VFW mission as the last.

Before the VFW came into existence, veterans did not receive health care for wounds received in combat; most of them didn't receive any treatment for any disease or illness acquired as a result of military service; pre-VFW veterans had no reasonable expectation of receiving compensation of any sort.

The men who founded the VFW challenged the status quo and by doing so, helped shape the future for veterans forever.

It was the VFW that demanded America promise to graciously and appropriately care for those who bear the burden of war and put their lives on the line in defense of our nation and way of life. And throughout the years, it has been the VFW that has remained tenacious and resolute in its fight to ensure that America lives up to that promise.

Over its storied 115 year history, the VFW's efforts led to the establishment of the Veterans Administration. It helped to create the Montgomery and Post-9/11 GI Bills. It was a key player in the development of the national cemetery system. It led the fight for compensation for Vietnam vets exposed to Agent Orange and for veterans diagnosed with Gulf War Syndrome. It was a powerful

force in the passing of a record VA discretionary budget, the VOW to Hire Heroes Act, the reinstatement of military Tuition Assistance programs and most recently, the Veterans Access, Choice and Accountability Act of 2014. These achievements offer merely a glimpse into its long list of legislative accomplishments.

But, the effect the VFW has had on the lives of those who've worn the uniform, as well as those of their families, extends far beyond its advocacy efforts. Its programs and services are second to none and have provided a hand up to millions of those who have needed it and deserved it the most. Its service officers have helped hundreds of thousands of veterans recover billions of dollars in benefits and compensation from the VA. It has provided millions of dollars in grants to military families who've fallen on hard times, millions of free calls home for deployed and hospitalized veterans, and raised billions of dollars for needy veterans through its "Buddy" Poppy program.

VFW Posts have and continue to act as pillars of support in communities across America and abroad. Posts are often the first to organize and offer aid or assistance to local veterans and military families in need. They are the patriotic pulse of local communities, working to foster patriotism in our nation's youth, inciting good citizenship, erecting memorials, maintaining cemeteries, organizing community events and donating millions of volunteer service hours within their communities each year.

Though much has changed over the years, today's VFW operates by the same creed upon which it was formed back in 1899. It exists only to care for those who fight to ensure America remains a nation free from tyranny and fear. It's an organization that was created by veterans, for veterans, and owes all that it has accomplished over its many years to its members; the lifeblood of the organization.

No one has, does or will do more for veterans.


Department Officer's Comments


From the Department Commander:


From the Department Judge Advocate:

Comrades,

In this month's Typhoon article I will discuss policy and procedures for submitting amendments or a revision to Post, District and Department By-Laws. With that said, the following information is rendered for your connivance and review.

101 AMENDMENTS FOR BY-LAWS

The instructions from National indicate that if you want to propose a change to By-Laws it must be submitted as such, **not** as a resolution. This means **no "Whereas"** or **"Be It Resolved"**



In the examples below you will see that in documenting an amendment it is important to show clarification of; 1) **who** the amendment was proposed by, 2) **referenced** article and section that the amendment applies to, 3) **amend detail** of implantation and 4) **exact wording** of the proposed change. The following are some examples of what National desires when forwarding proposed amendments for Post, District, Department, or National By-Laws:

Example: Amending entire section wording.

Proposed by Post 007 (who)

ARTICLE XIV – APPROVAL, AMENDMENTS and CONFLICT (reference) Section 1402 – Amendments.

Amend Section 1402, Post 007 By-Laws, by deleting wording after the section title and substituting in its place the following; (amend detail)

These By-Laws may be amended by the Post with a two-thirds (2/3) vote of the members present at a stated meeting thereof provided each member has been notified at least twenty (20) day in advance and, upon request provided a copy of the proposed amendments. All amendments shall be forwarded through channels and reviewed by the Department Commander and the Commander-in-Chief before becoming effective. (exact wording)

Example: Amending section words.

Proposed by Department of Pacific Areas

ARTICLE II - POSTS

Section 220 - Vacancies and Removal of Elective Officers or Committee Members.

Amend Section 220, National Manual of Procedure, by deleting the word "majority" in the first sentence of paragraph four, and inserting, in lieu thereof, the following;

two-thirds (2/3)

Example: Amending by deleting and adding sentence(s).

Proposed by Department of Pacific Areas

ARTICLE V - OFFICERS ELECTED AND APPOINTED



Section 503 –Proof of Eligibility.

Amend Section 503, Department By-Laws, by deleting the second sentence of the section, and inserting in lieu thereof, the following;

The Adjutant shall ensure that proof of eligibility is on file with the Adjutant General of the Department Commander, Department Senior Vice Commander, Department Junior Vice Commander, Department Adjutant and Department Quartermaster

The above examples of proposed amendments for submission are definite and specific to deletions and exact wording and are considered correct procedure for documentation. Also, if many amendments are required a unit may consider submitting a proposed revision to the by-laws. The proposed amendments are then written into the whole document and highlighted as a proposed revision to the by-laws with cover letter for review by Department, and then forwarded to National for final approval.

Please note if a unit's current by-laws state in the last section; "Whenever these By-Laws or subsequent amendments may be found to be in conflict with the present or any future National and/or Department By-Laws the latter shall prevail and be binding upon this unit as though written herein". This statement may cover a unit's needs until such a time that a revision may be necessary to incorporate changes that occur over a period of time in National and/or Department By-Laws.

Who's the Originator

An originator of proposed amendments to by-laws may be a Post, District, Department officer or the Department Convention for Department and National By-Laws. In the case of Post By-Laws an officer or any member may submit proposals for adoption by the Post and forwarding as required. In the Districts the officers, a Post or the District Convention may submit proposals to District By-laws and if adopted at a Convention shall be forwarded for review and approval. In all instances where the originator is going to forward proposed amendments to by-laws a cover letter with an attachment containing the proposals shall be submitted through proper channels. Just remember that any proposed changes to by-laws being forwarded not in proper form, unclear as to meaning, or concerning matters clearly not within the scope and purpose of the VFW cannot be considered by Department or National.

In conclusion of my article the above information is provided to clarify how to draw up proposed amendments or a revision to by-laws. 



From the Department Quartermaster:

Comrades,

The new VFW membership application has several differences from the older version. You should discard the old ones and only use the new ones, especially if you mail your applications to National for processing. If you don't have the new ones, you can order them in packs of 25 from the VFW Membership Department. You can call them (not a good option in our time zones), or send them an email using the "Contact Us" option at www.vfw.org.

The first big difference is DATES OF SERVICE. Due to an IRS requirement, this block must be completed. But the dates have become simpler to record. All that is required are the dates the member joined the service to the date he/she left the service. Or record the start date to





New Life members have several options for payment. They may elect to pay if full using cash or credit card. Or they may elect to make an initial payment of \$45 and have the remainder automatically taken from their credit card in 11 equal installments. Finally, they may elect to make an initial payment of \$45 and have the VFW mail them a bill for the next 11 months. The recruiter should explain each option before asking the applicant to choose one. The installment plan amounts are listed on the back of the application's cover page.

If a new Life member elects to use the installment plan, the application MUST be mailed to National because the Online Membership System cannot process installment plans. The Post Quartermaster still needs to review every application and sign at the bottom.

From the Department Surgeon:

Comrades,

Well Comrades, it is that time again to provide inputs to the Typhoon and I am, as usual, late. October is Breast Cancer Awareness Month and it is a subject that should be of interest to men and women.

What is Cancer? Cancer is a broad term for a class of diseases characterized by abnormal cells that grow and invade healthy cells in the body. Breast cancer starts in the cells of the breast as a group of cancer cells that can then invade surrounding tissues or spread (metastasize) to other areas of the body.



What causes cancer to develop? Cancer begins in the cells which are the basic building blocks that make up tissue. Tissue is found in the breast and other parts of the body. Sometimes, the process of cell growth goes wrong and new cells form when the body doesn't need them and old or damaged cells do not die as they should. When this occurs, a build-up of cells often forms a mass of tissue called a lump, growth, or tumor. Breast cancer occurs when malignant tumors develop in the breast. These cells can spread by breaking away from the original tumor and entering blood vessels or lymph vessels, which branch into tissues throughout the body. When cancer cells travel to other parts of the body and begin damaging other tissues and organs, the process is called metastasis.

Facts about Breast Cancer in the United States: One in eight women will be diagnosed with breast cancer in their lifetime. Breast cancer is the most commonly diagnosed cancer in women. Breast cancer is the second leading cause of death among women. Each year it is estimated that over 220,000 women in the United States will be diagnosed with breast cancer and more than 40,000 will die. Although breast cancer in men is rare, an estimated 2,150 men will be diagnosed with breast cancer and approximately 410 will die each year.

A Global Burden: According to the World Health Organization, breast cancer is the most common cancer among women worldwide, claiming the lives of hundreds of thousands of women each year and affecting countries at all levels of modernization.

Good News About Breast Cancer Trends: In recent years, perhaps coinciding with the decline in prescriptive hormone replacement therapy after menopause, we have seen a gradual reduction in female breast cancer incidence rates among women aged 50 and older. Death rates from breast cancer have been declining since about 1990, in part to better due to screening and early detection, increased awareness, and continually improving treatment options.

Male Breast Cancer: All people, whether male or female, are born with some breast cells and tissue. Even though males do not develop milk-producing breasts, a man's breast cells and tissue can still develop cancer. Even so, male breast cancer is very rare. Less than one percent of all breast cancer cases develop in men, and only one in a thousand men will ever be diagnosed with breast cancer. Breast cancer in men is usually detected as a hard lump underneath the nipple and areola. Men carry a higher mortality than women do, primarily because awareness among men is less and they are less likely to assume a lump is breast cancer, which can cause a delay in seeking treatment. Of the men who develop breast cancer, the vast majority of those cases are Infiltrating Ductal Carcinoma (IDC), which means cells in or around the ducts begin to invade surrounding tissue. Very rarely, a man might be diagnosed with inflammatory breast cancer, or Paget disease, of the nipple. <u>Risk Factors</u>: Radiation exposure. High levels of the hormone estrogen. Family history of breast cancer, especially breast cancer that is related to the BRCA2 gene. <u>Signs & Symptoms</u>: Male breast cancer can exhibit the same symptoms as breast cancer in women, including a lump. Anyone who notices anything unusual about their breasts, whether male or female, should contact their physician immediately. Survival rates and treatment for men with breast cancer are very similar to those for women. Early detection of breast cancer increases treatment options and often reduces the risk of dying from breast cancer.

Genetic testing: Although treatment outcomes are very similar to women at the same stage of detection, a man diagnosed with breast cancer should also consider seeing a genetics counselor for a consultation. If a man tests positive for a defective gene (most commonly either BRCA1 or BRCA2) that can lead to a future diagnosis of breast cancer and his children have a 50% chance of carrying the gene. *In addition:* A male child of a man with breast cancer who inherits the defective BRCA2 gene has only approximately 6% chance of eventually developing breast cancer and just over 1% with BRCA1. A female child of a man with breast cancer who inherits the defective gene has a risk between 40% and 80% of eventually developing breast cancer. Men with a genetic predisposition to breast cancer are also at higher risk of getting prostate cancer at a younger age than usually diagnosed.

Doctors seldom know why one woman develops breast cancer and another doesn't, and most women who have breast cancer will never be able to pinpoint an exact cause. What we do know is that breast cancer is always caused by damage to a cell's DNA. *Known Risk Factors*: Women with certain risk factors are more likely than others to develop breast cancer. A risk factor is something that may increase the chance of getting a disease. Some risk factors (such as drinking alcohol) can be avoided. But most risk factors (such as having a family history of breast cancer) can't be avoided. Having a risk factor does not mean that a woman will get breast cancer. Many women who have risk factors never develop breast cancer.

Genetic Factors: Gender: Breast cancer occurs nearly 100 times more often in women than in men. Age: Two out of three women with invasive cancer are diagnosed after age 55. Race: Breast cancer is diagnosed more often in caucasian women than women of other races. Family History and Genetic Factors: If your mother, sister, father or child has been diagnosed with breast or ovarian cancer, you have a higher risk of being diagnosed with breast cancer in the future. Your risk increases if your relative was diagnosed before the age of 50. Personal Health History: If you have been diagnosed with breast cancer in one breast, you have an increased risk of being diagnosed with breast cancer in the other breast in the future. Also, your risk increases if abnormal breast cells have been detected before (such as atypical hyperplasia, lobular carcinoma in situ (LCIS) or ductal carcinoma in situ (DCIS)). Menstrual and Reproductive History: Early menstruation (before age 12), late menopause (after 55), having your first child at an older age, or never having given birth can also increase your risk for breast cancer. Certain Genome Changes: Mutations in certain genes, such as BRCA1 and BRCA2, can increase your risk for breast cancer. This is determined through a genetic test, which you may consider taking if you have a family history of breast cancer. Individuals with these gene mutations can pass the gene mutation onto their children. Dense Breast Tissue: Having dense breast tissue can increase your risk for breast cancer and make lumps harder to detect. Several states have passed laws requiring physicians to disclose to women if their mammogram indicates that they have dense breasts so that they are aware of this risk. Be sure to ask your physician if you have dense breasts and what the implications of having dense breasts are.

Environmental and Lifestyle Risk Factors: Lack of Physical Activity: A sedentary lifestyle with little physical activity can increase your risk for breast cancer. Poor Diet: A diet high in saturated fat and lacking fruits and vegetables can increase your risk for breast cancer. Being Overweight or Obese: Being overweight or obese can increase your risk for breast cancer. Your risk is increased if you have already gone through menopause. Drinking Alcohol: Frequent consumption of alcohol can increase your risk for breast cancer. The more alcohol you consume, the greater the risk. Radiation to the Chest: Having radiation therapy to the chest before the age of 30 can increase your risk for breast cancer. Combined Hormone Replacement Therapy (HRT): Taking combined hormone replacement therapy, as prescribed for menopause, can increase your risk for breast cancer and increases the risk that the cancer will be detected at a more advanced stage.

What Are The Stats: 60-70% of people with breast cancer have no connection to these risk factors at all, and other people with risk factors will never develop cancer.

These do not cause breast cancer: Breast cancer is not contagious; you can't contract cancer from a person who has the disease. Breast cancer is not caused by wearing underwire bras, implants, deodorants, antiperspirants, mammograms, caffeine, plastic food serving items, microwaves, or cell phones, as myths often suggest.

Well Comrades, I have provided you with all the information that I can related to Breast Cancer and probably more than many want to know, lol. Hopefully it will give some of us information that either we or loved ones may be able to use.



Fellow VFW Comrades,















This past month commemorated the 200th Anniversary of our National Anthem:

The Star Spangled Banner


It was during the War of 1812 and after the burning of Washington DC that Francis Scott Key found himself witness to the bombardment of Fort McHenry in Baltimore Md, by the British. During the stormy night of 13 September 1814, the fort was continually shelled by the British warships. The sky was filled with the noise of exploding bombs and shells and the flashes rockets going off. A small storm flag continued to fly during the night and in the morning of September 14, a larger flag was raised. The Americans had prevailed and won the battle.

Key was so inspired by the victory and the flying of the 15 star flag with 15 stripes that he penned a poem that he titled the Defense of Fort McHenry. On September 20th, two newspapers ie Baltimore Patriot and the American printed the song. It quickly became popular and later seventeen newspapers from Georgia to New Hampshire printed it.

Throughout the 19th century, the song gained popularity and bands played it during public events such as Fourth of July celebrations. The US Navy adopted the song to be played at the raising of the flag in 1889.

President Woodrow Wilson mandated that the Star Spangled Banner be played at Military functions and "other appropriate occasions" in 1916. The song began to be played at baseball games and was significant in the 1918 World Series during the seventh inning stretch. It wasn't until WWII that the song was played regularly before each game as it is today.

Incredibly the United States did not have a National Anthem until March 3, 1931 when then President Herbert Hoover signed a law making the Star Spangled Banner our national song.



Oh say does that Star Spangled Banner yet wave. O'er the land of the free and the home of the brave.

From the Department Legislative Committee Chairman:

Comrades,

Congress is back in session, and it has been a busy period for military and veteran-related issues. The VFW, at the national, department, district, and post levels remain busy in ensuring our rights are protected.

I had a chance to visit Post 10047 in Las Vegas last month (where John Stroud, our National Commander, once served as Post Commander). It was enlightening to see just how active post members are in our political process. Out in the Department of the Pacific, we don't have the easy access to our representatives and government functions, but we still have email, and we need to make sure our representatives don't forget about us. Make your voice heard!



Midterms are coming up. Know who is running in your district and make an informed vote. If we really care about veterans, we need to elect those who care as well.

Once again, I highly recommend that each member sign up for the VFW Action Corps Weekly. This weekly e-mail highlights VFW legislative issues of interest and is a good way to remain up-to-date on items that could affect veterans. To sign up, simply go to vfw.org, click on "VFW in D.D.," then go the National Legislative Service" link where you will find the current newsletter as well as being able to sign up for the newsletters to be e-mailed to you.

Here are some of the current legislative highlights concerning vets:

- 1. DOD Releases Military Health System Review: The Pentagon released a 200-page Military Health System Review that Defense Secretary Chuck Hagel had ordered in response to the access to care crisis at the Department of Veterans Affairs. The Military Health System encompasses 56 hospitals, 361 medical clinics and 249 dental clinics that serve a worldwide patient population of 9.6 million beneficiaries. Seventeen multiservice Military Treatment Facilities were selected for the review, which "found pockets of excellence significant excellence we are very proud of," said Hagel at a Pentagon briefing on Wednesday. Regarding surgical morbidity, or complication rates, three MTFs stood out in the top tier nationally: Travis AFB, Calif., Fort Gordon, Ga., and Tripler Army Medical Center in Hawaii. But the secretary also said the report "found gaps and facilities that must improve," which in the surgical morbidity category included eight of the 17 MTFs surveyed. Wrote one outside consultant, "Overall [Military Health System] performance mirrors what we see in the private sector, a good deal of mediocrity, pockets of excellence, and some serious gaps." Said Hagel, "We can do better." Read the report at http://www.defense.gov/home/features/2014/0614 healthreview/.
- 2. House Holds Hearing on Jailed Marine Sergeant: House Foreign Affairs Subcommittee Chairman Matt Salmon (R-Ariz.) held a special hearing Oct 1 regarding the plight of Marine Sgt. Andrew Tahmooressi, who has been languishing away in a Mexican jail for six months without any noticeable help from the White House or U.S. State Department. The sergeant's mother was the key witness. Jill Tahmooressi testified how her son's condition has significantly worsened because the Mexican government is unable to treat him for his diagnosed PTSD. The VFW led the way by twice calling on President Obama to phone Mexican President Nieto about Sergeant Tahmooressi, a simple call that subcommittee members also questioned why never took place. The VFW continues to call for a nationwide boycott of products and travel to Mexico until the sergeant is released. - 3. New Disabled Veterans Memorial Opens Sunday: The new American Veterans Disabled for Life Memorial opens in Washington on Oct 5. The President is expected to dedicate the VFW-supported memorial, and he will be joined by the secretaries of Interior and Veterans Affairs, and many others, to include VFW National Commander John Stroud. The memorial will open to the public at 3 p.m. It is located at the foot of Capitol Hill on the House side, at the trisection of 2nd and C Streets and Washington Avenue, SW.
- 4. Camp Lejeune Care Update: The Department of Veterans Affairs released final regulations for the "Honoring America's Veterans and Caring for Camp Lejeune Families Act." The published regulations put in motion VA's ability to provide hospital care and medical services for veterans, and to reimburse eligible Camp Lejeune family members for out-of-pocket health care costs related to any of the 15 covered medical conditions listed in the law (P.L. 112-154). What you should do now:

- * Call 1-877-222-8387 and ask to be added to VA's Camp Lejeune database. VA will contact you after Oct. 24.
- * Gather documents showing your relationship to a veteran who served at Camp Lejeune, such as marriage license or birth certificate, and copies of orders or base housing records that showed you lived on base for 30 days or more between Jan. 1, 1957 and Dec. 31, 1987.
- * Keep receipts for health care expenses you paid for a covered condition on or after March 26, 2013. This is the date when Congress began to fund this program. Hold on to your documents and receipts. You'll be able to submit these starting Oct. 24.

5. VFW Charter Update: VFW's congressional charter was signed in 1936, by President Franklin D. Roosevelt when the military consisted only of men. Today, our military consists of brave men and women putting duty and service before themselves. Based on a resolution that was passed on the floor of the VFW National Convention, two companion bills, S. 2782 and H.R. 5441, were introduced by Senate and House VA Committee chairmen will make small but significant changes to that charter. The update consists of two wording changes - replacing the word "men" with "veterans" and the word "widows" with "surviving spouses." Contact your Senate and House members today and ask them to support passage of S. 2782 and H.R. 5441. Tell them that the VFW believes that being an eligible veteran is what is most important to our organization, not gender. And changing widows to surviving spouses more accurately reflects the membership of the VFW. Urge them to support and pass these bills today!



There are stories about other senior and well-known POWs, such as Lt. Cmdr. John McCain and future Adm. James Stockdale. But one of the more remarkable stories is about the youngest Navy POW to be jailed in North Vietnam, Seaman Apprentice Douglas B. Hegdahl. The 19-year-old South Dakotan had joined the Navy only six months before, lured by a chance to visit Australia. He was assigned to serve as an ammunition handler on the guided-missile cruiser USS Canberra (CAG 2) in the Gulf of Tonkin.



Eager to witness a night bombardment, he went topside without authorization and was knocked overboard by the concussion of the ship's giant guns on April 6, 1967. He stayed afloat for several hours before being picked up by North Vietnamese fishermen and turned over to militiamen and then trucked to Hoa Lo.

Hegdahl's story that he had fallen off a ship was so preposterous to his captors they thought he was a spy. After being slapped around for a few days, he finally convinced officials he was just a raw recruit and then cunningly played up his country bumpkin demeanor. More than 6-feet tall and near-sighted without the glasses he lost overboard, Hegdahl played the fool to gain extra communication opportunities and time outdoors. In the process, he became a valuable reconnaissance operative and "mailman" in the POW network.

Using the tune of "Old McDonald Had A Farm" as a mnemonic device, Hegdahl memorized 256 captive's names, their shoot-down dates and a personal reference to prove his information was correct, all gained through an elaborate tap code created by the prisoners.

A peace delegation visit in 1969 offered the opportunity for the North Vietnamese to free a few pre-chosen POWs while hiding the true numbers of POWs held captive and the atrocities they endured. Although the POWs had pledged that no one would accept an early release unless all were released, Lt. Cmdr. Richard "Dick" Stratton, the senior officer at the Plantation, ordered Hegdahl to accept it. And so unbeknownst to the enemy, Hegdahl "sang" a detailed accounting of captives and conditions to Naval Intelligence of Hanoi's neglect and mistreatment of American prisoners that discredited the Communists' "humane and lenient" claim.



Stratton, who would survive as a POW and retire as a captain in the Navy, credited Hegdahl with saving his life by providing that information. And with his permission, he offers an uncensored, poignant and often hilarious recounting of his time with Hegdahl on his blog, Tales of SE Asia. One includes Hegdahl surreptitiously dumping a little dirt each day into the fuel tanks of the Plantation's trucks. Over the course of his captivity, Hegdahl disabled five trucks. The country bumpkin who played his captors for a fool would eventually become a civilian instructor in the Navy's SERE school in California.

Stratton said the emotion he feels on POW/MIA Recognition Day is "relief that I made it and sorrow that others didn't," he said Friday morning from his home in Florida. "I am very proud of the efforts being made to account for people who remain missing, from the incredible work being done to identify remains at the laboratory in Hawaii to the folks in Washington who are doing a superb job considering the issues of working with other countries."

For those returning during Operation Homecoming in 1973, the journey that ended with Denton's words on the tarmac at Clark brought some of the prisoners home to hard-won honor and tributes

and others to new trials. For all of them, their tenure as POWs would be a defining chapter in their lives, just as their homecoming would be a singular moment in the life of the nation that celebrated their return.

When Marine aviator Capt. Harlan Chapman arrived stateside, Gen. Louis Wilson shook his hand and said: "Welcome back to the Marine Corps." Chapman replied: "Thank you, General, but I never left."



Commanders, District & Post Chairmen for the VOD / PP / Teacher's Award,

We have entered the last 20 or so days for all entries for the VOD / PP / Teacher's Award that are due at District Level by 01 Nov 2014. If you have not already done so, may I suggest that you make one more stop to all schools in your area and remind them of the coming deadline. I would also explain all requirements, as I would hate for a student that has taken the time to submit an entry and be disqualified for not following all required instruction. (i.e. PP – essay length: 300-400 typewritten words, in no way may contestants identify themselves within their essay, do not put their name or the school they are from on the essay. VOD – students should record their reading of the draft to a CD. The recording can be no shorter than 3 minutes and



no longer than 5 minutes (plus or minus 5 seconds), preferred format for CD's is the audio CD format. When burning your CD make sure that "Create Audio CD" option (or Similar) is selected so the program can properly convert your sound file and burn it to CD. After is has finished, be sure to play back your audio CD on a system other that your computer, such as a standard radio or car CD player, to verify that the conversion/burning process was successful, the body of the essay must not identify you in any way.)

VA Updates Disability Claims Application

The Department of Veterans Affairs (VA) today announced that it is introducing a uniformed disability claims form to better serve Veterans, families and survivors. Standardizing the process by which Veterans file claims and initiate appeals will make it easier for Veterans and their survivors to clearly state what benefits they are seeking from VA and provide information that is necessary to process their claims and appeals. The new forms eliminate applicant guesswork, which often leads to delays in decisions and ultimately delays in receiving benefits. The new regulations go into effect in late March 2015.





"We must do everything that we can to make it as fast and easy as possible for Veterans and their survivors to file for and receive an accurate decision on their claim," said VA Secretary Robert McDonald. "Our Veterans and survivors will know, at the outset of the claims process, what is needed, which removes subjective interpretation from the process. We want to eliminate any barriers that make it difficult for our Veterans or survivors to receive benefits to which they are entitled."

In the past, a Veteran or survivor did not have to use a certain form to seek compensation or other benefits from VA. Claims or appeals (Notice of Disagreement) could be submitted on any piece of paper which caused delays due to missing information.

By using standard forms for all disability claims, VA can more quickly and accurately

identify what the Veteran is claiming or appealing. This will allow VA to immediately move on to next steps in the evidence-gathering and decision-making process, which saves administrative processing time and speeds the delivery of earned benefits. The existing process is also inconsistent with most, if not all, other government and non-government application processes, such as applying for social security, applying for a driver's license, applying for a job or filing for an income tax refund.

"These days, government agencies and private businesses rely on standard forms to deliver faster and more accurate customer service," said Under Secretary for Benefits Allison A. Hickey. "VA's ability to deliver better customer service requires the use of standard forms as well. That is why we worked extensively with our partners in the Veterans community to streamline the way we process claims while preserving the effective date rules concerning informal claims through the creation of a new intent to file a claim process."

The updated process also includes standardizing the traditional informal claims process by employing a new "Intent to File a Claim" process which affords the Veteran or survivor one year to compile the necessary documentation or evidence to support the claim while preserving an effective date of claim.
