Comrades,

This month's letter will focus primarily on not just Membership but also our other programs! We are ranked #2 in the VFW National organization in membership. We have 8 Posts and 2 Districts that are now over 100%. As of 5 October 2018, we stand at 11,099 members and have achieved a membership percentage of 94.47%. All seven of our Districts are in the Top 25 of their VFW National Division. That does not mean we can let up. It is not where you start out that matters – It is where you END UP that really matters! I am so proud of all of you. Keep doing what you have been doing – It is working!



The DPA Chairmen have been kicking their programs into gear. Information on the programs can be found on the DPA Website and throughout our Face Book Pages. Our objective this year is to have most of our programs completed by the Mid-Term Conference. There are five donations that can be done in lieu of participation. Posts can make a \$50.00 online donation to each program -- VOD/PP/Teachers Award, V&MS and to the National Home. Districts who have no participation in these programs can also make a donation of \$100.00 to the programs. PLEASE ENSURE your donations are properly credited to your Post or District. Last year we spent 100+ hours researching donations that were made by individuals who did not credit their Post or District. In addition, each Post and District needs to send an email to the respective DPA Chairman so that they can document these donations.

Finally, I would ask that you share your information on the 2 DPA Face Book Pages and My Commanders Page. Remember that the DPA Around the Pacific is designed to share items that may be of interest to all of your fellow Comrades, the DPA Official Communication is for sharing official DPA information on our programs, and my Commander's Page is for you to share any issues, questions or concerns that you might have that involve, Posts, Districts or DPA Programs. I know that the Chairmen post in the Typhoon each month – but the DPA Official Communications was developed for the purpose of sharing information on a much more frequent basis. Chairmen should not wait until the monthly deadline. Use our Pages and share information with over 500+ of our comrades who are online.

#### **National Direct Dues Program**

Our Department will participate in the National Direct Dues Program. This means the entire transmittal, along with the dues is sent directly to National for both annual and life memberships. The Posts will be paid their portion of the Life Membership and Annual dues from National. Contact the Department Quartermaster or Department Senior Vice Commander for assistance.

#### **VFW Online Dues Processing**

Post Quartermasters are highly encouraged to submit their dues processing using the VFW Online Membership Systems.

#### **New post Institution Program Refund**

Any new Post instituted during the year will receive a rebate of \$6.00 from Department for each new and reinstated member listed on the final Charter Application form submitted to National. When the new Post is officially instituted and chartered – the Department Quartermaster will refund monies for those members shown on the Charter on the closing date (up to 90 days after the institution of the Post). The Life Membership stipend does not apply to the formation of a new Post.



#### **Life Membership**

Life membership recruiting is an important program and we will strive to encourage everyone to become a Life Member. We have to be sure that all new and potential life members understand how strongly the VFW supports them, other veterans and local communities. It goes without saying that without the recruiting of new members, our great organization will not be able to survive. Recruiting must begin at the Post level. It is up to each Comrade to do their part to ensure that our organization continues to grow. We have a proud legacy of leading the Veterans of Foreign Wars of the United States of America in membership recruitment throughout the years. Let's go out and show them that the best Department is right here in the Pacific Areas.

The judging as to who will represent the Department will commence via email prior to the C of A and will be completed on Friday 7 December between 0800 – 1000 hours during the C of A.




All entries need to be received by Posts no later than 31 October 2018.

# From the Quartermaster:

Comrades.

Since our mid-term Council of Administration meeting is only two months away, I'd like to cover the Department's "expense defrayment policy". That's a Bill Wichmann-ism that I enjoy repeating. The policy in its entirety can be found on the Department website under the Judge Advocate tab. For reimbursement. Use the DPA Form 15, which is available under "Forms" at the Department website.

Council members will be reimbursed for economy air travel from their home country to the Philippines, either Clark or Manila. In-country ground transportation, both in your home country and in the Philippines, will be reimbursed up to \$100 total for the entire trip. Normally the

Department reimburses for two night's lodging at the Mid-Term, but this year there are meetings scheduled for Friday, December 7. Anyone required to attend a Friday meeting will be reimbursed for 3 nights – Thursday, Friday and Saturday.

Past Department Commanders not on the Council and not living in the Philippines will receive a \$300 stipend to offset air travel and room costs.

Please make your flight reservations early enough to avoid paying the high cost of last minute travel. I have seen airline tickets differ by as much as \$500 for travel from the same airport to the same destination and for the same meeting! Experts seem to agree that the window of 45-60 days before the flight offer the best rates. I am sure there are exceptions.

# From the Judge Advocate:

Comrades.

In this month's Typhoon article I will provide the correct procedures for submitting amendments and/or a revision to Post, District and Department By-Laws.

#### 101 AMENDMENTS FOR BY-LAWS

The instructions from National indicate that if you want to propose a change to By-Laws it must be submitted as such, <u>not</u> as a resolution. This means <u>no</u> "Whereas" or "Be It Resolved" clauses are to be used when proposing an amendment. The by-law proposed amendments must be <u>definite</u> and <u>specific</u> as to the material to be deleted or added, containing the <u>exact</u>



wording of the proposed change. Also, if a Post, District or Department adopts a proposed amendment it shall be submitted as an attachment to a cover letter, which may outline the rational for the proposed change(s). After a Post or District adopts an amendment or revision to their by-laws it shall be sent to Department for review for compliance with Department By-Laws and then forwarded to National for final review and approval.

In the examples below you will see that in documenting an amendment it is important to show clarification of; 1) who the amendment was proposed by, 2) referenced article and section that the amendment applies to, 3) amend detail of implantation and 4) exact wording of the proposed change. The following are examples of what National desires when forwarding proposed amendments for Post, District, Department, or National By-Laws:

#### **Example:** (Amending entire section wording.)

Proposed by Post 007 (who)

ARTICLE XIV - APPROVAL, AMENDMENTS and CONFLICT (reference)

Section 1402 – Amendments.

Amend Section 1402, Post 007 By-Laws, by deleting wording after the section title and substituting in its place the following; (amend detail)

These By-Laws may be amended by the Post by a two-thirds (2/3) vote of the members present at a stated meeting thereof provided each member has been notified at least twenty (20) day in advance and, upon request provided a copy of the proposed amendments. All amendments shall be forwarded through channels and reviewed by the Department Commander and the Commander-in-Chief before becoming effective. (exact wording)

#### Example: (Amending section words.)

Proposed by Department of Pacific Areas

#### **ARTICLE II - POSTS**

#### Section 220 - Vacancies and Removal of Elective Officers or Committee Members.

Amend Section 220, National Manual of Procedure, by deleting the word "majority" in the first sentence of paragraph three, and inserting, in lieu thereof, the following;

two-thirds (2/3)

Example: (Amending by deleting and adding sentence(s).)

**Proposed by Department of Pacific Areas** 

ARTICLE V – OFFICERS ELECTED AND APPOINTED Section 503 –Proof of Eligibility.

Amend Section 503, Department By-Laws, by deleting the second sentence of the section, and inserting in lieu thereof, the following;

The Adjutant shall ensure that proof of eligibility is on file with the Adjutant General of the Department Commander, Department Senior Vice Commander, Department Junior Vice Commander, Department Adjutant and Department Quartermaster.

The above examples of proposed amendments for submission are definite and specific to deletions and exact wording and are considered correct procedure for documentation. Also, if <u>many</u> amendments are required you could consider submitting a "**proposed revision**" to the by-laws. The proposed amendments are then written into the whole document, submitted as a proposed revision to the by-laws for review by Department, and then forwarded to National for final approval. If a unit's current by-laws state in the last section; "wherever these By-Laws or subsequent amendments may be found to be in conflict with the present or any future National and/or Department By-Laws the latter shall prevail and be binding upon this unit as though written herein" This statement may cover a unit's needs until such a time that a revision may be necessary to incorporate changes that occur over a period of time in National and/or Department By-Laws.

#### Originator

An originator of proposed amendments to by-laws may be a Post, District, Department officer or the Department Convention for Department and National By-Laws. In the case of Post By-Laws an officer or any member may submit proposals for adoption by the Post and forwarding as required. In the Districts the officers, a Post or the District Convention may submit proposals to District By-laws and if adopted at a Convention shall be forwarded for review and approval. In all instances where the originator is going to forward proposed amendments to by-laws a cover letter with an attachment containing the proposals shall be submitted through proper channels.

Caution: Any proposed changes to by-laws being forwarded not in proper form, unclear as to meaning, or concerning matters clearly not within the scope and purpose of the VFW <u>cannot</u> be considered by Department or National.



#### **Make Beer Taste Better**

What's more, it's free and has practically no negative side effects. That's right, I'm talking about walking & you'll have to read to the end to find out about beer. Walking will help you to:



**Maintain a healthy weight-** Regular walking can help improve your body's response to insulin, which can help reduce belly fat and is one of the most effective low-impact ways to mobilize fat and positively alter body composition. Daily walking increases metabolism by burning extra calories and by preventing muscle loss, which is particularly important as we get older.

Prevent or manage various conditions, including heart disease, high blood pressure and type 2 diabetes- Walking can have a bigger impact on disease risk and various health conditions than just about any other activity that's available to you.

**Strengthen your bones and muscles & improve balance and coordination-** When you take long strides, you work all the muscles that support your stomach, back, and pelvis and like muscle, bone is living tissue that responds to exercise by becoming stronger. Therefore, a physical activity, like walking, is an essential factor in bone health.

**Improve your mood-** A number of studies have found that it's as effective as drugs for decreasing depression. It can help relieve everyday stresses, too. Tension starts to ease as the road stretches out in front of you because mood-elevating endorphin levels increase.


**Make beer taste better-** There is no scientific or medical basis or reference for this; it is simply based on my own experience and opinion, and also I needed an effective hook in the headline.

# From the Voice of Democracy / Patriot's Pen / Teacher's Award Chairman:









Comrades,

Posts should start receiving entries for the Patriots Pen essay, the Voice of Democracy audio essay and the Smart/Maher Citizenship Education Teachers Award soon. The deadline for submission to the posts is October 31st.

The themes for this year's programs are: VOD - "Why My Vote Matters" & PP - "Why I Honor the American Flag"

\* Notice: Qualifications state that both programs are open to students who are enrolled in a public, private or parochial high school or home study program in the United States, its territories and possessions; or in an overseas U.S. military/civilian dependent school. However, VFW National Adjutant General and Programs Director agreed that as long as the student is a U.S. citizen then they can participate.

All Patriot's Pen essays and Voice of Democracy audio essays should be reviewed by the chairman several days before the judging, so that small errors like too many words, and audio CD or USB drive that will not play on your equipment, a Voice of Democracy audio essay that is a bit too long/short, or a reference that inadvertently identifies them might be corrected by the student rather than the chairman eliminating them from the competition. Chairman should never forget that our priority is to increase the number of students participating, rather than eliminating them. Ensure that each entry form is filled completely and that the information is legible.

In order to qualify for All-State and All-American, each Post and District must submit entries for all three programs or make a donation to VFW National. #### **Post Level Judging:**

For Patriot's Pen essays and Voice of Democracy audio essays, districts should have their judging done and winners forwarded to department by November the 14<sup>th</sup>. Each district can forward one (1) essay each for Patriot's Pen and Voice of Democracy to department. Scan and email me your winning Patriot's Pen essay entry form and essay and scan your

winning Voice of Democracy audio essay entry form and copy and send the audio file. Maintain the original entry forms, essays and audio files to be brought to the CofA along with the student's head & shoulders photo.

For Smart/Maher Citizenship Education Teachers Award, districts should have their judging done and winners forwarded to department by November the 14<sup>th</sup>. Each district can forward one (1) entry to district for each grade level; K-5, 6-8 and 9-12. Scan and email me your winning Teachers Award entry form, essay, resume and other supporting documentation for each grade level. Maintain the original entry forms, essays, resume and other supporting documentation to be brought to the CofA along with the teacher's head & shoulders photo.

#### **Department Deadline November the 20th**

#### **Department Level Judging:**

I will require each district to provide the contact information (email address) of who will represent your district as a judge. I will email all Patriot's Pen essays, Voice of Democracy audio essays and scoresheets to each judge. Each judge can score and fill out the score sheets prior to the CofA. Scan and email me each score sheet so I can tally up the scores.

For Smart/Maher Citizenship Education Teachers Award, I will evaluate depending on how many entry forms I receive for each Grade Level. If there is two (2) or more for any Grade Level, I will also be emailing the entry forms, resume sand other supporting documentation.

# From the Legislative Committee Chairman:

Comrades,

Just a reminder, it is never too early to think about your post's All-State requirements, and one of our requirements for All-State and All-American is as follows:

Post participation in one or more of the following activities:

1. Support an ongoing "VFW Action Corps Weekly" registration drive reporting to the Department National Legislative Chairman.

OR

2. Hold a Deployment or Welcome Home event (Department will help fund via the Department Veterans & Military Support Chairman).

OF

3. Adopt a Unit, reporting to the Department Veterans & Military Support Chairman. to either

If it is difficult for your post to hold a Welcome Home Event or Adopt a Unit, then holding a VFW Action Corps Weekly is a simple and relatively easy task to accomplish. Once you complete the drive, please email me at the below email address. Holding the drive is not merely a checkmark, though. The weekly is the best way that we, as VFW members, can keep track of legislative action that matters to the VFW and all vets. So even if your post has completed either of the second two requirements, I urge all posts to still hold their registration drive.

Here are some of the current legislative highlights concerning vets:

- 1. VA Secretary Wilkie Testifies before Senate Committee: On Wednesday, Sept 26, Secretary of Veterans Affairs Robert Wilkie testified before the Senate Committee on Veterans' Affairs to discuss the progress he has made in his first 60 days. He spoke at length about a variety of topics including implementation of the VFW-supported VA MISSION Act of 2018, Blue Water Navy, accountability of wrongdoers, and the department's efforts to modernize its electronic health record. Secretary Wilkie said at the hearing, "the state of VA is better" when describing the department's recent progress. Committee members and Chairman Isakson discussed the need to pass the VFW-supported H.R. 299, Blue Water Navy Vietnam Veterans Act of 2018. Watch the hearing, which begins at the 14:00-minute.
- 2. New Rule Changes How VA Calculates Income for Needs-based Benefits: Last week, VA published a final rule in the Federal Register that will establish a three year look-back period when determining eligibility for income-based benefits, including pension with aid and attendance. The new rule goes into effect on Oct. 18, 2018. It makes several changes, such as increasing the amount of net worth a veteran can have to qualify for pension, and expanding the definition of custodial care to allow veterans to deduct medical expenses for dementia care and third-party care providers. The three year look-back rule is intended to limit asset transfers done solely to qualify for governmental assistance. Such transfers may bar the veteran from receiving pension benefits, until the assets are used for their living expenses. There are some protections in place for veterans to transfer funds without a penalty, such as special needs trusts for the benefit of helpless children and helpless adult children, and trusts where the veteran retains control over the funds. Veterans can also reverse the transfer or buy back the asset in order to avoid the penalty. For questions about VA benefits and assistance with filing a claim, contact a professional, accredited and highly trained VFW Service Officer near you.
- 3. Senate Must Pass Blue Water Navy Bill: On Wednesday, Sept 19, the VFW joined other veterans service organizations in sending a letter to the Senate Committee on Veterans' Affairs urging the Senate to pass H.R. 299, the Blue Water Navy Vietnam Veterans Act of 2018, which would provide long-overdue benefits to Blue Water Navy and Korean DMZ veterans. It would also expand benefits to the children of veterans who were exposed to Agent Orange in Thailand and commission more research on Gulf War Illness. The VFW calls on its



members and supporters to contact their Senators and urge them to pass this important bill. Read the letter. Contact your Senators.

4. Army Medic to Receive Medal of Honor: The White House announced that former Army medic Staff Sgt. Ronald J. Shurer II will be presented the Medal of Honor on Oct. 1 for fighting his way through an enemy ambush to render aid to wounded Special Forces soldiers and Afghan commandos. On April 6, 2008, his team was navigating its way through Shok Valley in northeastern Afghanistan when a firefight forced his unit into a defensive fighting position. According to an Army press release, Shurer heard that their forward assault element was also pinned down at another location with multiple casualties. He moved through a hail of bullets to reach the pinned-down element, stopped to treat a wounded teammate's neck wound, then spent the next hour fighting across several hundred meters, before finally arriving at the forward location, where he immediately rendered aid to four critically wounded U.S. soldiers and 10 injured commandos. Soon after, Shurer and his team sergeant were shot at the same time. Despite a gunshot wound to his arm, the medic ran 15 meters through a barrage of gunfire to pull his teammate to cover and rendered care. Moments later, Shurer moved back through heavy fire to help another teammate who had suffered a traumatic amputation to his right leg. Shurer saved the lives of all casualties under his care, to include lowering three critically wounded, non-ambulatory, teammates down a near-vertical 60-foot cliff, while avoiding rounds of enemy gunfire and falling debris caused by numerous air strikes. He was initially awarded the Silver Star, the third-highest award for valor.

<u>Columbus Day</u>: On June 28, 1968, President Johnson signed Public Law 90-363 making Columbus Day, October 12 a national holiday and commencing in 1971, this holiday has been observed on the second Monday in October giving the American public another long holiday weekend. In keeping with our American heritage, the VFW Department of Pacific Areas (DPA) encourage each Post in the DPA to sponsor and participate in the observance of this national holiday by the various opportunities presented each. For example, participation in parades, special social affairs, cooperation with schools and youth groups to instill in young Americans the need to perpetuate the memory of the acknowledged discoverer of America.



<u>US Navy Birthday</u>: On 13 October 1775, the Continental Congress authorized the fitting out of small ships for the Navy. This action constituted the 1st Naval legislation and became the genesis of the U.S. Navy. In as much as that date marks the beginning of the U.S. Navy, it is appropriate to celebrate 13 October as the Navy's Birthday.

<u>Hispanic Heritage Month</u>: National Hispanic Heritage Month is celebrated from September 15th to October 15th. During this celebration, the Army commemorates and celebrates the contributions of Hispanic Americans to the nation, society, and culture.

During Hispanic Heritage Month the VFW commemorates the long-standing and remarkable contributions that Hispanics have made in building and defending the nation.

- More than 20,000 Hispanic Soldiers fought on both sides of the Civil War.
- In 2014, the 65th Infantry Regiment a unit of Soldiers mostly from Puerto Rico known as Los Borinqueneers received the Congressional Gold Medal, the highest civilian honor.
- More than 40 Hispanic-American Soldiers have been presented the Medal of Honor, the country's highest military decoration. In 1919, Private David Bennes Barkley was the first Hispanic Soldier to be (posthumously) award the Medal of Honor for his courageous actions in World War I.

There has been 61 Hispanic Americans that earned the Medal of Honor. In celebrating National Hispanic Heritage Month, the VFW recognizes not only the significance of individual contributions but also the value of diversity and an inclusive environment.
