Make sure you stay in touch with SVC Farris and submit your completed requirements to the various DPA Program Chairs. You are on track to "smash" our previous records in almost all areas. Our Posts are doing an excellent job—we have 12 Posts who are in the running for All-American and an additional 10 who are on track for All-State.



Just returned from the Legislative Conference in Washington DC. Our representative for the VOD Award (Amaya R. Peruccio) represented us extremely well. She is an amazing young woman with a highly motivated approach to life. I was proud to escort her at the VOD Parade of Winners on Monday 4 March 2019. She has a bright future and I wish her the best in her future endeavors.

The DPA Convention Registration is up and running on the DPA Website. Please go online and register as soon as possible. The Convention Committee is working extremely hard to ensure that you have an enjoyable time. In order to do that – they need to know the number of people attending, the number of meals required and the size and number of shirts you wish to order. Finally, flight bookings will be filling up fast. So get your airline tickets early.

The VFW National Convention Housing Registration had a minor glitch for the first few days after it opened. These were resolved a couple of days later and all is working well now. There is so much to do in Orlando. Minda and I spent 3.5 years there and still did not have enough time to see it all. Hope to see a big turn-out from the DPA this year!

Most Posts and Districts should have all of their requirements completed except CSRs and Financial Audits. Keep working to complete these – suspense for the CSR Report is 30 April 2019. Remember each Post must have a least 3 CSRs per month. If you missed a couple during the year you can go back and catch up. The majority of the time – Posts had many reports that were done but never reported. Audits should be submitted to the DPA Quartermaster as soon as possible after they are completed.

In addition to the above there is the National Outstanding Community Service Post nomination that is due to your District Commander NLT 25 March.

The Outstanding Community Service Post is a National program that recognizes Posts who have done an outstanding job in serving their local community through VFW programs. We are looking to recognizes one Post that performed a community service project that had a significant impact on the community and demonstrated a positive involvement of the VFW within that community. The project should have an unusually profound affect on their community. In addition, the winning Post will have demonstrated a commitment to the National organization by submitting a high level of appropriate Community Service Reports (CSRs).

The selected DPA post will be recognized and awarded by National. Specifically they will receive the following:

- National Plaque recognizing the Post will be presented at a reception. Group photograph with Commander-in-Chief will be sent to each Post.
- Reserved seating at Joint Opening Ceremony.
- Post will be listed and recognized in the National Convention Booklet.
- Post Quartermaster will receive \$599 stipend check to disburse to their Representative to assist with some Convention expenses.
- Post Representative will receive a Recognition Street Sign.

Further information on the Awards program is available through your District Commander.

In addition to awards, remember we have two months remaining to update your CSRs over the past ten months and of course continue reporting your community service. We will be closing out the CSR year on 30 April. The current status of CSRs is listed at the end of this report.

It's been a great year so far let's finish strongly as we recognize our outstanding posts and members and continue to submit reports of our community service via the CSR.

Greetings,

I would like to call your attention to Sec. 222 of the National By-Laws and Manual of Procedure, specifically the Manual of Procedure, "Delegates, District Convention & Meetings, Department and National Conventions".

I have copied and pasted the specific paragraph below:

Sec. 222 - Delegates, District Convention & Meetings, Department and National Conventions.

Delegates and alternates for the District Convention and Meetings, Department and National Conventions shall be elected at a regular meeting in April. Delegate strength will be based on members in good standing as of March 31st.

Delegates shall not be recognized at the National Convention unless they personally register their completed delegate card with the National Credentials Committee.

Posts instituted after delegate strength has been determined, but prior to convening date of the respective convention or district meeting, shall on the day of institution, elect one delegate and one alternate for each thirty names or fraction thereof according to the number of names listed on the charter application.

Please note that delegates for District and Department Conventions are to be elected at a regular Post meeting in April. Following your election of Post delegates, please forward your delegate letter, for the Department of Pacific Areas Convention, to me at: adjdpa@vfwdeptpacific.org.

From the Quartermaster:

Comrades,

With Post and District elections only a month away, I'd like to present a reminder to units considering electing a new Quartermaster. Please note that the current Quartermaster needs to serve out his term through the end of June. In July, the new QM will be given access to the online tools from National that he needs to submit members and conduct other QM business. Too many times the outgoing QM walks away from his duties, leaving the Post or District in a bind for a month or two. Try to avoid this situation.



Also, the current QM needs to submit the Election Report to National as well as sending in the registration information for at least one member for the National Convention, whether or not anyone from the Post is attending. And the current Adjutant should complete General Order #1 and submit it to the Department Adjutant. This allows for a smooth transition into the next VFW year.

The Department Convention Registration page is now active on the Department's website. You'll notice a few differences from previous years. We're asking you to provide incoming and outgoing flight information so we can provide free transportation from the airport to the hotel and back to the airport. Please be advised that the airport still has no operable jetways, and stairs are being used to enplane and deplane. I believe this will still be the case in June. Ground personnel are very accommodating in helping passengers up and down the stairs.

The first page of the registration is self-explanatory. If you wish to have a non-smoking room, please indicate that in the "Special Requests" box. The second part of the registration process is the "SHIRT/Activities" page found at the top of page 1. Here you can order a convention shirt and indicate if you are interested in any of the extra activities we're planning to offer. This page needs to be downloaded and emailed to convention@vfwdeptpacific.org. The activities are still in the planning stage, and will be finalized once enough interest is shown. Golf should cost about \$35 for green fees + cart. Shoes and clubs will be extra. The submarine tour of our lagoon is a special event for our group only. The cost is unknown until we get a good count of folks going. The historical tour is free. The Managaha trip is for spouses and kids while our meetings are in progress. Managaha is a small island inside the Saipan lagoon. It has pristine beaches and a very relaxing atmosphere – no cars, no roads, no shopping. Just sun and surf. Transportation to and from the island is by boat, and we are hoping to get free passes for those wishing to go.

From the Judge Advocate:

Comrades,

In this month's issue I will discuss policy and procedures that pertain to delegates to District Convention-meetings and the Department Convention. Also, will render a heads up on office reelect installation prior to the Department Convention and end my article with notice concerning election reports.


Delegates for Conventions & Meetings

The following are some questions with answers and comments that concern delegates to both the District Convention / meetings and Department Convention ~

Question: How many members can one delegate or alternate represent for a Post in the District election?

Answer: Delegate strength shall be one for every thirty members or fraction thereof in good standing in a Post.

Comments: The below references will explain the answer.



 \Box Refer to National By-Laws, Sec. 421 – Voting, and you will see each delegate shall have one vote only and may vote his share of delegate strength at a District Convention or meeting. E.g., if the prior month ending Post membership was 195 members then the Post delegate strength would be $195 \div 30 = 7$ delegate strength. The Post then elects its delegates at a regular meeting at least thirty (30) days prior to the District Convention and writes a letter signed by the Post Commander indicating names of delegates (1 to 7 names) and alternates as deemed necessary. The letter is then submitted to the District Adjutant in a timely manner and updated when necessary during the ensuing year. If only one delegate is present at a meeting / convention they may cast one vote with delegate strength of 7. Should more delegates be present they would cast pro-rata share of the total voting strength.

Note: For the purpose of Sec. 421 the Post Commander shall be considered a delegate.

Question: Can one delegate vote the entire Post delegate strength?

Answer: Yes, see the above references and comment hereto.

Comment: Refer to National By-Law, Sec. 421 – Voting, where it states; "The delegate or delegates of a Post present at a District Convention or meeting shall be entitled to vote the full delegate strength to which the Post is entitled".

Question: If I'm the only Post member at a District Convention or meeting, can I vote?

Answer: Yes, as long as, a signed delegate letter has been submitted to the District indicating that you are a delegate or alternate.

Question: Can a Post Commander at the Department Convention vote a pro rata share of the Post delegate strength?

Answer: Yes, a Post Commander has the option to vote as a delegate rather than Post Commander, but not both.

Comment: Refer to National By-Laws, 521 – Voting. The Post Commander, or the SVC or JVC Commander functioning in his place as a member of the Convention, may at his option, choose to vote as a delegate rather than as a Post Commander.



Question: Are there any differences between policy and procedures concerning delegates for District Convention / meetings and a Department Convention?

Answer: There is not much difference in the National By-Laws and Manual, Sec. 222, paragraphs (a) and (b), as the policy and procedure are similar indicating both requiring Posts to elect delegates and alternates not less than thirty (30) days prior to convention, with one delegate and alternate for each thirty members or fraction thereof in good standing in the Post at the time of election.

Comment: The only difference is that Department By-Laws, Section 403 – Delegates, does indicate Posts in attendance at a Department Convention shall pay a Per Capita Tax (delegate registration fee) of \$6 per authorized vote (delegate strength based on 30 members) prior to voting. This tax will be submitted with a delegate letter prior to or at the Convention.

Heads Up - Post Installation

This is a reminder to Posts that current policy pursuant to National By-Laws and Manual of Procedure indicates that an officer-elect needs to be installed prior to the Department Convention. Please review the following section from the Manual of Procedures:

Sec. 217-- Nomination, Election, Installation and Term of Office. (Manual)

Installation of Officers. The Post Commander-elect will select the installing officer who holds or has held a rank at least as high as that of Post Commander. Post officers shall be installed in their respective offices prior to the convening of the Department Convention, but shall not assume their duties until the Department Commander is installed. The installation may be conducted publicly at an open meeting.

An officer-elect who may be absent for good and sufficient reason or cause may be installed at any regular or special meeting prior to the Department convention. If not then installed, the office will automatically become vacant.

Comment: In the aforementioned paragraph an officer-elect if not installed prior to the Convention will have to go through the process again of nomination, election and be duly installed at a regular or special meeting.


From the Surgeon:




Comrades,

Just a reminder, time is getting close in which to get your post's All-State requirements done, and one of our requirements for All-State and All-American is as follows:

Post participation in one or more of the following activities:

1. Support an ongoing "VFW Action Corps Weekly" registration drive reporting to the Department National Legislative Chairman.

3. Adopt a Unit, reporting to the Department Veterans & Military Support Chairman. to either

If it is difficult for your post to hold a Welcome Home Event or Adopt a Unit, then holding a VFW Action Corps Weekly is a simple and relatively easy task to accomplish. Once you complete the drive, please email me at the below email address. Holding the drive is not merely a checkmark, though. The weekly is the best way that we, as VFW members, can keep track of legislative action that matters to the VFW and all vets. So even if your post has completed either of the second two requirements, I urge all posts to still hold their registration drive.

Here are some of the current legislative highlights concerning vets:

- 1. VFW to Deliver Veterans' Voices to Congress: More than 500 VFW and VFW Auxiliary members are arriving in the nation's capital this weekend to urge their respective members of Congress to continue improving the programs and services provided by the Department of Veterans Affairs. Highlighting the annual legislative conference will be VFW National Commander B.J. Lawrence's testimony Wednesday at 10 a.m. before a special joint hearing of the House and Senate Committees on Veterans' Affairs in room G-50 of the Dirksen Senate Office Building. Topping his list of VFW legislative priorities is passage of the Blue Water Navy Vietnam Veterans Act, a call for full congressional oversight over the implementation of the VA Mission Act of 2018 and the combined VA and Defense Department electronic health record initiative. Other priorities include improving burn pits research and accountability, eliminating the so-called "Widow's Tax," allowing military retirees to receive full retirement pay and disability pay without offset, and expanding and improving VA health care and research programs. Read the VFW's full list of 2019 Priority Goals.
- 2. VA Announces Expedited Claims for Purple Heart Veterans at Oversight Hearing: On Tuesday, Feb 26 Secretary of Veterans Affairs Robert Wilkie and Veterans Health Administration Executive in Charge Dr. Richard Stone testified before the House Appropriations Subcommittee on Military Construction, Veterans Affairs, and Related Agencies on the current improvements to VA customer service, MISSION Act implementation, business transformation, and VA/DOD collaboration. Secretary Wilkie announced that effective in April, VA will provide priority disability benefits claims processing for the initial claims from discharged combat veterans who have been awarded the Purple Heart Medal. Wilkie also said that the state of VA is getting stronger, but there is still an enormous amount of work that needs to be done with veterans' homelessness, opioid safety & reduction efforts, and women's health. Read the testimony or watch the hearing.
- 3. New Appeals Process Launched: VFW Washington Office Executive Director Bob Wallace, National Veterans Service Director Ryan Gallucci, Training & Quality Assurance Manager Lauren Barefoot, and Retired National Veterans Service Director Jerry Manar joined senior VA officials at VA central office for the kickoff of the new and improved appeals process. Starting this week, all veterans who disagree with their VA rating decision will have



three new options to resolve their benefit disputes: request a higher-level review from a more experienced person, submit a supplemental claim with additional evidence, or appeal directly to the Board of Veterans' Appeals. Over the past four years, Mr. Manar and Ms. Barefoot have represented the VFW in negotiations with Congress, VA, and other veterans organizations to craft this new framework. The goal of the new process is to offer veterans greater flexibility and transparency to resolve benefit disputes in a timely manner, instead of waiting years for VA to adjudicate their appeals. The VFW will monitor the implementation and work with VA to resolve any issues that come up. Read more about appeals modernization. For assistance appealing a decision on your benefits claim, contact a highly trained and accredited VFW Service Officer.

- 4. Coast Guard to Build New Heavy Icebreakers: Congress has restored funding for the Coast Guard to begin building its first new heavy icebreaker in 40 years. The funding was part of the \$333 billion spending bill the president signed last week, according to an article in Stars and Stripes. The Coast Guard will receive \$655 million to begin building an icebreaker to replace the aging Polar Star its only working heavy icebreaker and \$20 million more to begin buying materials for a second such vessel. "With the support of the administration and Congress, we plan to build a new fleet of six polar icebreakers at least three of which must be heavy icebreakers and we need the first new Polar Security Cutter immediately to meet America's needs in the Arctic," the Coast Guard said in a statement to USNI News. The Coast Guard has one operational heavy icebreaker and one that is inoperative. The service also has a medium icebreaker and a research vessel with light ice-breaking ability. This fleet is miniscule compared to Russia's 40 icebreakers. Even China, which aims to create an Arctic trade route known as the "polar silk road," has two heavy icebreakers and plans to acquire more. Read the Stripes article here.
- 5. VA to Implement Appeals Modernization Act: Beginning Feb. 19, all veterans who disagree with their VA rating decision with have three new options to resolve their benefit dispute: request a higher-level review from a more experienced person, submit a supplemental claim with additional evidence, or appeal directly to the Board of Veterans' Appeals. Over the past two years, the VFW worked closely with VA and other veterans' organizations to craft this new framework, which was authorized by the VFW-supported Veterans Appeals Improvement and Modernization Act of 2017. The goal of the new system is to offer veterans greater flexibility and transparency to resolve benefit disputes in a timely manner, instead of waiting years for VA to adjudicate their appeals. Read more about appeals modernization. For assistance appealing a decision on your benefits claim, contact a highly trained and accredited VFW service officer.
