

As we wait for the updated MEMSTATS, which we expect to be posted early this month, let's continue looking for opportunities to recruit new members, upgrade annual members to life membership, and encourage life members to become Legacy Life members. Don't forget for those annual (continuous) members who will not be upgrading, ensure they are retained and their annual dues are collected.



When planning your recruiting campaign consider these tried and true methods to ensure a successful campaign and bear in mind:

- 1. SELECT AND ORGANIZE A MEMBERSHIP COMMITTEE WITH A CHAIRMAN WHO IS WELL SPOKEN KNOWLEDGEABLE, DEDICATED AND ORGANIZED.
- 2. DEVELOP A RECRUITING PLAN, THERE ARE 5 ELEMENTS OF A SUCCESSFUL RECRUITING PLAN:
  - a. ANAYZE YOUR CURRENT SITUATION
  - b. SET GOALS; I.E., WHERE DO YOU WANT TO GO
  - c. DEVELOP PLAN OF ACTION
  - d. IMPLEMENT THE PLAN
  - e. TRACK THE REULTS
- 3. SET REALISTIC GOALS.
- 4. PLAN YOUR ACTIVITIES, RETAIN CONTINUOUS MEMBERS, RECOVER FORMER MEMBERS, RECRUIT NEW MEMERS. USE PERSONAL CONTACT, EMAIL REFERRALS, TELEPHONE.

Finally, two points:

Remember everyone is a Recruiter!

All eligible veterans are future VFW members, THEY JUST DON'T KNOW IT YET!

Another outstanding tool available to us is the All American Dashboard. This is located on the VFW website and can be used by posts and districts to track their progress towards All American Recognition. Go to <u>vfw.org</u> then login, you will now be on the My VFW page. You will see Membership Quick Links, go to the third item which is All-American Dashboard, click on that and your post should be displayed with green color representing met requirements and red color representing unmet or not as yet reported. Any questions please contact me.

In order for proper credit to be applied to the Dashboard ensure the National program director has acknowledged your donation or completion of the program. In addition, advise the DPA chairman of the particular program and Cc the DPA SVC that would be me @ svcdpa@vfwdeptpacific.org.

This month we reap the rewards for your dedication in recruiting Life Members. The annual Life Member payout is usually distributed during the third week of the month. Did you know that our Department budget has a line item for MVS/MAP events held by your Post? It is not a huge amount, but if you want to host a cookout or party for your adopted military unit, Department can help defray some of the expense.

Did you know that your Post can receive \$1,000 from the VFW Foundation for a charity of your choice within the geographical area of your Post? The VFW Foundation is the charitable arm of the organization, and makes these funds available on a first come, first served basis. They give out roughly 300 of these grants annually.

Thank you for all you do helping veterans and their families. This is what makes our organization great.

Commanders and Comrades, Mayaguez Memorial VFW Post 11575 Commander Jack continues to coordinate locally with Cambodiana Hotel, a conference call this past week allowed us to finalize "lock" VFW room rates at \$85 night / single or double, there is a 2% accommodation tax however the 10% VAT is included in the negotiated rate. Saturday lunch, Saturday night Commanders Dinner and airport transfers will be book/reserved through the hotel, payment at check in. The international Buffet lunch \$20, Commanders Asian & Western dinner Buffet \$30 per person. Airport transports \$15 for car, \$20 for 15PAX Van.

Room booking includes breakfast buffet, newspaper, Internet access, Fitness club, Swimming pool and tennis courts. Rooms equipped with tea/coffee making facilities, Hotel offers 24-hour room service. 




### From the Chaplain:

### From the DPA Department Service Officer:

Comrades,

This month's update will be a little lengthy, but it will address some of the questions I have received over the last few months from DPA comrades. I have been working hard with the VFW National Veterans Service (NVS) Office to get additional funding for an additional ADSO in Korea and the Philippines. The DPA recently submitted a candidate to fill the ADSO-Thailand position which became vacant in May. The DSO Office annual budget is \$26,100 which is used to pay many things in the DSO budget to include one full-time employee salary (Administrative Assistant), some expenses for the VSOs, internet requirements where we have an ADSO, office supplies, travel by the DSO to our 10 Countries or Territories, and other



annual requirements. The availability of qualified Accredited VSOs in Asia is very limited. The standard VSO stateside makes an annual salary of \$50K+. Questions have been asked why Guam has no Accredited VFW VSO. The reason is that Guam and Saipan are territories of the US and have Veterans Affairs County Offices that are staffed full-time to support US veterans. When we propose a candidate for any of our regions in the DPA - We must be able to show a workload requirement. The average number of contacts (email & in-person) reported to me from Guam has been about 5 per month over the last 2 years. That clearly does not validate a need for an Accredited Veteran's Service representative for Guam. If the numbers change, we will relook their situation. The four major areas with the largest ex-pat populations in the DPA are the Philippines, Thailand, Japan and Korea. Our current staffing for all the DPA includes 3 people - the DSO, the Administrative Assistant and an ADSO in Japan. In March I briefed the VFW National Veterans Service Office Advisory Council in Washington, DC and as stated above - have been working on getting an additional allocation of funding to place an NVS BDD representative in Korea to handle pre-discharge processing of active duty military and a DPA ADSO. The bottom line is that we are working to get the resources to fill the vacancies in the areas that have the highest population and need. Filling a vacancy for an Accredited VSO is time consuming and requires an extensive Background Investigation and months of processing from the DPA, to the VFW National Veterans Service (NVS), and then to the Office of General Council (OGC) in the Department of Veteran's Affairs.

There are two jurisdiction paths that we follow for assisting veterans! One for VA organization's claims processing and one for VFW organizations chain of command. ALL claims are submitted to the VA Intake Center in Janesville, Wisconsin where the VA then assigns the veteran's claims from overseas areas to VARO Pittsburg for processing. The exception is the Philippines who has the only VARO (VARO-Manila) outside of the USA and its territories. Their claims are processed by VARO-Manila. Under VFW NVS policy - ALL DPA Post/District Service Officers must work through the Department Service Officer or Assistant Department Service Officers in their Department area of responsibility. Although the DSO lives in the Philippines - he has responsibility for oversight of all of our Post/District Service Officers/ADSOs. Their reporting and funding come to and through the DPA DSO. The ADSO-Japan, ADSO-Thailand, and the ADSO-Philippines report to the DPA DSO! When an ADSO-Korea is authorized - they too will report to the DPA DSO.

My travel schedule as the DSO is as follows: (1) Commute to Angeles City from Subic for duty on Mondays & Tuesdays each week; (2) Office hours at the Retired Activity Office in Olongapo on Wednesdays; (3) Travel to Manila on Thursday afternoon for duty on Friday in the VARO-Manila; (4) Office hours at my home office on Saturdays & Sundays. ### From the Surgeon:

#### **Dengue Fever Overview**

#### Dengue Fever is a threat throughout the Department of Pacific Areas

The current Dengue outbreak is reaching epidemic proportions in the Philippines with the number of deaths rising daily and the threat of exposure is also very real within almost all Districts in the Department of Pacific Areas.

**Overview:** Dengue is the fastest spreading vector-borne disease in the world. Dengue is a flu-like viral infection spread mainly through the day-biting female Aedes Aegypti mosquito.

While dengue is a highly infectious disease, it is not contagious - which means the virus cannot be passed on from one person to another. But when a mosquito bites a person with dengue, the insect becomes a carrier of the virus. That infected mosquito can pass on the virus by biting another person.

**Symptoms:** Symptoms include sudden high fever, severe headaches, pain behind the eyes, severe joint and muscle pain, fatigue, nausea, vomiting, skin rash which appears two to five days after the onset of fever and mild bleeding (such a nose bleed, bleeding gums, or easy bruising). Sometimes, symptoms are mild and can be mistaken for those of the flu or another viral infection. Young children and people who have never had the infection before tend to have milder cases than older children and adults. However, serious problems can develop. These include dengue hemorrhagic fever, a complication characterized by high fever, damage to lymph and blood vessels, bleeding from the nose and gums, enlargement of the liver, and failure of the circulatory system. The symptoms may progress to massive bleeding, shock, and death. This is called dengue shock syndrome (DSS). People with weakened immune systems as well as those with a second or subsequent dengue infection are believed to be at greater risk for developing dengue hemorrhagic fever.

**Treatment:** There is no cure and no specific medicine to treat dengue infection. If you think you may have dengue fever, you should use pain relievers with acetaminophen and avoid medicines with aspirin, which could worsen bleeding. You should also rest, drink plenty of fluids, and see your doctor. If you start to feel worse in the first 24 hours after your fever goes down, you should get to a hospital immediately to be checked for complications.

**Prevention:** Simple. 1.) The most effective way of preventing dengue is using mosquito repellent with DEET on exposed skin from dawn to dusk. 2.) Wear protective clothing. Cover as much of your skin as possible. Wear long sleeves, socks and covered shoes. Light colored clothing is less attractive to mosquitoes than dark colors. 3.) Avoid mosquito-attracting smells. Perfume and sweat attract mosquitos. Shower to remove sweat and use unscented sunscreen, soap & shampoo.

In conclusion, be wary & stay healthy. Dengue symptoms are similar to some other diseases so see your doctor asap if you experience symptoms.

**POST AND DISTRICT CHAIRMEN:** School has started, so everyone should be in contact with the schools in your area to promote the Voice of Democracy and Patriot's Pen Essay Competitions.

**NEW VOICE OF DEMOCRACY AND PATRIOT'S PEN THEMES:** The 2019-20 themes have been chosen by Commander-in-Chief, William J. "Doc" Schmitz. The Voice of Democracy and the Patriot's Pen theme will be "What Makes America Great?" The new 2019-20 Voice of Democracy and Patriot's Pen entry forms are now available on the VFW website. Entry deadline to the Post is 31 October 2019.

\*Notice: Qualifications state that both programs are open to students who are enrolled in a public, private or parochial high school or home study program in the United States, its territories and possessions; or in an overseas U.S. military/civilian dependent school. However, VFW National Adjutant General and Programs Director agreed that as long as the student is a U.S. citizen, they can participate.

Additionally, anyone (including students, parents, teachers and chairmen) can download and print the student entry forms for Voice of Democracy and Patriot's Pen.

Chairman should never forget that our priority is to increase the number of students participating, rather than eliminating them.



### From the Women's Veterans Chair:

Each generation has at least one moment that defines them: "Where were you when...?" For my grandparents it was Pearl Harbor; my parents it was that word of President J.F. Kennedy was assassinated in Texas; for my generation it will be September 11, 2001. Between the 2,753 people who perished at the World Trade Center site, 184 personnel at the Pentagon and 40 casualties of Airline Flight 93 that crashed near Shanksville, Pennsylvania, the total casualty of 2,977 represents the largest loss of life in a single event on American Soil. 9/11 changed the way we saw homeland security and all branches of the military and emergency response teams experienced a surge of recruits in response. It would be impossible to show an adequate tribute to all who served, and continue to serve. Below is a small sample of stories of our departed Heroes.



- Police Officer Moira Smith, New York Police Department: A 13 year veteran, Officer Smith was among the first to respond to the September 11 attack at the World Trade Center and was last seen evacuating people out of Tower Two, saving hundreds of lives. Throughout her police career, Officer Smith exhibited extreme valor, and among her awards was the department's Distinguished Duty Medal, which she received in 1991 for saving dozens of lives after a subway crash. Posthumously awarded: 2011 Women of Distinction; NYPD's Medal of Honor; Glamour and Ms. magazines' Women of the Year for 2001; Woman of the Year by the NYPD's Policewomen's Endowment Association; 9/11 Heroes Medal of Valor.

-Captain Kathy Mazza, Port Authority of New York and New Jersey Police Department: A 13 year veteran, Captain Mazza was the first female commanding officer of the Port Authority Police Academy. She was killed while leading a group of people downstairs when the World Trade Center started to collapse. Using her 9mm sidearm, Captain Mazza shot out glass walls, enabling many to escape.

-Special Investigator Diane DiGiacomo, ASPCA Humane Law Enforcement Division: A 17 year veteran, Investigator DiGiacomo was assigned to search for abandoned animals in homes in the restricted area around the WTC site for 3 months following 9/11. She was regularly seen on Animal Planet on the TV series Animal Precinct. She developed cancer directly attributed to exposure to toxins in the air near ground zero.

-Special Agent Melissa Morrow, US Department of Justice, Federal Bureau of Investigations: A 22 year veteran, assigned to FBI Washington Field Office's Evidence Response Team, Special Agent Morrow processed evidence from the Pentagon crash site. Exposure to contaminated conditions led to the development of brain cancer.

Where the Towers represented our economy and civilian workforce, the Pentagon is where military decisions are made. The third plane crashed into the west side of the Pentagon resulting in a partial collapse and the following service members lives lost: YN3 Melissa Rose Barnes, US Navy, served in telecommunications at the Pentagon and reported to the Chief of Naval Operations; IT1 Marsha D. Ratchford, US Navy, handled crucial military messages at the Navy Command Center in the Pentagon; SGT Tamara C. Thurman, US Army, worked as an assistant in the office of the Deputy Chief of Staff for Personnel; Lt. Col. Karen J Wagner, US Army, Medical Personnel Officer in the Office of the Army Surgeon General and Deputy Chief of Staff for Personnel; SPC. Chin Sun Pak Wells, US Army, Administrative Assistant to the Deputy Chief of Staff for Personnel at the Pentagon; SSG Maudlyn A. White, US Army, Administrative specialist Office of the Deputy Chief of Staff for Programs. In addition to active duty, the lives of 21 female civilians working for the US Army and US Navy were lost.

The list of emergency response personnel effected by cancer associated with toxic air and contaminated conditions will soon be a longer list than those that died on 9/11. The Victim Compensation Fund received national attention after a heartfelt plea by Jon Stewart, political commentator, to members of US Congress. With the passing of the 9/11 Health and Compensation Act, there is now a permanent line item in the budget and will be available to aid in the monitoring and treatment of first responders. ### From the Americanism and Loyalty Chairman:

Comrades,

There are over ten events in September that we can observe. Here are four that I will recognize for you.



Air Force Birthday – The official Air Force Birthday is recognized as September 18, 1947. This was the date of the passage of the National Security Act of 1947. That legislation created what would become known as the United States Department of Defense. This established the United States Air Force as a separate branch of military service. The 71<sup>st</sup> Air Force Day will be celebrated on September 18, 2019.

Citizenship Day/Constitution Day – September 17<sup>th</sup> is the day when two important observances take place. Citizenship Day and Constitution Day. There is also Constitution Week which is observed the week of September 17 – 23. These observances were created to both commemorate the signing of the Constitution on September 17, 1787, and to "recognize all who, by coming of age or by naturalization, have become citizens." During this time, the U.S. Citizenship and Immigration Services "encourages" Americans to reflect on the rights and responsibilities of citizenship and what it means to be a U.S. Citizen.

POW/MIA Recognition Day – Third Friday in September – The familiar POW/MIA flag, so closely associated with the observance, actually pre-dates it. According to DoDLive.Mil, in 1971 a military spouse named Mary Hoff contacted a private company to request a flag to honor those missing in action or prisoner of war (one of whom was her husband). A World War 2 pilot named Newt Heisly created the now iconic design. Many Americans take this time to not only remember the POW/MIA, but their family members who fought and or died for our country.

National Day of Service at VA Cemeteries on 9/11 – On Wednesday, September 11, 2019, from 0900 until 1300, the National Cemetery Administration and carry the Load will partner on a national day of service with headstone and marker cleaning and grounds beautification at 40 national cemeteries across the country. Honor our men and women buried in VA national cemeteries and commemorate the heroism of September 11, 2001.

Comrades, hopefully, some of you will find the time to show your loyalty and observe one of these events.

Comrades,

Yearly, we the Veterans of Foreign Wars selects emergency medical technicians, law enforcement and firefighter personnel to receive VFW Public Servant Awards. Post Safety Chairmen are encouraged to submit a candidate for these awards to the Department of Pacific Areas Headquarters by November 29, 2019. The DPA will select a single candidate for each of the three awards during the Mid Term C of A, 6-8 December 2019 and submit those to VFW National Headquarters by February 1, 2019.



NOTE: The only item the National VFW Programs Department requires is the "VFW Department

Public Servant Award Citation Request Form" which is now available on the VFW website. You can locate this form by logging in to <u>www.vfw.org</u> and searching under "My VFW" in the Training & Support section.

VFW National Emergency Medical Technician Public Servant Citation: Any individual, who actively gives emergency medical treatment, provides rescue service or civil disaster assistance as a member of any public or volunteer company organized to give emergency medical care, provide rescue and civil disaster assistance to our nation's citizens.

VFW National Law Enforcement Public Servant Citation:

Any individual who serves in a municipal, county, state or federal unit tasked with enforcement of the laws pertaining to their area of responsibility. This award does not apply to individual employed by private companies or security services.

VFW National Firefighters Public Servant Citation: Any individual who actively fights fires as a member of any public or volunteer company organized to fight fires and give assistance to our nation's citizens.

Criteria for these awards – Candidates must have demonstrated:

- 1) Recognition by their colleagues or those they serve.
- 2) Consistent excellence in the performance of their duties.
- 3) Consistent dedication to their official responsibilities over a period of years and continuous growth in responsibilities and skills within their profession.

Documentation required for all Candidates:

- 1) Nomination letter containing the candidate's name, title, address, telephone and identifying the award for which the individual should be considered.
  - a. Include justification outlining background in field, accomplishments and awards.

### From the Legislative Committee Chairman:

Just a reminder, it is never too early to think about your post's All-State requirements, and one of our requirements for All-State and All-American is as follows:

Post participation in one or more of the following activities:

1. Support an ongoing "VFW Action Corps Weekly" registration drive reporting to the Department National Legislative Chairman.

OR

2. Hold a Deployment or Welcome Home event (Department will help fund via the Department Veterans & Military Support Chairman).

OR

3. Adopt a Unit, reporting to the Department Veterans & Military Support Chairman. to either

If it is difficult for your post to hold a Welcome Home Event or Adopt a Unit, then holding a VFW Action Corps Weekly is a simple and relatively easy task to accomplish. Once you complete the drive, please email me at the below email address.

Holding the drive is not merely a checkmark, though. The weekly is the best way that we, as VFW members, can keep track of legislative action that matters to the VFW and all vets. So even if your post has completed either of the second two requirements, I urge all posts to still hold their registration drive.

Here are some of the current legislative highlights concerning vets:

- 1. DOD to Divert \$3.6 Billion to Fund Barrier Projects: On Wednesday, September 4, DOD announced that \$3.6 billion will be diverted from 125 military construction projects in both the U.S. and overseas to fund 11 fencing and barrier projects along the southern U.S. border. In total, this reprogramming will suspend programs in 23 states, three U.S. territories, and 19 nations. These projects include schools, dining and maintenance facilities, upgrades to flight line infrastructure, and upgrades to ballistic missile defense infrastructure. See the <u>full list of projects</u> slated for deferment. Read the official DOD press release.
- 2. VFW Supports Relief Efforts for Hurricane Dorian: The VFW is accepting donations to help veterans, service members, and military families impacted by Hurricane Dorian. From hurricanes to raging wildfires, each year natural disasters leave many in desperate need of assistance. The VFW's Disaster Relief Fund provides our organization the opportunity to react quickly with immediate relief to those in the affected areas. You can donate to the VFW Disaster Relief Fund. Learn more about the hurricane's impact on your respective VA facility.
- 3. On-Base Shopping Eligibility Expands Jan. 1: Beginning in the new year more than 3 million service-connected disabled veterans with VA ratings from zero to 90 percent will be authorized on-base exchange and commissary shopping privileges, as well as access to certain MWR facilities, but you must have a VA-issued Veteran Health Identification Card, or VHIC, to gain access. The VHIC is issued only to veterans who are enrolled in the VA health care system. You can apply online, or in person at your local VA medical facility. Family members of the newly eligible veterans will not be authorized to shop, but will be permitted on-base as guests of the VHIC-carrying veteran. Veterans who do not reside near a military installation can still shop online at the four military exchanges. Search for stores at ShopMyExchange, Marine Corps Exchange, Navy Exchange, and Coast Guard Exchange. Caregivers will be processed differently, initially, since they have no military or VA affiliation. The VA will post a memo to VA.gov for caregivers to be used for access at the front gate, along with a driver's license. This process is expected to transition to a caregiver-type ID card, which will have scanning swipe capability. One hundred percent disabled veterans, their spouses, and eligible dependents already have access because they are issued military identification cards.

- 4. Retirees Enrolled in TRICARE Prime May Get a Refund: On Thursday, TRICARE released a policy manual update that will be beneficial to some retirees who are enrolled in TRICARE Prime. Prior to the TRICARE reforms that went into effect in 2018, enrollment fees were included in the maximum out-of-pocket payment or catastrophic cap; after the reforms, they were no longer counted toward the cap which effectively increased the cost for some families. The new change, which is retroactive to 2018, will allow the annual enrollment payment to be counted toward the cap again. This means retirees who paid the enrollment fee and exceeded their catastrophic cap could get a refund. The update explains that the contractor will be responsible for notifying the beneficiaries who are affected by the policy change. The outreach letter will explain the credit, how the credit was applied, and the steps to request a refund. Learn more.
- 5. Legislation Introduced for Veterans Exposed to Burn Pits: VFW-supported H.R. 4137, Jennifer Kepner HOPE Act, has been introduced. This important legislation would make individuals eligible for hospital care, medical services, and nursing home care provided the individual served as a member of the Armed Forces in support of a contingency operation and was based or stationed at a location where an open air burn pit was in use after Jan. 1, 1990. The eligibility for care would be open even for those who have insufficient medical evidence to conclude that a disease or disability is associated with burn pit exposure. Learn more
