

My primary responsibility this term is Department Membership Chairman. We are doing ok, not great, but I know we will finish great because that is the legacy of our Department. When the dashboard is not consistent with what you know to be a completed requirement ensure your post adjutant is aware and has reported it up the chain.

For All State status check with your District CDR. A few days ago I sent him the latest information I have on MET and UNMET requirements for All State. Suggest you go over that data with your District CDR.

Now is the time to take notice of your shortfalls for All American, All State, and Membership Statistics. Then suggest you enact an action plan to meet all membership and program requirements.

I continue to stand by to assist, all you need to do is contact me.





From the Judge Advocate:

Comrades,

Over the next two months it will be time to consider nominations and election of officers for both Posts and Districts for 2020-21 term of office. So, in this month's issue I will present questions and render answers on some by-laws and parliamentary procedures concerning the forthcoming elections.

NOMINATIONS AND ELECTIONS

The following are questions with answers that may come up at nominations and election time:

Question: When do nominations commence and for how long?

Answer: Nominations for Posts normally shall start in March and end in April at election time. Districts may open nominations in the meeting prior to their Convention and then continue at the annual Convention prior to elections.

Question: Does a member have to be at a meeting or Convention to be nominated?

Answer: No, if the comrade making the nomination of an absentee for any office presents to the Adjutant, in writing, the consent of the member being nominated prior to the opening of nominations.

Question: If I'm nominated for office do I have the right to decline the position for which I was nominated?

Answer: Yes, any nominee may have the opportunity to decline the position for which he has been nominated before the close of nominations.

Question: Who determines what form of elections shall be used?

Answer: The membership at the March Post meeting prior to opening nominations or governing body to a Convention shall decide the form of election to use, unless By-Laws indicate the manner of elections. Normally, balloting for officers may be conducted by open or written secret ballot. Another method of balloting that may be used is the poll system and preprint ballots. Another method of balloting that may be used is the poll system and preprinted ballots.

Question: If the Post decides at the March meeting to use the poll system with preprint ballots, are nominations held open until the April meeting?

Answer: No, in the poll system, nominations are closed at the March meeting. Then the Post shall determine certain procedures used to conduct polling of the vote.

Question: What kinds of procedures are used in the poll system?

Answer: The Post may determine procedures such as date, time and where polling shall take place, who does the tallying and what happens in case of a tie. A Notice and preprinted ballots shall be distributed to members in good standing within a reasonable time prior to the date of voting. The notice shall contain the names of the candidates and a space for write-in candidates. There shall be no absentee or proxy votes when the poll system is used. Also, the greater number of votes rules when using the poll system.

Question: What's the difference between a majority vote and plurality vote?

Answer: A majority vote at election time is considered more than half of all votes actually cast. Whereas, a plurality vote means a person having more votes than any other person is the winner. (Note: National By-Laws call for majority vote of all votes cast, except where otherwise designated, shall be necessary to elect.)

Question: Who is eligible to vote at election time?

Answer: In Posts any member in good standing at the time of elections and at District Conventions those members in good standing that are part of the governing body defined in the District and/or National By-Laws.

Question: When is a member considered to be in good standing to vote at elections?

Answer: Any Life members and a member who has paid his current annual dues to December 31 the year of elections is in good standing, and cease to be in good standing on 1 January immediately following the year for which his dues were paid.



Question: If I'm an elected two year House Committee member can I be elected to another Post office?

Answer: Yes, as elected committee members are not considered Post Officers, so you may concurrently hold an elected Post office

Question: What happens when more than two candidates are nominated and there is no majority vote realized? **Answer:** You would drop the comrade with the lowest amount of votes and continue successive ballots until the election

is made.

Question: If the final vote is deadlocked, how is it decided?

Answer: There are two ways to decide a tie which are; 1) the units by-laws specify that in event of a tie vote, the candidates or their nominator or designated representative shall determine the result by lot or coin, or 2) if the by-laws are silent, a motion can be adopted in advance of vote stating in the event of a tie vote for a final choice, the candidates or their representatives or nominator shall decide the result by lot, or toss of the coin. (Note: At conventions normally Rules of Order for the convention will state the second choice and shall be voted at start of the convention.)

Question: What happens if the By-Laws are silent and no motion was made in advance of voting concerning a deadlock? **Answer:** Pursuant to Robert's Rule of Order the Chair can't break a tie in elections, therefore, the Chair can call for unanimous consent meaning everyone in the meeting or delegates to a convention must be in favor for the candidates or their representatives or nominator to decide the election by lot, or toss of the coin. The Chair should normally ask if there is any objection to having the method of deciding the election by lot, or toss of the coin. If there is one objection then a motion shall have to be made in advance for the method of breaking a tie and then reelection at the current meeting or convention shall be held again.

Question: Who do I submit my grievances' to as I want to challenge the Post elections for irregularities?

Answer: Any challenge must be made in writing containing specific details concerning the irregularities, signed and forwarded to the District Commander, mailed no later than three (3) days after the election. (Any appeal to actions taken by the District Commander shall follow procedures in the National By-Laws and Manual of Procedure, Section 109 – Right of Appeal.)

Question: What if I'm elected to a Post office and can't make the installation?

Answer: If you're an officer-elect and absent for good reason you may be installed at any regular or special meeting prior to the convening of the Department Convention. If not installed your office is automatically vacant. Then after the Department Convention the Post shall go through the election process to fill the position and if elected you would be installed.

Question: What happens if a District officer-elect can't be at the District installation?

Answer: In the case of a District officer-elect not being installed for good reason you may be installed at any succeeding regular or special meeting of a unit of the organization, within sixty (60) days of the date of installation. If not installed, the office will automatically become vacant.

As you can see comrades there are various questions that may come up during the course of nominations and voting during election time that can be answered by reviewing the various by-laws at different levels of command, as well as consulting Robert's Rules of Order of Parliamentary Law and Procedure.

From the Surgeon:

Prepare to Panic...Or Not

Leave your car at home; apply mosquito repellent; avoid snakes; but most importantly, remember to wash your hands frequently.

I don't provide the above stats to downplay the severity of nCoV, but to allow you to put the risk of infection into perspective. While the new coronavirus ravages much of China and world leaders rush to close their borders to protect citizens from the outbreak, the flu has quietly killed 10,000 in the U.S. alone so far this influenza season. Experts agree that unless you were at ground zero in Wuhan China, the seasonal flu currently poses a much higher risk. Three things you can do to help prevent flu and nCoV infection follow:

Wash your hands frequently- Wash your hands frequently with an alcohol-based hand rub or soap and water. Washing your hands with an alcohol-based hand rub or soap and water kills the virus if it is on your hands.

Avoid touching eyes, nose and mouth- Hands touch many surfaces which can be contaminated with the virus. If you touch your eyes, nose or mouth with your contaminated hands, you can transfer the virus from the surface to yourself.

Maintain social distancing- Maintain at least 1 meter (3 feet) distance between yourself and other people, particularly those who are coughing, sneezing and have a fever. When someone who is infected with a respiratory disease, like nCoV, coughs or sneezes they project small droplets containing the virus. If you are too close, you can breathe in the virus.

In conclusion, I'd like to reiterate the importance of driving carefully, using insect repellent, avoiding snakes and protecting yourself from the flu by getting a vaccine. Oh, and also beware of falling coconuts (140 deaths annually), lightning with 24,000 deaths annually, tripping and falling at home (6,000 deaths annually) and finally, be sure to dodge flying champagne corks at weddings. Of the nearly two dozen champagne-accident fatalities a year, more than a third occur at weddings.

For the 2019-2020 year, the Department will provide a free Life Membership or a \$400 stipend for Posts meeting the following criteria:



From the Legislative Committee Chairman:

The 2020 election season is now fully upon us. It is imperative that all VFW members participate, not just in November, but as various states hold their primaries. The primaries are for everyone, not just for the presidential candidates. These are also to determine who runs for local, state, and national offices.

The only way we can ensure that our veterans and active duty Soldiers, Sailors, Airmen, Marines, and Coastguardsmen are supported is to ensure we elect representatives who understand their duties to those who've served in uniform.

Please pass these out at your post meetings and make sure all members register to vote to make their voices heard.

Here are some of the current legislative highlights concerning vets:

- 1. Senate Advances VFW-Supported Mental Health Bill: On Wednesday, January 29, the Senate Committee on Veterans' Affairs held a markup to discuss and advance the VFW-supported S.785, Commander John Scott Hannon Veterans Mental Health Care Improvement Act of 2019, which would improve VA mental health care programs and services for veterans. The bill would also establish two grant programs, one to enable nongovernment entities to provide supportive mental health care services and another to expand telehealth programs such as Project ATLAS. The committee also advanced legislation to improve health care for women veterans, expand transportation grants for veterans who live in rural areas, expand veterans preference for reserve component members, and confirm Judge Grant Jaquith to the Court of Appeals for Veterans Claims. The bills and Judge Jaquith's nomination now await consideration by the full Senate. Watch the markup, which begins at the 21:45 minute mark.
- 2. New Navy Aircraft Carrier to be Named After Doris "Dorie" Miller: On Monday, January 20, the Navy announced that it will be naming a new aircraft carrier after Mess Attendant 3rd Class Doris Miller. Miller was the first black service member to receive the Navy Cross for valor. On Dec. 7, 1941, during the attack on Pearl Harbor, Miller got his mortally wounded officer to a safer location and manned a machine gun to fire at the Japanese aircraft until he was ordered to leave, even though he had never been trained to operate the machine gun. Miller continued his service in the Navy after the Pearl Harbor attack, he died when the carrier he was serving on was sunk by a Japanese torpedo. Read more.
- 3. House Approves VA Dental Pilot Program: On Monday, January 13, the House approved H. J. Res. 80, which would provide congressional approval of the VA Innovation Center's programs to expand access to dental care through pro bono services at community dental clinics. This legislation is now being considered in the Senate.

National Salute To Veterans Patients - The week of February 14 is reserved each year as the National Salute to Veterans Patients. The Purpose of the National Salute to Veterans Patients Program is to pay tribute and express appreciation to Veterans, to increase community awareness of the role of the VA medical center and to encourage citizens to visit hospitalized Veterans.

During this time, you have the opportunity to say thank-you to a special group of men and women, the more than 9 million Veterans of the U.S. armed services who are cared for in



Department of Veterans Affairs (VA) medical centers, outpatient clinics, domiciliaries, and nursing homes. During the National Salute, VA invites individuals, Veterans groups, military personnel, civic organizations, businesses. Schools, local media, celebrities and sports stars to participate in a variety of activities at the VA medical centers. The activities and events include special ward visits and valentine distributions; photo opportunities, school essay contest, special recreation activities and Veteran recognition programs.

The week also provides an opportunity for the community to become acquainted with the Volunteer opportunities within the medical center.

Presidents Day – Presidents Day falls on Monday, February 17th, and this year will be the 27th annual celebration. The observance of George Washington's Birthday, February 22nd, 1732, is always the third Monday in February.

The federal holiday is officially recognized as Washington's Birthday, though the Federal government has never legally changed the holiday to President's Day. However, where it gets complicated is at the state and local level, as they do not need to abide by Federal holidays. 24 U.S. states recognize President's Day, 9 recognize Washington's Birthday and some states do not observe either.

It is up to you as to how you chose to honor this day. As a day to recognize Washington and Lincoln's birthday or even all American Presidents!!

United States Coast Guard Reserve Birthday - February 19 is the official birthday of the United States Coast Guard Reserve. Set-up in the late 1930s as a "civilian reserve" operation, it was non-military in nature. The Coast Guard Reserve Act of 1939 was the earliest incarnation. The Reserve soon evolved into something much greater than the original authors of the law had envisioned.

The "regular" Coast Guard was founded in 1790. It wasn't until much later that the Auxiliary and Reserve operations would be added to this branch of military service.



From the Women's Veterans Chair:

This month, the focus is on the Army. Women have been making an impact and receiving accolades from the beginning of our Nation's history. The Medal of Honor (MOH), our highest award was given to Dr. Mary Walker for her service as a surgeon during the War Between the States. President Andrew Johnson presented the award for her service as a surgeon to the soldiers on the front lines as well as her service while incarcerated in a POW prison in the south. A section of the citation follows: "...faithfully served as contract surgeon in the service of the United States, and has devoted herself with much patriotic zeal to the sick and wounded soldiers, both in the field and hospitals, to the detriment of her own health, and has endured hardships as a prisoner of war four months in a southern prison while acting as contract surgeon...." In 1917, Dr. Walker's MOH along with 900 others, was rescinded. She refused to return the medal and fifty-eight years after her death, U.S. Congress posthumously reinstated her medal, and it was restored by President Carter on June 10, 1977.

Distinguished Service Cross

The second highest award in the Army, established in 1918, the Distinguished Service Cross was created to award acts of heroism that are notable and involve risk of life so extraordinary to set the individual apart from their comrades. Beatrice M. MacDonald was the first of six female nurses to receive this medal for valor while serving during air raids of WWI. Nurse Helen Grace McClelland worked alongside MacDonald and provided the necessary care to MacDonald after she was seriously wounded by a German bomb, consequently losing her right eye. Jane Jeffery, an American Red Cross nurse serving a French military hospital and Army nurses Eva Parmelee, Isabelle Stambaugh and civilian Emma Sloan were also wounded in air raids but continued to care for others.

Virginia Hall was the only female to earn this award during WWII. A member of the U.K.'s clandestine organization Special Operations Executive (SOE), she was the first female agent residing in France. In 15 months, she built the Heckler network in Lyon. She provided: supplies, money, weapons, safe houses, medical assistance to wounded agents and pilots and organized resistance movements. Hall left France to avoid capture but returned in March 1944 to continue her mission of resistance support through training and providing supplies.

The Silver Star, third highest in prestige was first awarded to four nurses for bravery during the battle of Anzio, WWII. While the Army evacuation hospital was under German shellfire, 1st Lt. Mary Roberts, 2d Lt. Elaine Roe, 2d Lt. Rita Virginia Rourke, and 2d Lt. Ellen Ainsworth kept the hospital running as long as possible before finally evacuating 42 patients by flashlight. 60 years later, Sergeant Leigh Ann Hester of the Kentucky National Guard received the Silver Star for actions performed in combat. Hester's 617th Military Police Company was assigned to support a supply convoy near Bagdad which required clearing improvised explosive devices. After coming under attack by insurgents, Hester directed her team to safety, mounted a counter attack resulting in 27 insurgents dead, six wounded and one captured with no fatalities to Hester's unit. Spec. Monica Brown an Army medic, became the first female soldier to receive the Silver Star for combat in Afghanistan in 2008. While under gun fire, Spec. Brown was directly responsible for the medical treatment of five wounded soldiers in her unit after a roadside bomb went off near their convoy of Humvees. It wasn't until 2013 when the Pentagon officially allowed women to serve in combat roles but, sometimes the front lines are blurry.
