## VETERAN & PEARL HARBOR DAYS




Veterans Day 2021 will be on Thursday, November 11th, 2021. As a federal holiday Veterans Day is typically observed on November 11<sup>th</sup> every year. However, if it occurs on a Sunday then the following Monday is designated as the Federal holiday, and if it occurs on a Saturday then either Saturday or Friday may be designated.

The theme for the 2021 Veterans Day Poster is: **“Honoring All Who Served.”**

Each year on December 7, Pearl Harbor survivors, veterans and visitors from all over the world come together to honor and remember the 2,403 service members and civilians who were killed during the Japanese attack on December 7, 1941. Another 1,178 people were injured. Eight Navy battleships were among the 18 Naval ships either damaged or sunk. On Oahu military bases, 178 aircraft were destroyed.



December 7 was a catalyst that led to a changed world. The 80th Commemoration will tell the story of the multi-pronged attack across the Pacific and in particular the attack on Pearl Harbor. The goal of the commemoration is to ensure that future generations will understand the valor and legacy of those who perished and those who fought throughout the war. The commemoration also highlights the importance of the peace that brought reconciliation, a reconciliation that continues to move forward today in creating a better future for all.




## UPCOMING COMMEMORATIVE DATES



**27 January 1973 signing of the Paris Peace Accords** effectively removed the U.S. from the conflict in Vietnam. However, the agreement's provisions were routinely flouted by both the North Vietnamese and the South Vietnamese government, eliciting no response from the United States, and ultimately resulting in the communists enlarging the area under their control by the end of 1973. North Vietnamese military forces gradually built up their military

infrastructure in the areas they controlled and two years later were in a position to launch the successful offensive that ended South Vietnam's status as an independent country. Fighting began almost immediately after the agreement was signed, due to a series of mutual retaliations, and by March 1973, full-fledged war had resumed.



**15 February 1898 U.S.S. *Maine*** was a [United States Navy](#) ship that sank in [Havana Harbor](#) in February 1898, contributing to the outbreak of the [Spanish–American War](#) in April. American newspapers, engaging in [yellow journalism](#) to boost circulation, claimed that the [Spanish](#) were responsible for the ship's destruction. The phrase, "Remember the *Maine*! To hell with Spain!" became a rallying cry for action. Although the *Maine* explosion was not

a direct cause, it served as a catalyst that accelerated the events leading up to the war.



**28 February 1991 The Liberation of Kuwait** was a U.S.-led military operation to retake Kuwait from Iraq after the [massive air campaign](#), between 24–28 February 1991. U.S. troops and the Coalition entered to find the Iraqis surrendering en masse; however, pockets of resistance existed, particularly at [Kuwait International Airport](#) where Iraqi troops, seemingly unaware that a retreat order had been issued to them, continued to fight, resulting in a fierce battle

over the airport itself. The majority of the fighting took place in Iraq, rather than Kuwait.<sup>[2]</sup> The operation is part of what is commonly known as the [Gulf War](#).

Due to Covid-19 restrictions, Pattaya, which is a city reliant on tourism, has been hard-hit by the disease and related measures to control its spread. Numerous establishments that employ tens of thousands of people have been closed by government mandate since April 10th. Although some business sectors have been allowed to reopen people are still in need in Pattaya. Post Commander Manny Guarnuccio and VFW Post 9876 started a drive to raise funds for Charity Food Giveaways. Money immediately poured in from Members and friends of the VFW both local and abroad, to help make a difference in the community for those who are most in need. Assisting VFW members in the preparation and distribution of those meals were the VFW Post 9876 Wives Club, Pattaya American Legion Post TH02, Pattaya Sports Club, and Friends of the VFW to include U.S. Embassy Warden Bobby Brooks. Locations of the meal giveaways included Bali Hai Pier in South Pattaya, Lewinski's Golf Club and Restaurant (our Post Home), and host Trattoria Pizzeria Toscana on Beach Road, North Pattaya. A total of 3,200 meals were distributed in September. VFW Post 9876 also made a 30,000 baht donation to Baan Kru Boonchoo Foundation in Sattahip, presented to Foundation President Mrs. Boonchoo Moangmaithong to assist with the care of disabled and special needs children.



# In the SPOTLIGHT

Between 10 July 2021 and 21 September 2021, the U.S. Veterans Affairs (VA) Manila launched a campaign to provide free COVID-19 vaccinations to all U.S. military veterans, their spouses, widows, domestic partners and CHAMP-VA beneficiaries. The VA Manila asked for assistance from any Veterans Service Organization to help get as many eligible individuals vaccinated as possible.

Robert W. Zaher Post 2485 in Angeles City, Philippines volunteered to help in this life saving campaign by partnering with the VA Outpatient Clinic Manila to collect the names and contact information of eligible individuals, schedule their vaccine appointments and arrange for group transportation for those needing transportation from Angeles City to the VA Clinic which is 55 miles away in Manila. Please see photos of some of the many who used the group transportation arranged by Post 2485 and the CDC Vaccination Card issued by the VA Manila

VFW Post 2485 assisted a total of 289 Veterans, spouses, widows, domestic partners and CHAMP-VA beneficiaries in getting their COVID-19 vaccine at the VA Outpatient Clinic Manila.

On 21 September at the end of the campaign, Mr. Daniel Gutkoski, the VA Manila Outpatient Clinic Manager sent out an announcement expressing his deepest gratitude to the Veterans Service Groups who have assisted VA Manila in reaching Veterans, provided transportation to the Clinic, supported Veterans with transportation subsidies, and helped VA Manila communicate with Veterans throughout the Philippines. We could not have done so much without everyone working together for the common good.





# JUNIOR VICE COMMANDER

Greetings Comrades,

I just got back from our Junior Vice Commander's Training Conference in Kansas City, Missouri and I had the great opportunity to learn a lot of vital information that are essential to perform my duties and help on our mission in the VFW. I had the chance to meet with our VFW National Junior Vice Commander In Chief Duane Sarmiento and the rest of JVCs in the whole 52 states to include the Pacific Areas and Europe. We were trained and given a lot of materials regarding various VFW Programs and met up with VFW National Directors and learned firsthand on how each Program works and how to get the various Resources to get the Mission done. One of the important subjects that we have discussed is the Community Service Program and the VFW National Dashboard.

Community Service and Program reporting is vital to being able to show what our VFW members are doing in their communities and to recognize those members at our Department Convention and National Programs. It can also be complex because of the different reporting requirements between our organizations. The goal of online reporting is to make it easier to understand what can be reported and to simplify the reporting process with paper and online reporting options.

The VFW reporting year now ends on **31 March 2022** and all reports must be received at Department no later than **8 April 2022**

**Program and Community Service Reporting** is designed for "activity" based reporting which is reporting a given "activity" such as a poppy drive that you held for your Post or Auxiliary that applies to programs, service to veterans, their families, and our communities. The activities listed in the forms are those defined by VFW Programs and include all required details. For example, the number of poppies and handouts distributed in a poppy drive. See below for the different categories that we as a VFW Organization need to report:

## Americanism and Citizenship Education

Activities that can be reported by the VFW or Auxiliary under this category relate to the promotion, participation and education of patriotism and celebration of patriotic holidays including:

- Public patriotic holiday programs
- US flag programs, flag etiquette, flag retirements
- Patriotic education, Veterans in the Classroom
- Business recognition
- Blue Star, Gold Star recognition

## Buddy Poppy

Activities that can be reported by the VFW or Auxiliary under this category relate to the promotion and distribution of Buddy Poppies, including:

- Buddy Poppy program promotion, both within the Post or Auxiliary and in the community
- Buddy Poppy drives

# JUNIOR VICE COMMANDER

## Community Activities, Community Outreach

Activities that can be reported by the VFW or Auxiliary under this category relate to aiding and volunteering as an organization to the benefit of our communities and are not directly related to other VFW or VFW Auxiliary programs, including:

- Helping the elderly and special needs populations
- Blood drives
- Hunger, Homelessness projects for the general population

**Note:** This category is for projects and activities that **are not** affiliated with VFW or VFW Auxiliary programs and do not directly benefit the Post of Auxiliary. For example, activities such as performing repairs or maintenance to the Post home, preparing, or serving a meal for a Post or Auxiliary fundraiser, or participating in a Buddy Poppy distribution cannot be reported under this section. Also, projects that are specifically for Veterans such as stand downs should be reported under Veterans and Military Family support. Also, Auxiliary members may be able to report activities for organizations outside of their own provided that the project was approved by the Auxiliary and recorded in the meeting minutes prior to the project.

## Hospital

Activities that can be reported under this category relate to volunteering, sponsoring, and providing services and aid to both VA and non-VA facilities in support of the veterans that facilities service, including:

- Aid to VA and Non-VA facilities
- Donations of items or services
- Hospital visits and sponsoring hospital events or activities
- Volunteering in any medical facility, recruiting volunteers
- Veterans Affairs Voluntary Service (VAVS) program

## Legislative

Activities that can be reported under this category relate to improving the lives of veterans, service members and their families through advocacy, including:

- Promotion of VFW Priority Goals
- Participation in election activities
- Attending legislative events such as town halls

## National Home

Activities that can be reported under this category relate to the support of the VFW National Home for Children, including:

- Promotion of the National Home and the National Home Hotline
- Fundraising and donations to the National Home

## Scholarships

Activities that can be reported under this category relate to the support of VFW and Auxiliary scholarships and Teacher award including:

- Promotion of scholarships programs
- Assisting with program preparation such as coordinating resources and judges
- Hosting awards ceremonies

Activities that can be reported under this category relate to supporting Veterans and Military and their families including:

- Fundraising for National Veterans Service (NVS), VFW Unmet needs, Help a Hero, etc.
- Promotion of suicide prevention and mental health awareness
- Homeless Veteran events or projects
- Direct aid to Veterans, Active Duty and their families
- Other - such as participation in veteran funerals, honor guards, etc.


## Youth Activities

Activities that can be reported under this category relate to sponsoring and working with youth groups including:

- Supporting Scouting and ROTC programs
- VFW, Auxiliary activities with youth groups
- Promotion, participation in Illustrating America, Get Excited for the Red, White and Blue programs
- Youth Groups Supporting Our Veterans citations and Patriotic Youth Awards presentations

## 2021-22 Dedicated to our DPA



### Vietnam Veterans Past and Present

For most Americans who read this they will only see the numbers that the Vietnam War created. To those of us who survived the war, and to the families of those who did not, we see the faces, we feel the pain that these numbers created. We are, until we too pass away, haunted with these numbers, because they were our brothers, friends, fathers, husbands, wives, sons and daughters. There are no noble wars, just noble warriors. Less we forget those who fought in Vietnam. A little history most people will never know.

There are 58,267 names now listed on that polished black wall, including those added in 2010.

The names are arranged in the order in which they were taken from us by date and within each date the names are alphabetized. It is hard to believe it is 65 years since the first casualty.

The first known casualty was Richard B. Fitzgibbon, of North Weymouth, MA. Listed by the U.S. Department of Defense as having been killed on June 8, 1956. His name is listed on the Wall with that of his son, Marine Corps Lance Cpl. Richard B. Fitzgibbon III, who was killed on Sept. 7, 1965.

There are three sets of fathers and sons on the Wall.

39,996 on the Wall were just 22 or younger.  
8,283 were just 19 years old. The largest age group, 33,103 were 18 years old. 12 soldiers on the Wall were 17 years old. 5 soldiers on the Wall were 16 years old. 1 soldier, PFC Dan Bullock, was 15 years old.

997 soldiers were killed on their first day in Vietnam and 1,448 soldiers were killed on their last day in Vietnam.

31 sets of brothers are on the Wall.

54 soldiers attended Thomas Edison High School in Philadelphia. I wonder why so many from one school.

8 Women are on the Wall, nurses killed while nursing the wounded.

244 soldiers were awarded the Medal of Honor during the Vietnam War, 153 of them are on the Wall.


Beallsville, OH, with a population of 475, lost 6 of their sons.

West Virginia had the highest casualty rate per capita in the nation. There are 711 West Virginians on the Wall.

The most casualty deaths for a single day was on January 31, 1968 ~ 245 deaths.

The most casualty deaths for a single month was May 1968 - 2,415 casualties were incurred.

**Update:** The last battle of the Vietnam War was actually fought in Cambodia on the Island of Koh Tang 12-15 May 1975 during the Mayaguez Incident. The last 41 names on the wall are from this battle. (Unless casualties from earlier battles died of their wounds from 12-15 MAY). Of the last two lines of names, Loney, Hall, Hargrove, Marshal and Rumbaugh remains are all still unaccounted for from this battle. The last Casualty on the wall is Air Force 2<sup>nd</sup> Lt. Richard Van De Geer of Cleveland, Ohio who was killed on 15 May 1975 when his helicopter was shot down just off the Coast of Koh Tang Island. His remains were identified in 1995 and buried at Arlington National Cemetery in 2000.

# REMEMBERING THOSE WHO HAVE SERVED

First Sgt. Pascal Cleatus Poolaw Sr. served this country through three wars and gave up his life in Vietnam.

Poolaw has been called America's most decorated American Indian Soldier with 42 medals and citations. Among his medals are four Silver Stars and five Bronze Stars. He also earned three Purple Hearts, one for each of the wars in which he fought - World War II, Korea, and Vietnam.

The fourth Silver Star was awarded posthumously after Poolaw died during action in Vietnam. On Nov. 7, 1967, Poolaw's unit, Company C, 1st Battalion, 26th Infantry, was part of a search and destroy mission near the village of Loc Ninh.

The unit was attacked by numerically superior Viet Cong force. Under a hail of fire, Poolaw raced to the lead squad, exposed all the way, and deployed the squad there to lay down a base of fire, the citation read. This action saved countless lives, but Poolaw wasn't finished.

Poolaw continued moving among the troops, making sure they were positioned properly pulling casualties back to the lines despite being wounded himself. He was mortally wounded as he pulled another casualty back to the lines.

His devotion to his Soldiers was exceeded only by the love of his Family. Poolaw served in Vietnam trying to spare his son the horrors of war.

When his son, Lindy, received orders for Vietnam, Poolaw volunteered for the combat zone with the hope of serving there in place of his son. Regulations prohibit two members of the same Family from serving in combat at the same time without their consent.

Another of Poolaw's sons had already been in Vietnam, which added to his wanting to spare Lindy. His son, Pascal Cleatus Poolaw Jr., a Spc. 4, had been wounded in Vietnam in February 1967. The younger Poolaw was hit by a mine and received metal fragments in the legs. His right leg had to be amputated below the knee.

When the senior Poolaw finally reached the port of departure on the West Coast, he discovered Lindy had left for Vietnam the day before. He decided to follow his son.

Having the father and son of the Family serving in combat at the same time was nothing new to Poolaw. He had served in World War II with his dad, Ralph Poolaw Sr., and his two brothers.

Poolaw served almost four months in Vietnam before the fatal combat operation. In a letter he wrote just before his death, Poolaw said he rated his job as being more important than his life.

In her eulogy at Poolaw's funeral at the Fort Sill Post Cemetery, his wife, Irene, echoed those sentiments. "He has followed the trail of the great chiefs," she said. "His people hold him in honor and highest esteem. He has given his life for the people and the country he loved so much."

## MEDAL OF HONOR RECIPIENTS

On this day in 1967, a Navy chaplain makes the ultimate sacrifice as he ministers to his Marines during the Vietnam War. [Father Vincent Capodanno](#) would receive a Medal of Honor for his selfless actions on this day so long ago. Father Capodanno has since been declared a “Servant of God” by the Catholic Church, and he is now being considered for sainthood. Capodanno was no ordinary military chaplain! In fact, he was affectionately dubbed “The Grunt Padre” by his men because of his insistence upon sharing their burdens and duties—however dangerous they might be. “He was not a religious leader who did his job and then returned to the comfort of his own circle,” Capodanno’s biographer writes. “He lived as a Grunt Marine. Wherever they went, he went. Whatever burdens they had to carry, he shared the load. No problem was too large or too small to take to Father Vincent—he was available to them day and night.” That approach would cost Capodanno his life during Operation Swift, a Vietnam War operation during the fall of 1967.

On September 4, a portion of Capodanno’s battalion was ambushed. The conflict turned into an all-out battle. As a chaplain, Capodanno could easily have remained at the company command post. All things considered, it was a much safer place to be! But it also went against the grain for Capodanno to stay in a place of relative safety when his men were suffering. He wanted to be with them. He “ran through an open area raked with fire, directly to the beleaguered platoon,” his [Medal citation reports](#). “Disregarding the intense enemy small-arms, automatic-weapons, and mortar fire, he moved about the battlefield administering last rites to the dying and giving medical aid to the wounded.” During the course of his ministrations, Capodanno was seriously wounded in his arms and legs. His right hand was partially severed. And yet he continued on.

Capodanno was at the side of Sergeant Lawrence Peters when Peters passed away. The Sergeant had acted so heroically during the battle that he would receive his own Medal of Honor! Peters did not have to die alone because of Capodanno. Another Marine, Corporal Ray Harton, was wounded that day. Father Capodanno found him as he lay bleeding there on the battlefield. “As I closed my eyes, someone touched me,” Harton later reported. “When I opened my eyes, he looked directly at me. It was Father Capodanno. Everything got still: no noise, no firing, no screaming. A peace came over me that is unexplainable to this day. In a quiet, calm voice, he cupped the back of my head and said, ‘Stay quiet Marine. You will be okay. Someone will be here to help you soon. God is with us all this day.’”

The end came when Capodanno noticed a corpsman struggling with a wound to his leg. An enemy machine gun was still trained on the young man. “Fr. C. ran out to him and positioned himself between the injured boy and the automatic weapon,” Lieutenant Joseph E. Pilon later related. “Suddenly, the weapon opened up again and this time riddled Fr. C. from the back of his head to the base of his spine—and with his third Purple Heart of the day—Fr. C. went Home.” When Father Capodanno’s body was recovered, it had 27 bullet wounds in it.

As we head into the halfway point of our term, now would be a good time to examine your goals and make adjustments as necessary.





# VIETNAM WAR STORIES

This image is of Lt. Rick Rescorla, an Army infantry officer who was photographed as he fixed his bayonet in the Ia Drang Valley in 1965. The image graced the cover of the first edition of the book, *We Were Soldiers Once and Young*, written by Lt. Gen. Hal Moore and Joe Galloway.

Rescorla would earn a Silver Star and Purple Heart and other awards, surviving the famously fierce battle. During battles, he was known for singing battle hymns which helped calm those around him. He went on to serve in the Army Reserve until his retirement as a colonel in the 1990s.

On Sept. 11, 2001, Rescorla was a director of security in the south tower of the World Trade Center. After the aircraft hit, Rescorla went up into the towers to help people evacuate. Evacuees who were helped by Rescorla said that through the smoke they could hear a man singing so they followed the sound which led them to Rescorla. He directed them to safety, down and out of the building.

He is credited with saving more than 2,700 lives. He was last seen climbing higher into the towers with his security team to help those that were trapped in the higher floors who still needed help. His body was never found. He was [StillServing](#) back then!

# CHIEF OF STAFF

Comrades,

A quick look at MEMSTATS for October 16, 2021, shows that 23 of our 25 Posts are over 90% in membership. Of those 23, thirteen are over 95%! And two Posts have already achieved 100% in membership – Korat and Ban Chang. The Department of Pacific Areas started the new VFW year (July 1) as the top Department in the Nation, and 3 ½ months later, we are still number 1 in the Nation for membership.

As I'm sure you know, this doesn't happen by accident. It takes dedicated members who want to see our organization grow to ask other qualified veterans to join our ranks. We currently have 53 members who have recruited at least 1 new member this year. Notably, John Bowers from Post 9723 has recruited 15 new members; Joe Perkins from 8180 has 7; SVC "Max", also from 8180 has recruited 5; and Alex Roesse from Post 12130 has recruited 5.

I am positive that our Life Member Incentive Program will keep us at the top spot if we take advantage of it. Even younger veterans will be tempted to join for Life if they are given a \$100 discount. And it only costs your Post \$20 once you recruit 5 new Life members. 10 LM's for the larger Posts.

With COVID restrictions loosening up in many countries, and the holiday season right around the corner, opportunities for recruiting should be plentiful in the next few months. Wouldn't it be great if the current number of 53 recruiters doubled before Christmas! If you are already a recruiter, teach another comrade how to do it and what it takes to convince a vet to join the VFW.

I believe that next year we are going to see some major changes to the National Membership Program. Recruiters will receive National recognition like we've never seen before. Instead of just Commanders and Quartermasters receiving membership recognition, recruiters will also receive awards like Henry rifles and "All-American Recruiter" caps.

So, let's get started now and build up our recruiter numbers by training fellow comrades who just need a little help from a seasoned recruited to become a super-recruiter in their own right. Together, we can do it!

## POW MEMORIAL AT THE BRIDGE

On SEP 14 1997, the Veterans of Foreign Wars Department of Pacific Areas District Five dedicated a memorial to the US POWs who worked and died on the Thai-Burma Railway during World War II.

It was the culmination of years of work and dedication by a handful of VFW members, led by District CDR Leon "Dick" Vileo with major contributions by Bob White, Jim Picha and Pete Evers

It took great dedication and persistence to obtain permission from the Thai Railway Authority to place the monument and memorial plaque beside the rails at the now famous Bridge over the River Kwai.

On that day, a large ceremony was held with many dignitaries present included US Ambassador William Itoh (who gave the dedication speech). The ceremony was also attended by military members from other embassies, members of the VFW (including Pacific Areas VFW CDR Michael Jugan) and both a USMC (US Embassy) and VFW color guard. Our Thai hosts were represented by the Governor of the Province and others.

On the plaque as it sits today beside the tracks near the infamous Bridge, the number of US POWs who died while working the Thai-Burma Railway was mis-stated. This was through no fault nor lack of attention to detail of the men who dedicated their time to this effort. The number of 356 was a commonly held belief at that time. In fact, a plaque at Commonwealth War Graves Commission cemetery in Thanbyuzayat Burma makes the same statement. Pursuant to this fact, it seems fitting that we attempt to update this data with a new memorial.

The Dept. of Pacific Areas, District Five, and the eight posts wish to thank that small group who worked tirelessly to ensure that the small contingent of US POWs was remembered. This act of remembrance of those Veterans clearly shows that "Every Veteran is a Hero". Beginning about 2015, a multi-year journey was begun following the mandate in the Congressional Charter of the VFW to "perpetuate the memory and history of our dead" and remember those POWs. We have been following their journey and the location of resting places of our "Fallen Comrades" and documenting their history.

It is highly unlikely that we could ever get permission to place a second memorial near the Bridge. Nor would it seem fitting to do so. There is no reason to diminish the effort of our 1990's predecessors.

Over time and with help from a grant from VFW National HQ, there are two goals for a second remembrance of those brave men. Those are: 1) to document the saga of these POWs as it had never been told before; 2) to display that information at various sites in Kanchanaburi that would allow visitors to access more of their story. In fact, that format was the impetus behind the website that resulted in the website: [www.uspowtbr.com](http://www.uspowtbr.com)

In the near future, we hope to be obtain permission to place 4 plaques in the Kanchanaburi area. These plaques would contain the following statements:

*Dedicated to the 131 members of US Military POWs who **died** while laboring as POWs on the Thai-Burma Railway. (65 Army; 62 Navy & 4 Marines)*

*Dedicated to the US Military POWs of the 2 Bn 131 FA and the USS HOUSTON who **died elsewhere**; (21 Army; 9 Navy; 1 USMC; including 19 lost at sea)*

*Dedicated to the 551 members of US Military who **survived** the ordeal of laboring on the Thai-Burma Railway. (309 Army; 211 NAVY & 23 Marines). Also included are 7 members of the US Merchant Marine and 3 US civilians.*

*Dedicated to the 666 members of the TXNG, the USS HOUSTON and the SS Sawolka who **died prior** to becoming POWs. (3 Army; 606 Navy; 41 Marines & 16 Merchant Mariners)*

It is our sincere hope that we can bring this project to fruition presented by integrating with the plans by the Thai government to enhance the tourist experience in Kanchanaburi to include such an expanded memorial.



# JUDGE ADVOCATE

I was recently asked what was needed for a post to change its name. It requires more than just changing the name on the door or your post website. To make it official this is what's required.

## Manual of Procedures **Sec. 208 - Change of Name**

A Post may, after at least thirty (30) days written notice to the Department Commander and members of the Post, change its name upon a two-thirds (2/3) vote of the members present and voting at a regular or special meeting. Upon recommendation of the Department Commander, an amended Charter will be issued by the Commander-in-Chief. No change may be effective until an amended Charter is issued.

A Post shall not change its name to the name of a living person, other than a living Medal of Honor recipient, only after written consent from the recipient has been received, nor adopt a name already adopted by another Post in good standing in the department.

The Application is available in the VFW Training & Support under the Forms Tab.

## VFW Podium Edition




### Meeting Attendance:

Pursuant to VFW By-Laws, Section 503, this meeting will be conducted using the Zoom Meeting Platform.

1. Each member is responsible for his or her connection to the meeting; no action shall be invalidated on the grounds that the loss of, or poor quality of, a member's individual connection prevented participation in the meeting.
2. To ensure all features are available to the user, each member is responsible for upgrading their zoom app to the latest version.

### Meeting Guidelines:

1. Department Adjutant will be the meeting host and is responsible for sending the meeting invitation and the meeting link to all council members and invited guests.
2. The Department Adjutant will also serve as the moderator and control the meeting per direction of the Department Commander.
3. Invited guests, (Non-members of the Department of Pacific, if any) will be pre-approved by the Department Commander.
4. Required reports will be submitted electronically to the Department Adjutant and included as an attachment to the minutes.
5. Important documents may be displayed to those in attendance using the share screen feature.
6. The meeting will be recorded and kept on file for future reference.
7. When addressing the assembly, members shall be in camera view while speaking.
8. Members shall mute themselves when not addressing the assembly.
9. For those rituals that call members to attention, you will remain seated at attention.
10. Caps will be removed during all prayers.
11. The meeting host to disconnect or mute a member's connection if it is causing undue interference.

# COUNCIL OF ADMINISTRATION

## Motion - Procedural Guidelines:

Once the Presiding Officer has acknowledged a motion and it has been seconded it may now be open for discussion.

Any member, when duly recognized by the Presiding Officer may speak on the motion for clarity, either for or against.

Every member is automatically entitled to speak once on a debatable motion before the body unless the body, by a 2/3 vote, has ordered the discussion closed. After discussion has been voted closed, no one can debate a motion—except by unanimous consent.

A member is also automatically entitled to speak a second time on the same question the same day, unless other members who have not yet spoken on the question actually rise to claim the floor to speak. If no one rises, he may speak a second time.

No member shall speak more than twice on the same question, nor longer than 10 minutes the first time and no more than 5 minutes the second time.

No one may automatically speak a third or further time if anyone in the assembly objects.

Only Council members are allowed to vote on any motion before the body.


Prior to any voting the Department Quartermaster will determine the voting strength based on the number of delegates present and voting.

Each member of the Council will only be entitled to one (1) vote.

The old professor answered, "Yes, I remember the situation with the stolen watch, which I was looking for in everyone's pocket. I didn't remember you because I also closed my eyes while looking."

This is the essence of teaching: If to correct you must humiliate; you don't know how to teach."



# THE LEGEND OF ABRAHAM WALD

The year is 1943. American bombers are suffering badly from German air defense. The military decides it needs some advice on how to cut losses, so they consult the wizards in the Statistical Research Group at Columbia University to see what their best options might be. One possibility is to use more armor on planes, but armor weighs a lot, and adding too much would lower performance considerably. So the Air Force brass ask the SRG, how much armor should we use for optimal results, and where should we put it?



The SRG was one of several collaborating groups of scientists formed soon after America joined the war. The story of its beginning, in the summer of 1942, is told well in [W. Allen Wallis' autobiographical memoir](#). The SRG was staffed by a distinguished lot, including many of the most prominent statisticians of the post-war world, the economists Milton Friedman and George Stigler--who were later to receive Nobel Prizes in economics--and the mathematician Abraham Wald. Norbert Wiener was at one time a consultant to the group. Recruitment to the SRG was by an "old-boy" network (to use a phrase also applicable to that other successful war-time operation across the ocean at Bletchley Park), but it prided itself on what we would call diversity.

Wald was born in the former Austrian-Hungarian empire in 1902, in the city now called [Cluj](#). It advertises itself as the unofficial capital of Transylvania, which is now a part of Romania but inhabited in the past largely by Hungarians, and Hungarian was Wald's mother tongue. He started his professional life in Vienna as a pure mathematician, but became interested in the mathematics of statistics in the mid-thirties. As a Jew, he was deprived of his academic position in Austria, and like others in his situation was lucky to be able to move to the United States. At the time the SRG was founded, he was on the faculty of Columbia University, which is where the SRG was located, and he was one of its first members. By all accounts, he was impressively bright--"smartest man in the room," says one recent book (but keep in mind, most of the time there were many smart men in the room).

The problem of armoring planes is assigned to Wald. Along with the assignment, he is given a fair amount of statistical data regarding aircraft damage, for example the location of damage from hits by enemy aircraft. It happens that most of the damage is located on the fuselage and very little in the area around motors, and the military is expecting to add armor to the fuselage, where the density of hits is highest. "Not so fast," said Wald. "What you should really do is add armor around the motors! What you are forgetting is that the aircraft that are most damaged don't return. You don't see them. Hits by German shells are presumably distributed somewhat randomly. The number of damaged motors you are seeing is far less than randomness would produce, and that indicates that it is the motors that are the weak point." The advice is taken, and in fact Wald's techniques for interpreting aircraft damage statistics continue through two later conflicts.

# NATIONAL HOME CHAIRMAN

Comrades, I received an update on the Eligibility for the National Home. There are three lanes of eligibility through which a family can apply to live at the National Home. Eligibility stems from the child or children in the family. They are:

- A veteran family (at least one parent that has served and been honorably discharged).
- An active duty military family (a parent is currently serving in the armed forces or reserves).
- A family that is related to a VFW or Auxiliary member (this include step-parents/grandparents).

This third lane is the most wide-reaching, as many people living in the United States have a parent or grandparent who has served. Sometimes, the child's parent or grandparent is not a VFW or Auxiliary member, but are eligible to become one. If they become a member, then the family is eligible to apply to live at the National Home.

The first step to living at the National Home is always through our Helpline at **800.313.4200**. Helpline staff will help callers to determine eligibility.





## LIFE'S LESSONS

The first police officer reaches under the one-ton bale of hay and attempts to lift it off of me. Of course, it doesn't budge. He grabs his flashlight and shines it under the hay into my face. I blink. He yells over his shoulder to his partner, "He's alive! He's alive! Help me move the hay."

Even working together two officers can't move it – not a fraction of an inch. A thousand pounds each? Of course, they can't move it.

"Cut the strings," I whisper. My voice is weak. They can't hear me.

I am not going to last much longer. If they just cut the strings, the bale will break apart, and they can drag me out of here.

"Lift, Joe, lift!"

"Just cut the strings," I mumble, "Please cut the strings."

"C'mon harder."

"It's too heavy! We can't lift it. We gotta go for help! Hang on, we'll be right back!"

I am alone again in the growing darkness. Wonderful painless, peaceful, irresistible sleep beckons. I struggle to remain conscious. One. Two. Three. Four... Where are they? How long does it take for police, fire, ambulance, to arrive? Where is the Coast Guard? Where are the Marines? Where is that one old farmer with enough common sense to just cut the strings?

The desert air grows chilly as the sky darkens. I grow weaker. Dizziness overcomes me and I begin to drift off into that gray space somewhere between the living and the dead.

Help finally arrives. One of the police officers bends down so I can see his face. "Hold on! A fire engine is here. There are six men aboard."

I do the math. Two big, strong cops and six burly firemen must move a ton of dead weight off me. That's two hundred forty five pounds each. No way can they possibly do that – but somehow, miraculously, they do. A couple of neighbors who have arrived at the scene stand by to catch me. They lower my limp body to the ground where I lie in a broken heap.

Why didn't they cut the strings? They could have saved a long, tortured hour.

How heavy is hay? A piece of hay is about the weight of a feather. How many pieces of hay does it take to make two thousand pounds? Lots. That package of sixteen bazillion individual pieces of hay wrapped in a gigantic bundle is a crushing weight. But separated, it would have been nothing. I feel bad saying this, because it makes me sound ungrateful – and I am very grateful to the guys who saved my life that night – but there is a point to be made here, isn't there?

Is it too big?

Is it overwhelming?

Cut the strings – just cut the strings!

Are you buried under crushing burdens? Projects that are too huge? Schedules that are too complicated? Maybe you are trying to do too much at once – trying to do everything instead of doing something.

Cut the strings and cut yourself free. Do one thing at a time – and get it Done.



## DEPARTMENT SERVICE OFFICER (DSO)

Why are you waiting? Time Fly's

Once or twice a week I get someone in the office that says, "I want to file a claim" or "the VA denied my claim" and I find out they are a Vietnam vet or a Gulf War vet and have legitimate issues but never filed. When I ask why – "I didn't think I would get it" or "I just didn't get around to it" or "I was always drunk". From 6 months before discharge until today, NOW is the time to file.

Even if it has been 30 or 50 years contact your Post Service Officer or one of our excellent ADSO's and start your claim. If you are already service connected, has the condition become worse? As we age things that were OK become really 'not OK'. You can also do it yourself on [VA.GOV](http://VA.GOV).

For those of us in the Pacific (and Europe) it's also the shock of leaving CONUS and finding out the VA will only reimburse you for "service connected" Doctor and hospital bills (and related drugs), and only through FMP – and not retroactive. If you go to the doctor today and apply for FMP tomorrow – no reimbursement. If you have new S/C disabilities since you filed with FMP you must send them the upgraded list of disabilities. Nine times out of ten, they won't look it up.

If you have not applied for FMP (Foreign Medical Program) do so NOW –

The other time sensitive thing is caring for your loved ones.

I recently married my girlfriend – I told a few people and one of my friends told me another friend (he did not name) said "why did he do that". In my case it is because I love her and want her to be OK after I depart the earthly bounds. It is also because I want the kids to be something other than a "trike driver" or a "girlfriend". If you are service connected the kids might get a good education, and go to the University. If the stars align and you die from a service-connected condition your wife or husband may get Dependency and Indemnity Compensation (DIC) .

So why does time matter?

First, there is no applying for service connection AFTER the veteran Dies. Even if he did apply and get awarded before he died, time is critical. I can't count the number of times I have seen "GI Joe died last week after a brief illness".

You may be eligible for DIC benefits if you are a surviving spouse who:

- Married a Service member who died on active duty, active duty for training or inactive duty training, OR
- Married the deceased Veteran before Jan. 1, 1957, OR
- Married a Veteran who died from a service-connected injury or disease, as long as the marriage began within 15 years of discharge, OR
- Married the deceased Veteran for at least one year, OR
- Had a child with the Veteran and cohabitated with the Veteran until their death.

## DEPARTMENT SERVICE OFFICER (DSO)

There are things that matter more than what is on the retched news. If you die service connected, even if everything is smooth it will be at least 4 months before the first check arrives. How will the rent, utilities, food and everything be paid for if all your assets are locked in a US savings account. What are your monthly bills times 4 and is it accessible to your surviving spouse? Some banks lock up the deceased funds until probate is finished, often even a joint account. Often a year or more, depending on the country you are in. Check with your bank. So, 4 months minimum expenses in a coffee can, a safe, an account in their name only. Don't be the one whose survivor is dragging the furniture into the street to pay the rent (I have seen this!). I too often hear "I don't care what happens after I die". None of my business, but that seems really sad, particularly if you just assume the VFW will take care of them. Neither the VFW or the VA is going to pay their rent or feed them.

## A LITTLE BIT OF HISTORY

On 31 July 1854, the man who was the probable inspiration for Uncle Sam passes away during a cholera epidemic. Did you know that there was likely a real person behind the Uncle Sam character that you are used to seeing?

Samuel Wilson was born on September 13, 1766, in Massachusetts. Legend has it that, when he was only 15 years old, he tried to join the Continental Army. He was not assigned to fighting duties (probably because of his age); instead, he would have served as a “service boy,” possibly guarding cattle and providing the troops with meat. The story of his Revolutionary War service is appealing, but it hasn’t been proven.

After the Revolution, Wilson and his brother moved to Troy, New York. Before too long, they’d begun a meatpacking business that became quite successful. Eventually, they had relatives and other community members working for them. Wilson was well-loved! He gained the nickname, “Uncle Sam,” even among those who were not related to him. This nickname became more nationally prominent during the War of 1812.

At the time, Wilson’s company was helping to provide meat to soldiers. When the barrels and crates of food arrived for the Army, they were stamped with the initials “E.A.-U.S.” The initials “E.A.” were a reference to a government contractor, Elbert Anderson. The “U.S.” meant that the crates were the property of the U.S. government. But the letters soon took on a new meaning.

As the story goes, a visitor saw barrels of meat being unloaded and did not know what the “U.S.” stood for. He asked a worker, and the worker jokingly responded: “Uncle Sam.” He meant his boss, but the joke soon spread. “Uncle Sam” was feeding the army!

Actually, the joke REALLY spread. As early as 1813, a newspaper article would reference Uncle Sam as a substitute for the United States. By the 1830s, Uncle Sam was being drawn in newspaper cartoons. After the Civil War, cartoonist Thomas Nast gave Uncle Sam his final makeover. Uncle Sam was drawn to look a bit more like Abraham Lincoln: He was thin and had a goatee!

Was he intentionally drawn to look like Lincoln? Nash never explained himself, but some have argued that Uncle Sam’s image was instead based on a popular circus clown from the era: Dan Rice. Either way, the image stuck, and this idea of Uncle Sam was used extensively in recruiting posters during the World Wars.

Not everyone has bought into the idea that Samuel Wilson inspired the Uncle Sam character. However, on September 15, 1961, Congress decided that he did. A resolution was approved “saluting Uncle Sam Wilson of Troy, New York, as the progenitor of America's National symbol of Uncle Sam.”

Sometimes just showing up for an event or ceremony creates a stronger bond in the community.
- Volunteer at a local chapter of a Veterans Service Organization (VSO) such as the Red Cross, AmVets, Disabled American Veterans (DAV), American Legion, etc.
- Donate professional services to military communities. Are you a professional counselor, psychologist, social worker, therapist, child care professional, or community organizer? Private and chartered organizations serving military families may need your expertise to make an impact in military communities whether active duty, Guard, Reserve, retirees, etc.
- Contact your nearest chapter of the [Navy/Marine Corps Relief Society](#), [Air Force Aid Society](#), [Army Emergency Relief](#), or [Coast Guard Mutual Assistance](#), to volunteer or participate in scheduled events to support their efforts. The winter months are prime fundraising and support time for these societies as they gear up to assist military families over the holiday season. The annual Toys For Tots drives and similar efforts held by these agencies are always in need of volunteer help.

## December

Pearl Harbor Day 7 December

Just before 8am on the morning of December 7, 1941, hundreds of Japanese fighter planes carried out a devastating attack on the Pearl Harbor American Naval base in Honolulu, Hawaii, on the island of Oahu. The Japanese aircrews managed to achieve complete surprise and for two hours, Japanese fighter, bomber and torpedo planes carried out a shocking assault on the naval base.

### Pearl Harbor Facts

The base was attacked in two waves by a total of 353 Japanese fighters, bombers and torpedo planes.

- There were 165 U.S. Naval ships involved. 20 were damaged. 12 of those were back in service in less than 1 year.
- All 8 U.S. Navy battleships were damaged; 4 were “lost in action.”
- All but one battleship were raised and 6 were returned to service and fought in the war.
- No Aircraft Carriers were in port at the time of the attack.
- Japan also launched attacks on U.S. troops in Wake Island, Guam, Malaya, Thailand and Midway that same day. Wake Island, Guam, Malaya, and Thailand would all eventually fall to the Japanese.
- Pearl Harbor Casualties:
  - 2,008 naval officers killed; 710 wounded
  - 218 Army personnel killed; 364 wounded
  - 109 Marines killed, 69 wounded
  - 68 civilians killed, 35 wounded
  - A total of 2,402 Americans were killed, 1,178 wounded

# VMS CHAIRMAN

The VFW offers a wide range of assistance programs aimed at helping service members and veterans of every generation. As a veteran, you understand better than most what struggles and hurdles today's service members and veterans face. Here are some of the assistance programs offered by the VFW:

**Student Veteran** includes the **Fry Scholarship** - Qualifying children of service members who die in the line of duty after September 10, 2001 are eligible for the Post-911/GI Bill, **Rural Benefit** - Certain veterans who relocate from highly rural areas to attend college may be eligible for a one-time \$500 payment to help defer costs associated with relocation, **Yellow Ribbon** -

Allows approved institutions of higher learning in the US and the VA to partially or fully fund tuition and expenses that exceed the GI Bill limits and **Scholarships** - Several national scholarships may be available to help defray some out-of-pocket costs for higher education.

VFW's "**Sport Clips Help A Hero Scholarship**" provides service members and veterans with the financial assistance they need to complete their educational goals without incurring excessive student loan debt. It's just another way for us to say "thank you" to those who fought for our freedoms.

**Unmet Needs** provides grants (not loans) and referrals to other organizations to active-duty service members, veterans and their immediate families to assist with basic life needs.

**Military Assistance Program (MAP)** provides financial assistance to VFW Posts/Depts. and Auxiliaries who sponsor events with their local military community. These funds are meant to build relationships and provide information on VFW programs and services.

**Adopt-a-Unit** VFW Posts work with unit commanders and senior enlisted personnel to develop supportive relationships with units before, during and after deployments. We offer a vast network of free resources and a variety of direct support for military members and their families.

**Student Veterans of America (SVA)** provides 10 exemplary VFW members who are student veterans the opportunity to make their voices heard on Capitol Hill and in their community.

Don't think of your donation as just an All-American/ALL-State requirement, but as a means in keeping these programs alive at helping service members and veterans of every generation.


