VJ Day, also known as Victory Over Japan Day, is observed on September 2 every year in the United States. It commemorates the official surrender ceremony of the Japanese aboard the USS Missouri in Tokyo Bay—an event that occurred on September 2, 1945. Patriot Day is an annual observance on September 11 to remember those who were injured or died during the terrorist attacks in the United States on September 11, 2001. POW/MIA Recognition Day is commemorated on the third Friday of every September, a date that's not associated with any particular war. Resolutions making it official were passed in 1979 by Congress and the president after the families of the more than 2,500 Vietnam War POW/MIAs pushed for full accountability. The remains of almost 82,000 Americans are still missing, according to the <u>Defense POW/MIA Accounting Agency (DPAA)</u>.

Operation Enduring Freedom (**OEF**) was the name used by the US Government for the Global War on Terrorism. On 7 October 2001, in response to the September 11 attacks, President George W. Bush announced that airstrikes targeting Al-Qaeda and the Taliban had begun in Afghanistan. Operation Enduring Freedom primarily refers to the War in Afghanistan, but it is also affiliated with counterterrorism operations in other countries. Congratulations to all the newly elected and appointed Comrades!!!

Our course remains clear, and that is focusing on taking care of Veterans. We must also be mindful of what drives our ability to do so and that is each and every Comrade in this Department. We are the fuel that drives the DPA engine and as we take care of ourselves, our duties and each other, we supercharge our efforts. Now is the time to plan ahead for awards and other administrative items that seem to sneak up on us toward the end of the term. Checklists and POAMs (Plans of Action and Milestones) are great tools to help us steer clear of administrative shoals. I will specifically be helping you with CSRs and AWARDS this year.

<u>CSRs</u>: They are no different than last year in that they are entered on the DPA website. Please fill them out as comprehensibly as you can. Refer to PAGE 8 of the All -State Program for general guidance on CSR entries. If you have an issue with one of your inputs, feel free to email me at <u>jvcdpa@vfwpacific.org</u> and I will do my best to resolve it. Specifically, if you need to update an entry with information or forgot to include something, let me know and I will go in and adjust as the system will allow. Don't forget the 3 CSR input requirement PER month.

<u>AWARDS:</u> I believe one of the reasons awards tend to be thought of as an administrative burden is because we sometimes don't focus on data collection until the need to turn in the award arrives. Post CDRs should, in whichever means is the easiest and most readily available, start entering individual line items (XX Comrades attended, participated, organized, etc. a Memorial Day remembrance ceremony, date, location, etc.) and/or those repetitive events that can be updated (Executed XX recruiting tables, recruiting XX new members). Use the meeting minutes as well since they should reflect events and other activities of the post and members therein. You can do the same with some of the other awards as well. Then when the awards are about to become due, you only have to organize your information. We can only recognize those Comrades and Posts for which awards are submitted. Also, don't forget about the DPA COMMUNITY SERVICE AWARD. No ticket, no ride.

DPA Community Service Award: Due to DPA JVC NLT 1APR23. Post Awards (ONE EACH) – Due to District Commanders or appointee District Awards Chairman NLT 15APR23. District Awards (ONE EACH) – Due to DPA JVC NLT 1MAY23.

MEDAL OF HONOR RECIPIENTS

Remembering Michael Joseph Daly who was an Irish American who served in the United States Army and received the United States military's highest decoration for valor the Medal of Honor for his actions in World War II.

Daly was born on September 15, 1924, in New York City, but resided his entire life in Fairfield, Connecticut, except for one year he and his wife lived in County Wicklow, Ireland. His father, Colonel Paul Daly, was a World War I and World War II veteran who was a recipient of the Distinguished Service Cross and was also nominated for the Medal of Honor twice but did not receive it. His great-grandfather Thomas F. Gilroy was an Irish immigrant who was the mayor of New York City in the 1890s.

Daly graduated from Georgetown Preparatory School in 1941 and joined the United States Army from Fairfield's Southport neighborhood in 1942. He attended the United States Military Academy in West Point, New York, where he was classmate of George Patton IV. While he was at the academy he was, by his own admission, a mediocre student. After having severe disciplinary problems and continuously being placed on special confinement and walking off punishment tours he resigned his appointment after only one year to fight in World War II. Sent to Europe as an eighteen-year-old infantry private, he trained in England and took part in the D-Day landings at Omaha Beach with the 1st Infantry Division. Daly participated in the drive through France and was wounded in Aschen, Germany, and was sent to England to recover. After he recovered, he was reassigned to the 3rd Infantry Division and was given a battlefield commission to second lieutenant. By April 18, 1945, he was a first lieutenant in command of Comp. A 15th Infantry Regiment, 3rd Infantry Division, 7th Army.

On that day, he led his company in their advance through Nuremburg, Germany, and single-handedly engaged German forces several times. As his unit passed a city square, a German machine gun opened fire, caus-

ing several casualties. Daly rushed the position and killed the three gunners. Advancing ahead of his men, he came across a German patrol preparing to use his rocket launchers to ambush American tanks. He again attacked alone and, despite being outnumbered and outgunned, killed all six patrol members. When a machine gun opened fire at close range, he picked up a dead man's rifle and killed the two-man German crew.

By fearlessly engaging in 4 single-handed fire fights with a desperate, powerfully armed enemy, Lt. Dal, voluntarily taking all major risks himself and protecting his men, killed 15 Germans, silenced 3 enemy machineguns, and wiped out an entire enemy patrol.

On April 19, 1945, Daly was shot through the head; a bullet entered at his ear and exited from the opposite cheek. He was sent to England and eventually the United States to recuperate. At about the same time, his father, who had been wounded in France, was also being evacuated to the United States. Daly was subsequently promoted to captain and on August 23, 1945, was awarded the Medal of Honor. In addition to the Medal of Honor, Daly received three Silver Stars, a Bronze Star with "V" device, and two Purple Hearts. This true American hero passed away on July 25, 2008, and he was buried at Oak Lawn Cemetery with full military honors.

We are forever grateful for his service.

A BIT OF HISTORY AND HUMOR

85 years ago on May 12, 1937, George Carlin was born in Manhattan. In the 1970s, he underwent a professional makeover going from clean cut to someone who represented American counter-culture. In 1972, he began performing his most well-known monologue "Seven Words You Can Never Say on Television" that got him arrested (pictured) and was the centerpiece of the 1978 Supreme Court case F.C.C. v. Pacifica Foundation which affirmed the government's authority to censor material on public airwaves. His 50-year career generated 23 albums, 14 HBO specials, 130 Tonight Show appearances and 3 books. Here are a few quotes (without any dirty words) in honor of the occasion:

- I think I am, therefore, I am ... I think.
- Isn't making a smoking section in a restaurant like making a peeing section in a swimming pool?
- I went to a bookstore and asked the saleswoman, 'Where's the self-help section?' She said if she told me, it would defeat the purpose.
- What if there were no hypothetical questions?
- Have you ever noticed that anybody driving slower than you is an idiot, and anyone going faster than you is a maniac?
- If you try to fail, and succeed, which have you done?
- When I ask how old your toddler is, I don't need to hear '27 months.' 'He's 2' will do just fine. He's not a cheese. And I didn't really care in the first place.
- If the black box flight recorder is never damaged during a plane crash, why isn't the whole airplane made out of that stuff?
- Think of how stupid the average person is, and realize half of them are stupider than that.
- Some people see things that are and ask, 'Why?' Some people dream of things that never were and ask, 'Why not?' Some people have to go to work and don't have time for all that.
- Most people work just hard enough not to get fired and get paid just enough money not to quit.
- 'Bipartisan' usually means that a larger-than-usual deception is being carried out.
- Fighting for peace is like screwing for virginity.
- Men are from Earth, women are from Earth. Deal with it.
- I have as much authority as the Pope. I just don't have as many people who believe it.
- One can never know for sure what a deserted area can look like.
- When you step on the brakes, your life is in your foot's hands.
- Some people have no idea what they're doing, and a lot of them are really good at it.

George Carlin died on June 28, 2008 in Santa Monica, CA. He was 71 years old

RULES FOR BEING HUMAN

<u>1. Rule One - You will receive a body.</u> Whether you love it or hate it, it's yours for life, so accept it. What counts is what's inside.

<u>2. Rule Two - You will be presented with lessons.</u> Life is a constant learning experience, which every day provides opportunities for you to learn more. These lessons specific to you and learning them 'is the key to discovering and fulfilling the meaning and relevance of your own life'.

<u>3. Rule Three - There are no mistakes, only lessons.</u> Your development towards wisdom is a process of experimentation, trial and error, so it's inevitable things will not always go to plan or turn out how you'd want.

<u>4. Rule Four - The lesson is repeated until learned.</u> Lessons repeat until learned. What manifest as problems and challenges, irritations and frustrations are more lessons - they will repeat until you see them as such and learn from them.

<u>5. Rule Five - Learning does not end.</u> While you are alive there are always lessons to be learned. Surrender to the 'rhythm of life', don't struggle against it.

<u>6. Rule Six - "There" is no better than "here".</u> The other side of the hill may be greener than your own but being there is not the key to endless happiness. Be grateful for and enjoy what you have, and where you are on your journey.

7. Rule Seven - Others are only mirrors of you. You love or hate something about another person according to what love or hate about yourself. Be tolerant; accept others as they are and strive for clarity of self-awareness; strive to truly understand and have an objective perception of your own self, your thoughts and feelings.

<u>8. Rule Eight - What you make of your life is up to you.</u> You have all the tools and resources you need. What you do with them is up to you. Take responsibility for yourself. Learn to let go when you cannot change things. Don't get angry about things - bitter memories clutter your mind.

<u>9. Rule Nine - Your answers lie inside of you.</u> Trust your instincts and your innermost feelings, whether you hear them as a little voice or a flash of inspiration. Listen to feelings as well as sounds. Look, listen, and trust. Draw on your natural inspiration.

10. Rule Ten - You will forget all this at birth. We are all born with all of these capabilities - our early experiences lead us into a physical world, away from our spiritual selves, so that we become doubtful, cynical and lacking belief and confidence.

The ten Rules are not commandments, they are universal truths that apply to us all. When you lose your way, call upon them. Have faith in the strength of your spirit. Aspire to be wise - wisdom the ultimate path of your life, and it knows no limits other than those you impose on yourself.

BALLAD OF THE TALL SUBMARINER

"Down the hatch, Down the ladder, Bonk the head, see brain cells scatter." And so it was, at the bottom of the main hatch, I turned to see my new home. It left an impression. On my right temporal lobe, specifically. It was more solid than anything I'd ever felt. Being a nub, I had no idea what I'd clocked my cranium on. But therein lay the beauty of the Submarine qualification program. I would soon be able to identify every single head trauma by ship's frame, subsystem, associated components, function, and nomenclature. It still hurt though.

My first destination was the ship's office. Maybe 20 steps through control and the upper level passageway - past Sonar, past Supply, across from Radio. In those 20 steps, I found two battle lanterns, two vents, two pipe mounting brackets the hard way. In somewhat of a daze, I took a hard draft reading of the ship's office door, height from the deck. It stood approximately 6'2". I was 6'4". I still remember which wrinkle of my aggravated forehead collected this data.

The first underway was the next morning. I met what would become my defining nemesis shortly. But first, the torpedo room/crews mess watertight door softened up the back of my head, ungently calibrating the extent to which I needed to bury my head in my chest to get my torse through. I would seen learn to ge feet first whenever



head in my chest to get my torso through. I would soon learn to go feet first whenever possible.

But immediate problems demanded immediate attention. Still rubbing the base of my skull, I discovered the vent in the crews mess - the one that protruded only an inch or so from the overhead, and painted to match (which is how everything gets painted on a submarine). It's edge caught me well up into the (1986 vintage) hairline, and with absolutely no warning. I rocked back a bit, and re-adjusted. And sat down a moment on one of the benches whereupon someone asked me where my qual card was, and why was I sitting and not working on it.

I tried not to glare. But the glaze in my eyes was misinterpreted. Sensing a tedious discussion, I stood back up, only to hit the same vent in the same spot. Yeah, the crew's mess wasn't going to be my friend.

I managed finally to stagger clear of the galley, only to bump-test a pipe at the top of the ladder to lower level. In my own head, the impact seemed to say, "Clang!" It would evolve into an entire battery of imagined sound effects, some of which I would utter out loud at times. This would prove later to be a bad idea.

It happened again on returning to the torpedo room, this time on the starboard torpedo ram handle that sat waiting for someone just over 6'2" to duck through the watertight door NOT feet-first, and in a hurry. There really was a "clang" that time, and may have been a couple minutes downtime. It happened again while avoiding the head valve in ops upper level. It happened in AMRLL. It happened in Shaft Alley. It happened in LL Berthing. Always, in my head, I heard and said, "Clang". And I moved on.

In a couple short weeks of underway, I memorized the overhead layout of the boat faster than anything else. I developed the skill of sensing impact with my hair, reflexively preventing the worst of impacts. As I would navigate a passage, my head would flop and bend like a curb feeler in a downtown Chicago Cadillac. The first few days' worth of damage had begun to heal, and my qual card began to fill out with signatures. I began to walk with a little confidence. I walked a little straighter, as it hurt to hunch constantly, letting my neck control my destiny.

And so it was that I came to be gliding through the crew's mess again one day, intent on my task at hand. With a full head of steam, I spectacularly failed to duck for the vent as I strode through towards the Torpedo room. What happened next is a little fuzzy, but there was a "clang" that wasn't mine. I was busy holding my head from the gritty impact on the Vent of Despair, which had set me down on a bench again, so someone took the liberty of saying it for me. In my misery, I burst out with some sailor-ish vulgarity, signaling to the ever-attentive crew that I'd reached some sort of emotional limit. Suddenly the entire space erupted in enthusiastic chorus of "Clang!"

And thus for many weeks, I endured being known simply as "Clang". The name lasted through my time of qualifying, until my next snarky outburst at the end of a stores load, when I found myself walking through lower level berthing on two layers of #10 cans, whereupon I carelessly said to myself, "hey! I'm Harry the Hamster, walking through my Habitrail.

INSPECTION PROCEDURES

2022-2023

The following are some of the key points regarding the inspection program for the 2022-2023 term.

We believe inspections are designed to identify potential problems and resolve them before they become serious issues within the post or district. As such we will refer to the program as the DPA Assessment and Assistance Program.

Inspections are a Department Program. MOP Sec 418 (11) & Sec 519 (9).

No later than 1 July each District Commander shall appoint an Inspector and if warranted an Assistant Inspector(s).

Inspectors should be thoroughly familiar with all VFW National and Department Programs, Policies, Bylaws, and Ritual. Preferably with experience as a District or Department officer, quartermaster, or trustee.

Each District Commander shall provide the Department Inspector the name(s) and contact information for all appointed Inspectors. Submit electronically to <u>inspd-pa@vfwpacific.org</u>. The Department Inspector will be the approving authority for all inspector appointments.

All assessments (inspections) shall be accomplished no earlier than 1 October and completed no later than 30 April.

The complete DPA Assessment and Assistance Program guidelines, as well as the NEW inspection form with instructions are available on the DPA website under programs/Inspections.

Look forward to working with all of you this term.

THAT'S NOT MY JOB!

This is a story about four people named: Everybody, Somebody, Anybody and Nobody. There was an important job to be done and Everybody was sure that Somebody would do it. Anybody could have done it, but Nobody did it. Somebody got angry about that, because it was Everybody's job. Everybody thought Anybody could do it, but Nobody realised that Everybody wouldn't do it. It ended up that Everybody blamed Somebody when Nobody did what Anybody could have done.

A BIT OF HISTORY

The interception of the Ocean vessel Rex was a training exercise and military aviation achievement of the United States Army Air Corps prior to World War II. The tracking and location of an ocean-going vessel by B-17 Flying Fortresses on 12 May 1938 was a major event in the development of a doctrine that led to a United States Air Force independent of the Army.

The mission was ostensibly a training exercise for coastal defines of the United States, but was conceived by planners to be a well-publicized demonstration of the capabilities of "heavy bombers (as) long range instruments of power"

In July 1921, promoting the concept of an independent Air Force, Gen. Billy Mitchell staged a series of aerial bombing exercises that resulted in the sinking of the former German battleship Ostfriesland by the U.S. Air Service. Although he incurred the enmity of the Navy, which considered the achievement nothing more than a publicity stunt, Mitchell continued to discredit the value of the battleship as the main weapon for projection of power by sinking several more obsolete ships in the next two years. However, the Air Service was limited by Army policy to being an auxiliary of the ground forces and was unable to obtain a role that would employ the use of long distance bombers

In May 1938 the Air Corps conducted one of the largest maneuvers in its history. 468 officers, 2,380 enlisted men, and 131 aircraft based on the East coast. The Navy, involved in fleet exercises off the West Coast, did not provide ships to play the role of the Black Force. The scenario was meant to depict simultaneous attacks on America by hostile fleets on both coasts, with the Air Corps tasked to defend against one of them.

When newspapers, including the Los Angeles Times, criticized the maneuvers for using a "mythical fleet" as a target, it was suggested that an ocean liner be substituted for naval vessels. The Italian Line's SS Rex was bound for New York and would pass the 1,000 nautical miles mark on 11 May, thus it was recommended that the Rex become the target for the interception.

At 08:30 on 12 May, the three B-17s took off from Mitchel Field at 08:45 and cruised east from Sandy Hook at 170 mph on a true course of 101 degrees through rain, hail, downdrafts, and an intense headwind that reduced their ground speed by 11.5 mph. The crew were unable to check the effect of the winds on ground speed and drift because of a heavy overcast that limited their altitude to 1,100 feet.

At 10:00 they emerged into good weather that lasted an hour. LeMay took double drifts until the B-17s had to separate to transit a cold front. At 11:15 they reassembled in clear weather on the other side, where they checked their course again. At noon the B-17s encountered an area of "scattered rain squalls, "spreading into a line abreast formation with the aircraft 15 nautical miles apart to increase their chances of spotting the Rex.

At 12:23, the bombers broke out of a squall line, and immediately sighted the Rex. "There it is! There it is!" transmitted by radio to the other pilots, twelve o'clock."

At 12:25, as predicted, the B-17s flew by the Rex while it was 620 nautical miles east of Sandy Hook. The aircraft reversed course and came up the ship's port side, "at smokestack level". The crew were in contact by radio with

the ship's captain, who invited "all members of the flight to come down to lunch." The ship's passengers filled its decks, waving to the bombers, with a group of Americans purportedly singing the Star Spangled Banner.

On 24 August 2007, three B-52 Stratofortress's of the 2nd Bomb Wing, successor to the 2nd BG, conducted "Operation Rex Redux", a training mission commemorating the interception of the Rex. Flying from Barksdale Air Force Base, Louisiana, and using the radio call signs Rex 51, Rex 52, and Rex 53, the B-52s intercepted the Military Sealift Command ship MV 2nd Lt. John P. Bobo east of Bermuda to test the capabilities of a new targeting system.

DEPARTMENT SURGEON

As your newly elected Surgeon for the Department. I wanted to take this opportunity to thank you for the honor and trust you have placed in me as your Department Surgeon.

Over the course of the next year. I will provide you with a range of information as it pertains to prevention and identifying potential member health issues, as well as information from our National Surgeon.

If there is ever a topic that you are seeking information on, or would like to pass along. Do not hesitate to reach out and send me your input.

For this issue of Pacific Times. I want to focus our attention on an ongoing health concern that affects all of us. This topic deals with Diabetes which knows no age limit, but is running rampant in our varying communities. As you know. Over the course of the past few years, we have lost several comrades due to complications with Diabetes.

Please take the time to read the following information. Also, share it with your loved ones. At times, they are quicker to notice these changes when we do not.

High blood sugar levels (or hyperglycemia) are a symptom of diabetes mellitus. They are also a precursor to this disease, which can be life-limiting. When you ingest sugar or any food high on the Glycemic Index (GI), your blood sugar levels quickly increase. They peak within 45 minutes of eating. In a normal person, the blood sugar then begins to decrease. Within 2 hours, it's back to normal levels. When you eat foods that are low on the GI, your blood sugar rises and stays level for an extended time before declining again.

In a diabetic person, the blood sugar levels cannot be managed by the body and do not lower. These constant high blood sugar levels place an enormous strain on the organs and cells of the body. After a prolonged period of not addressing high blood sugar levels, permanent damage is possible. That is why most diabetics have to use insulin. Our bodies produce insulin in the pancreas. A normal body produces enough insulin to control blood sugar levels. A diabetic's pancreas cannot produce enough insulin. So, people with diabetes must supplement the insulin supply in their bodies.

Another way to manage and minimize the blood sugar levels is to eat foods that are low on the glycemic index. That way the body's blood sugar levels are not on a rollercoaster ride of ups and downs. Therefore, most diabetics have to be careful about what they eat and drink. They avoid sugary drinks and foods rich in bad carbohydrates.

Studies suggest that many people have high blood sugar levels but aren't even aware of it. They are a ticking time bomb because their bodies are becoming more and more damaged. If they aren't aware of their condition, they won't change their eating habits and seek help. If you display some of these symptoms, you may have high blood sugar levels. A simple blood test can determine this. It may not yet be diabetes, and dietary changes and exercise will be treatment enough.

The wives smiled as they listened to stories, That they wished everyone would forget. Their husbands remembered old glories, Or something they'd done for a bet.

They remembered the good times together; They remembered being soaked in the rain; They remembered the hot and cold weather; But ignored all the suffering and pain.

Much later the drinking became slower, And the chatter then began to die down. The tone of those speaking grew lower, And foreheads began slowly to frown.

Thoughts turned to those who were missing, They remembered with fondness and pride. And their names came with warm reminiscing, Of old friends who had stood by their side.

DEPARTMENT SERVICE OFFICER (DSO)

"Enough is Never Enough". It sounds ridiculous written this way but time after time I will be talking to someone that says something like "when I left the service (retired, quit, medically retired) booted, etc., I got (insert percent) and I think that was fair, so I never saw a need to apply for more.

The VA is constantly adding new presumptive and areas where they were considered a problem. A good example is burn pits; another is contaminated water. Whether in tents or temporary buildings, there were often burn pits from the latrines in most places the military had a "temporary home". Gulf war vets were given "vaccinations" that are still in question and were exposed to smoke from burning oil fields, often for long periods. Functional gastrointestinal disorders, Chronic fatigue syndrome, Fibromyalgia, and Other undiagnosed illnesses, including but not limited to cardiovascular disease, muscle, and joint pain, and headaches can all be service connected. Afghanistan had new and varied gifts for our men and women in arms.

In case no one noticed we age. Let's say you fell off the back of a truck, jumped out of airplanes, slipped off an icy wing – the list is endless. In so doing you wrenched your back, twisted your ankle, or bonked your head. It's noted in your medical record that you were given pain medicine for a back injury and returned to duty. You hobbled around for a while and then seemed to get better. Young and resilient you kept on trucking. Thirty years later you have a bad hip, two bad knees, and a bad ankle. Maybe you didn't notice you favored one side or the other all your life. An examination from an ortho specialist might say all your physical issues might relate to that. Maybe not, but if it is, then the difference might be service connected. For those outside the US VA system, it would mean the difference between the Foreign Medical Program (FMP) paying for your visits and treatment or you either not get-ting treatment or paying for it yourself.

Post Traumatic Stress (PTSD) is another area where we often "shake it off" and say "it's just the way it is in the service" and try to ignore it. However, any number of life issues (continually fired, multiple divorces, alcoholism, etc.) might be related to being unable to detach yourself from an incident that occurred while you were in the service. Do not make the mistake of self-adjudicating and don't listen to the "bar experts". If you are already seeing a doctor, then talk to him or her about it. If you are not seeing a doctor, then it might be a good idea to investigate seeing one. Consider googling "VA DBQ" – as simple as that and look for the one that matches what you think was caused by your service. Print it out and take it to the doctor and ask them to fill it out IF you think there is a connection. You can then call or visit your local service officer to see about filing a claim with the VA, or do it yourself, there are instructions available.

This is not intended as an invitation to file dishonest or frivolous claims, but if you are suffering from something that was caused by your service then your uncle should help you with it. The VA is overloaded with claims, and many take more than a year to be adjudicated so fishing expeditions do not benefit anyone. However, every veteran should be compensated for those things that are affecting his or her life today because of what happened in service to their country.
