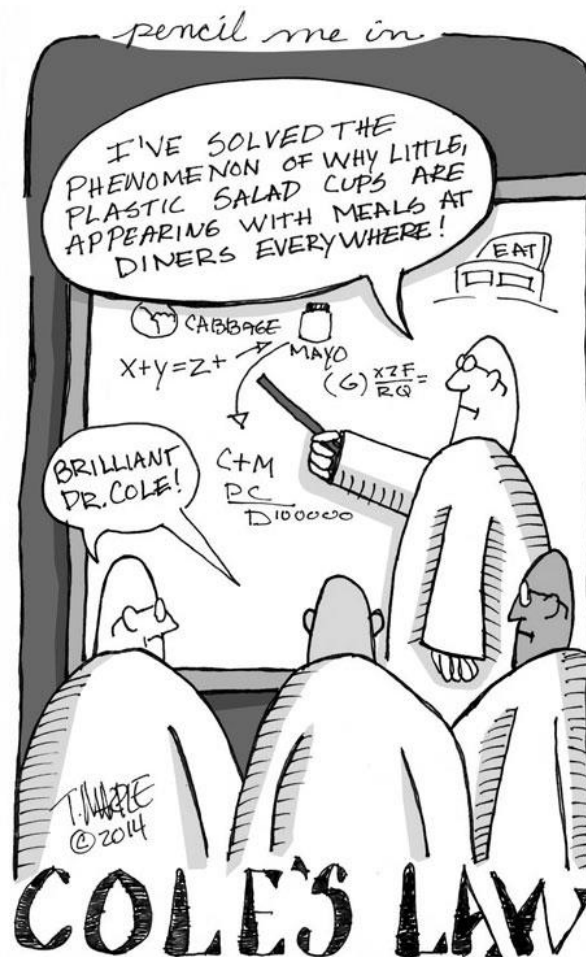

BZ to all the program chairpersons who “got'er done” and made sure we could recognize these outstanding citizens.

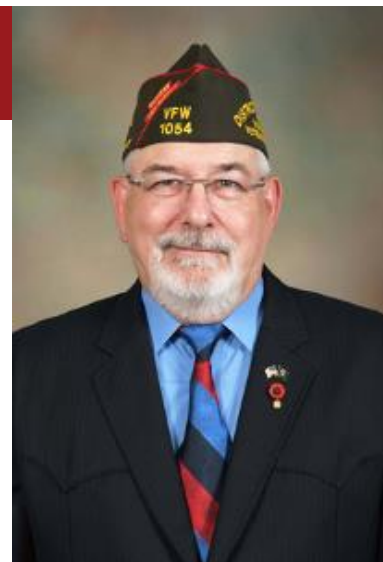

The “C” in CSR is for community, which means there are usually community members, active duty or Veterans involved in your activity. If it is just a post related task (attending a meeting, executing specific duties, etc.) it is most likely not a Community SERVICE-related task.

JUNIOR VICE COMMANDER

I would love to see at least one post from every district or a consolidated District event from each District in the Department of Pacific Areas involved and engaged in this Veteran led Community Service Projects initiative.

This is a great bridge to talk about the upcoming department awards cycle. One of these is the NATIONAL COMMUNITY SERVICE AWARD. This is a DEPARTMENT level award submission. To highlight some of the information contained in the award document located on the VFWPACIFIC website:

a. Purpose: This annual Department Award recognizes one Post that performed a community service project that had a significant impact on the community and demonstrated a positive involvement of the VFW within that community. The project should have an unusually profound effect on their community.

Notice the focus on PROJECT. It’s not about how many CSRs were entered or of what type.

b. Eligibility: any Post that has made significant contributions to VFW Department of Pacific Areas using the criteria and purpose stated in the Chairmans manual, may submit an application. The application shall be submitted to the Department JVC with a copy to their District Commander no later than 1 April.

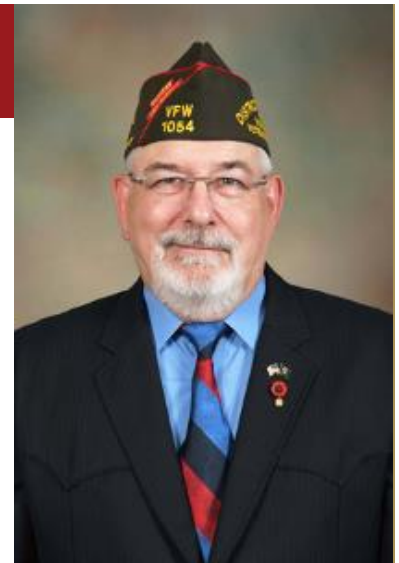
This is the only DEPARTMENT award that goes DIRECTLY to the JVC. All other Department Outstanding Awards Program entries shall be processed via the DISTRICT and a single selection for each category forwarded to the DPA JVC NLT 1 May (Public Servant Awards are processed and judged by the Chairman for that program and we should probably know the results before this article hits the news stand). Please start working on the Department Awards NOW! This will make it soo much easier to process and prepare as the deadline looms. Ok...getting back to the NATIONAL COMMUNITY SERVICE AWARD...

c. Criteria: Selection will be based on the significance and importance of a Community Service Project which had a profound effect on the local community and demonstrated a positive view of the VFW. The narrative describing the specific Community Service Project will include as a minimum the factors mentioned in the award submission form, paragraph 4.

So, the key word here is PROJECT. The focus is a specific project, and you can read up on the minimum factors in the application.

The DPA winner of this award will have their package forwarded to National and serve as the DPA National Outstanding Community Service Post awardee. VFW National will present The DPA selected Post with a plaque inscribed with the name of the VFW Post, a \$599 stipend to cover part of the Post representative’s expenses to the National Convention, publication of the Post’s name in the Convention program booklet, and a street sign identifying this national award for the Post to put up in their community.

These entries are all graded by National. Exceptional entries receive an Award of Excellence. Every Post Special Project receiving the Award of Excellence in the May judging will be entered in the Fred C. Hall Memorial Outstanding Post Special Project competition. The winning Post receives a plaque at the VFW National Convention and a \$1,000 service scholarship for community projects.

The Post Commander (or designated representative) and a guest will receive round-trip airfare, per diem and accommodations to receive the award at the VFW National Convention.

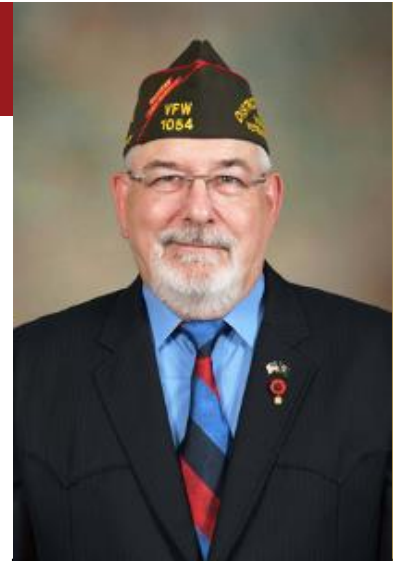

PACT ACT FREQUENTLY ASKED QUESTIONS



The PACT Act is a new law that expands VA health care and benefits for Veterans exposed to burn pits and other toxic substances. This law helps us provide generations of Veterans—and their survivors—with the care and benefits they've earned and deserve.

The Act **(1)** expands and extends eligibility for VA health care for Veterans with toxic exposures and Veterans of the Vietnam era, Gulf War era, and Post-9/11 era, and **(2)** expands eligibility for benefits for Veterans exposed to toxic substances.

What new or expanded presumptions will the Act create and when will they be in effect?

VETERANS AND SURVIVORS CAN FILE CLAIMS FOR ALL CONDITIONS OUTLINED IN THE PACT ACT IMMEDIATELY.

For Gulf War and post 9-11 Veterans, that includes:

Brain cancer, Glioblastoma, Respiratory (breathing-related) cancer of any type, Gastrointestinal cancer of any type, Head cancer of any type, Lymphoma of any type, Lymphatic cancer of any type, Neck cancer, Pancreatic cancer, Reproductive cancer of any type, Kidney cancer, Melanoma, Asthma (diagnosed after service), Chronic rhinitis, Chronic sinusitis, Constrictive bronchiolitis or obliterative bronchiolitis,

Emphysema, Granulomatous disease, Interstitial lung disease (ILD), Pleuritis, Pulmonary fibrosis, Sarcoidosis, Chronic bronchitis, Chronic obstructive pulmonary disease (COPD).

For Vietnam Veterans and other Veterans exposed to tactical herbicides, that includes two Agent Orange presumptive conditions:

Monoclonal gammopathy of undetermined significance (MGUS), High blood pressure (hypertension).

How can Veterans apply for VA health care?

Call our toll-free hotline at 877-222-8387, M-F, 8:00 a.m. - 8:00 p.m. ET.

Mail a completed, signed Application for Health Benefits (VA Form 10-10EZ).

Bring a completed, signed VA Form 10-10EZ with you to your [nearest medical center or clinic](#) or get help through your [state's Department of Veterans Affairs Service Officer](#).

Get help filing your claim by working with an [accredited representative](#).

What are the PACT Act key components?



The Act **expands and extends eligibility for VA health care for Veterans with toxic-exposures** and Veterans of the Vietnam era, Gulf War era, and Post-9/11 era.



VA **will improve the decision-making process** for determining what medical conditions will be considered for presumptive status.



Every enrolled Veteran will **receive an initial toxic exposure screening** and a follow-up screening every five years. Veterans who are not enrolled, but who are eligible to enroll, will have an opportunity to enroll and receive the screening.



VA health care staff and claims processors will receive **toxic exposure-related education and training**.



The Act requires **research studies** on mortality of Veterans who served in Southwest Asia during the Gulf War, Post-9/11 Veteran health trends, and Veteran cancer rates.



The Act will help VA **build a stronger, more skilled workforce** to meet the growing demand for benefits and services.



The Act authorizes **31 new medical facilities** across the country, providing greater access to VA health care.

How can a Veteran file a claim?



Veterans who would like to file a claim must complete [VA Form 21-526EZ](#) to apply for benefits and submit any supportive evidence.



To learn about standard VA disability claims, supplemental claims, secondary claims, and more visit: [VA.gov/disability/how-to-file-claim/when-to-file](https://www.va.gov/disability/how-to-file-claim/when-to-file).

If a Veteran was previously denied a claim, what can they do?

VA will contact Veterans when a presumption of service connection is established or changed. However, **Veterans previously denied a toxic-exposure related claim** are encouraged to file a supplemental claim. Once a supplemental claim is received, VA will review the claim under the new law.



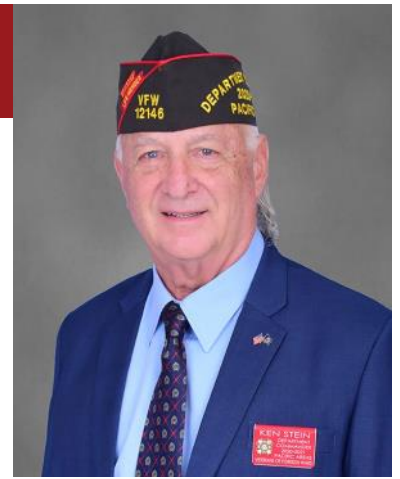

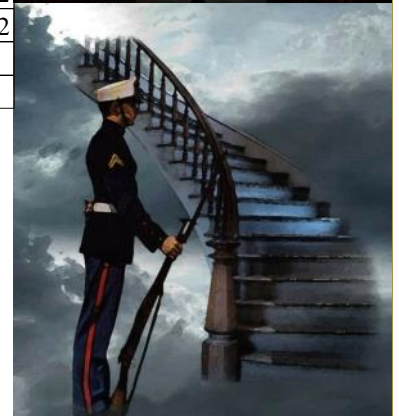

Inspections are almost complete. Six of the seven Districts have been completed as well as twenty one of the twenty five posts.

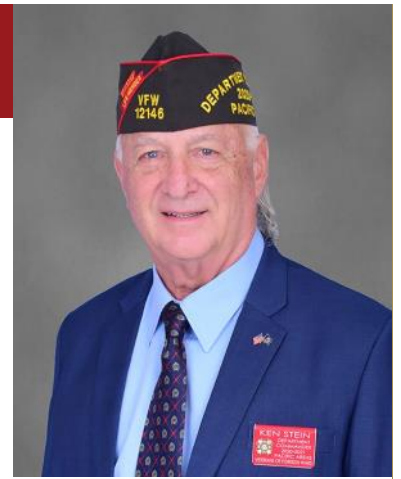
We expect by the end of January the inspections will have been completed.

Greetings Comrades

Guide for Electronic Meetings:

I think everyone will agree that in-person meetings are the preferred setting for conducting Post and District Meetings. However, there has been increasing preference among posts and districts to transact business at “electronic meetings,” in which some or all of the members communicate through electronic means. As stated in the VFW National Bylaws, Sec. 203, 403, Regular Meetings, Special Meetings, Committee Meeting, and Conventions, may be conducted or attended electronically providing the Quorum has been met and it allows participating members to communicate with each other simultaneously. Thus, providing a by-law provision for conducting “electronic meetings”

As you can see, this by itself leaves a lot of questions on how to conduct electronic meetings especially those that allow for both in-person and virtual attendance. In this case additional rules should be adopted to govern their conduct. Especially when they involve election of officers or other important issues.

These additional rules may be placed in your bylaws, adopted as special rules of order or standing rules. When developing these rules, there are many factors to consider and please note that one set of rules may not be appropriate for all types of electronic meetings.

The first is what internet platform best suits your needs? Of the options available, the most popular are Google Meet and ZOOM. The FREE versions of these programs normally limit the time and number of participants. In addition, many of the features needed such as share screen and the survey feature, are not active until you purchase the full-featured program. When selecting a program, you should also consider; what program is used by the other posts, districts, and the department? Is there a need of confidentiality? Are the funds available to purchase the program and maintain it? Keep in mind that additional equipment such as audio speakers, microphones and monitors may be needed to support electronic meetings.

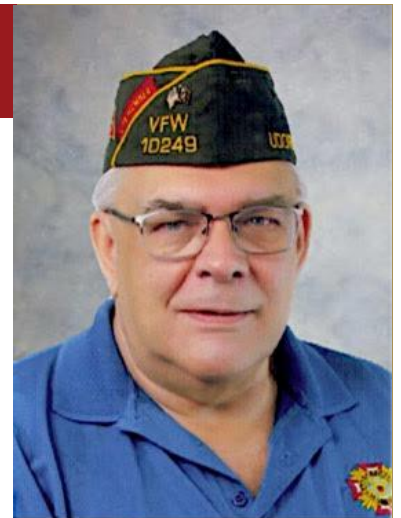
Things to consider:

- Is internet service available?
- Does the program support anonymous voting?
- Visible displays identifying those participating?
- Can you identify those seeking recognition to speak?
- Permit the display of pending motions?
- Showing the results of voters?

Voting: The preferred method of voting is the roll call vote. Per Robert’s Newly Revised, any anonymous vote conducted through the designated internet meeting service shall be deemed a ballot vote. Please note that Robert’s also states that all ballots must have the write in capability i.e., you can vote for someone not on the ballot.

Those members attending the meeting in-person would also fill out a ballot, fold it and place it in the ballot box or hand it to a teller to be counted. Some sort of measures should also be in place to ensure no one votes more than once.

Determination of a winner requires a majority of the votes cast. A majority **IS NOT** based on the number present at the meeting. It is based on the number *present and voting*. For instance, a member may abstain from voting. In which case they would not be counted. Example: if there are 40 members present at a meeting. A majority would be 21. If only 39 members vote the majority required would be 20.

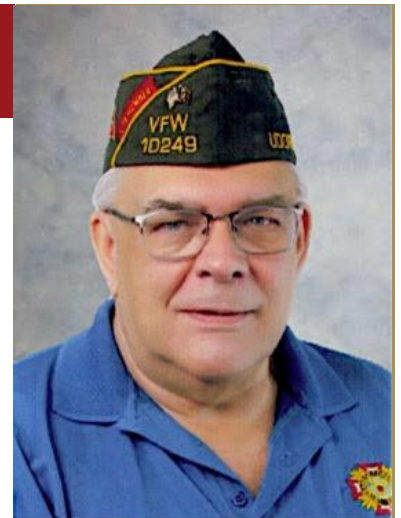
Sometimes two, three or even more members gather together to attend an electronic meeting. To allow each participant to vote using the online survey feature, each participant would need to have and use their own computer, smart phone or other device to vote. Remember, with the exception of delegates, each member is only authorized one vote.

Would it be best to include these additional rules in your bylaws? That's up to you. However, if you decide to include them in your bylaws, each time you amend them they must first need to be reviewed by department and then forwarded to National for final approval.

If you adopt them as a stand-alone document the membership could change them anytime with 2/3 majority of those members present and voting.

Here are some suggestions you may want to consider when developing Additional Rules for electronic meetings:

1. All meetings shall be conducted in-person with authorized virtual attendance. Using the _____ platform.
2. The Chair shall appoint a meeting moderator who, will control the meeting activities per direction of the Chair.
3. The adjutant shall send by e-mail to every (member of the post), (member of the governing body) no later than 15 days prior to the scheduled meeting. (24 hours for special meetings) the applicable date, time, and location of the meeting along with the URL for those wanting to join via virtual attendance.
4. The moderator will activate the meeting link 5 - 10 minutes prior to the scheduled start time. This allows the mediator time to see who is present and participating members time to check their speakers and mic.
5. Each member is responsible for downloading all required programs and keeping them up to date.
6. Each member is responsible for his or her connection to the meeting; no action shall be invalidated on the grounds that the loss of, or poor quality of, a member's individual connection prevented participation in the meeting.
7. The chair may order the meeting host (moderator) to disconnect or mute a member's connection if it is causing undue interference.
8. Should the meeting-room connection be lost any business transacted will continue as long as a quorum is maintained. Should the quorum not be present the meeting will be suspended and will not resume until connection is reestablished. If the connection cannot be restored in a timely manner the meeting shall be declared null and void, and the meeting rescheduled.
9. The chair shall be physically present in the main meeting room for all meetings.

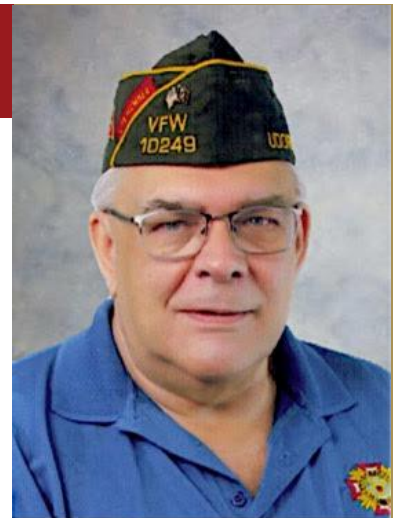

10. Members attending the meeting in-person will advance to the designated location so they can be seen and heard by all in attendance.
11. Members in virtual attendance will have their camera turned on when addressing the assembly.
12. Members in virtual attendance will have their microphones muted when not addressing the assembly.
13. All reports will be submitted electronically to the adjutant and kept on file per the DPA document retention policy.
14. Approval of standard reports such as the quartermasters monthly report, trustees report of audit and approval of the minutes shall be done by mutual consent i.e., show of hands.
15. Tailor these additional rules to best fit your needs and the environment.

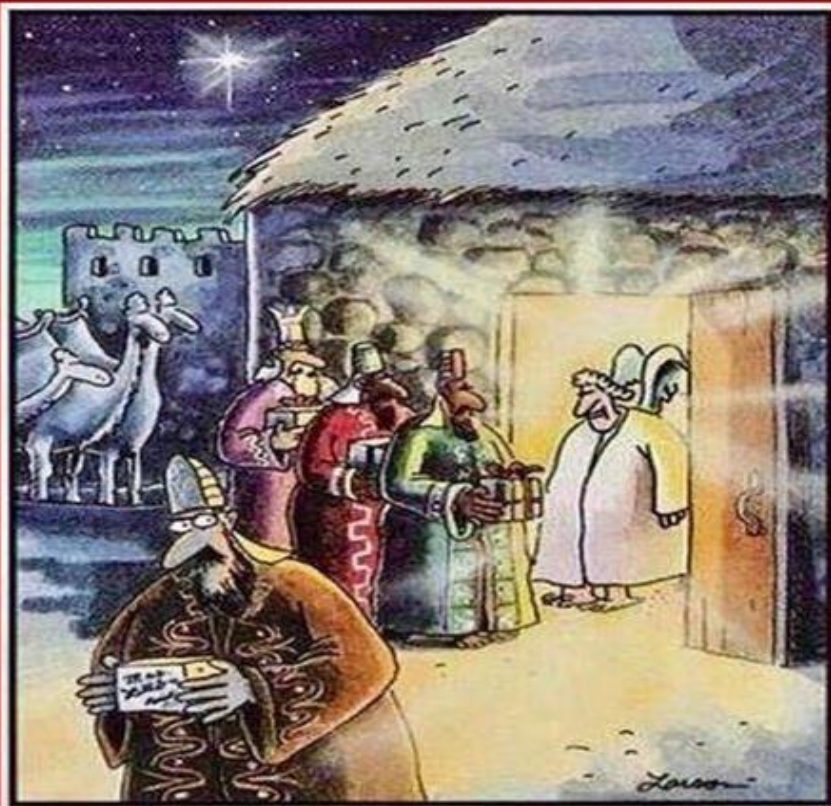

We have been hearing it for months - PACT ACT. The VFW has been a leader in getting it through congress and is a leader in promoting it. Where the name Agent Orange was named after the orange stripe around the 55-gallon drum that DIOXIN (a deadly poison used as a weed killer) came in, the Pact Act refers to the unwritten pact the American People had with the military to take care of our Veterans. Something that effectively started with Abraham Lincoln after the Civil War. The full name of the law is "The Sergeant First Class (SFC) Heath Robinson Honoring our Promise to Address Comprehensive Toxics (PACT) Act".

In the past 2 weeks I have had more people come to the office to apply for agent orange related issues that have come in for Pact Act related issues. Last week I saw three in a row that were in Vietnam, had agent orange health related issues and had never applied before. If you were Vietnam era and never applied before or applied more than 5 years ago you may fall under a court ruling issued in 1989 and modifications as late as December 2021! I got a letter in 2020 on a previous denial and after a new doctor's appointment was awarded service connection.

DO NOT be the veteran that comes into a service officer 30 years from now and says "I am wondering if I should apply for this PACT ACT thingy! "

The PACT ACT currently covers

- Open burn pits and other airborne hazards
- Gulf War-related exposures
- Agent Orange
- Radiation
- Camp Lejeune contaminated water exposure
- Other exposures Service on or after September 11, 2001, in any of these locations:
- Afghanistan * Djibouti * Egypt * Jordan * Lebanon * Syria * Uzbekistan * Yemen
- The airspace above any of these locations Service on or after August 2, 1990, in any of these locations:
- Bahrain * Iraq * Kuwait * Oman * Qatar * Saudi Arabia * Somalia * The United Arab Emirates (UAE)
- The air-space above any of these locations

I would like to thank all the Post and District chairmen who facilitated and cooperated in this year's Voice of Democracy, Patriot's Pen and Teachers Award programs.

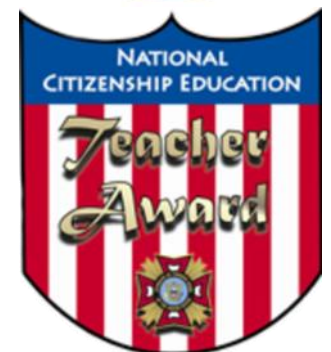

Army 1st Sgt. Leonard Funk served in some of the most pivotal campaigns in the European theater of World War II, making him one of the war's most decorated paratroopers. After jumping into Normandy on D-Day with the 82nd Airborne Division, he earned the Distinguished Service Cross during Operation Market Garden. His Medal of Honor was earned toward the end of the war when he led the capture of a German garrison during the Battle of the Bulge.

Funk was born 27 August 1916 and grew up east of Pittsburgh. He enlisted in the Army as a 21-year-old in June 1941, months before the U.S. entered World War II. He volunteered to be a paratrooper and was assigned to Company C of the 82nd's 508th Parachute Infantry Regiment. Funk was stationed in England for much of the war, although he didn't see action until June 6, 1944 — D-Day, the largest land, air and sea invasion in history.

On that day, the small unit he commanded landed nearly 40 miles inland. They fought for several days before breaking through enemy lines to rejoin their regiments closer to the coast. Everyone in Funk's unit survived that mission, and he earned a Silver Star Medal.

But that's a story for another time. Today we're focused on his heroics during the Battle of the Bulge.

On Jan. 29, 1945, Funk found himself in waist-deep snowdrifts with other American forces who had been fighting a massive contingent of German troops since mid-December. His unit had managed to advance 15 miles in a driving snowstorm so they could attack the German-held town of Holzheim, Belgium.

When the company's executive officer went down, Funk stepped up to take his place. He realized they didn't have enough infantrymen to take out the German garrison, so he gathered a platoon full of clerks — soldiers with noncombat jobs — and turned them into a fighting force.

Despite facing direct artillery shelling and gunfire, Funk's men moved in. They attacked and cleared 15 houses without suffering any injuries. With the help of another American unit, they quickly overran the town, taking about 80 German prisoners who were placed under a four-man guard. The rest of the dilapidated American forces, including Funk, scanned the town to mop up any isolated points of resistance.

A few hours later, an enemy patrol managed to trick the Americans acting as guards, freeing the German prisoners. They had begun to get into place to attack Company C from the rear when Funk returned to check on the prisoners. He walked right into the enemy patrol.

A German officer, poking a pistol into Funk's stomach, ordered him to surrender. The first sergeant pretended to comply with the order, slowly unslinging his submachine gun from his shoulder. But instead of giving it up, he quickly fired, emptying a full magazine into the German officer and his counterparts, all the while shouting to his American comrades to seize the enemy's weapons.

Within minutes, 21 Germans were killed, many more were wounded, and the rest were captured.

Despite being outnumbered and facing certain death, Funk's actions were directly responsible for the recapture of a force that was much larger than his own. His actions also allowed the other units of Company C to continue their attack plans unfettered.

Funk received the Medal of Honor for his actions on Sept. 5, 1945, at a ceremony at the White House. He's one of the most decorated paratroopers of World War II, having also earned the Bronze Star and Purple Heart with two oak leaf clusters. Martin Luther King, Jr. Day will be observed on Monday 16 January 2023, the third Monday every January. “Injustice anywhere is a threat to justice everywhere. We are caught in an inescapable network of mutuality, tied in a single garment of destiny. Whatever affects one directly, affects all indirectly.” – Dr. Martin Luther King, Jr., “Letter from Birmingham Jail”.

The month of February is a federally recognized commemoration for the contributions and achievements of African American figures in U.S. History. Every year, we remember trailblazers in science, math, arts and culture, politics, religion, and the military—encouraging us to celebrate the influence of African American key figures while overcoming adversity. Black History Month officially began almost a century ago and was originally only celebrated in the second week of February. Then named, “Negro History Week,” the events and promotions quickly expanded into the communities and became what we now know as Black History Month.

Four Chaplains Day is observed on 3 February 2023. This day of remembrance is celebrated across the country. It honors four military chaplains who sacrificed their own lives to save the lives of their fellow service members during WWII.

Troops must sacrifice creature comforts and familiar surroundings in order to forward deploy. And, at times, men and women of the military might have to make the ultimate sacrifice for their fellow soldiers, sailors, airmen, or Marines. However these sacrifices may be acknowledged, whether honored publicly or observed privately, they are a part of the reality that is serving in the military.

The National Salute to Veteran Patients takes place during the week of February 14 every year. This year, it takes place from February 12 to 18. The purpose of the holiday is to honor and pay tribute to the brave military veterans who receive medical care at Veterans Affairs (V.A.) medical facilities. The holiday also seeks to create more awareness about the importance of these centers and encourage more people to visit and volunteer.

President’s Day falls on Monday 20 February 2023. The observance of George Washington’s Birthday, 22 February 1732 is always the third Monday in February. The Federal holiday is officially recognized as Washington’s Birthday, though the Federal government has never legally changed the holiday to President’s day. However, where it gets complicated is at the state and local level, as they do not need to abide by Federal holidays. 24 U.S. states recognize President’s Day only, while 9 recognize Washington’s Birthday only, and 9 states do not observe any form of these holidays. Ultimately for many, it is how you choose to honor this day. As a day to recognize Washington’s birthday, or Lincoln’s birthday, or even all American Presidents, past and present.

UPCOMING COMMEMORATIVE DATES



March 24 - Start of Kosovo Campaign 1999

In 1999, once all diplomatic avenues had failed, NATO launched an air campaign to halt the humanitarian catastrophe unfolding in Kosovo. Operation Allied Force started on 24 March 1999 and was suspended on 10 June, lasting a total of 78 days. On 10 June 1999, the Federal Republic of Yugoslavia accepted the withdrawal of its military, police and paramilitary forces and the deployment of an effective international civil and security presence.



March 29 - National Vietnam War Veterans Day*

On March 29, 1973, combat and combat support units withdrew from South Vietnam. Generations later, Veterans of this time period are gaining the respect that was not so freely given upon their return. Involving five U.S. presidents, crossing nearly two decades and 500,000 U.S. Military personnel, it left an indelible mark on the American psyche. Returning veterans did not always receive respectful welcomes upon their arrival on American soil. Over 58,000 killed, never to return.



March 31 - End of Operation Restore Hope—Somalia 1995*

25 March 1994 Most of the American troops were out of Somalia, ending Operation Continue Hope the follow-on mission to Restore Hope. Only a few hundred marines remained offshore to assist with any noncombatant evacuation mission that might occur in the event violence broke out that necessitated the removal of the over 1,000 U.S. civilians and military advisers remaining as part of the U.S. liaison mission. All UN and U.S. personnel were finally withdrawn almost a year later in March 1995.



April 9 - National Former POW Recognition Day

It was officially designated by Congress in 1988 as a Presidentially-proclaimed observance. National Former POW Recognition Day commemorates the 9 April 1942 surrender of approximately 10,000 United States military personnel and 65,000 Filipino soldiers on the Bataan Peninsula in the Philippines by Major General Edward P. King to the invading Imperial Japanese Army headed by General Masaharu Homma. This is the largest surrender in US history. The surrender was followed immediately by the infamous Bataan Death March.



11 April - Persian Gulf War Official Cease-Fire

On 11 April 1991, less than 90 days after the U.S.-led offensive against Iraq known as Operation Desert Storm began, the United Nations Security Council declared the conditions of Resolution 687 in effect, making the cease fire official and formally ending the Persian Gulf War. The definitive victory elevated the United States as the preeminent global super power and the number one partner of choice for its allies around the world.
