

<u>DPA Around the Pacific Facebook</u>: Stay informed about Department activities and share events and achievements. If you are not a member, request to join.

# This year's All State Membership Program All State District Requirements

- The District and all Posts in the District must have Bylaws approved by the National Commander in Chief.
- The District Quartermaster or any other person accountable for District funds or property must be adequately bonded IAW SEC 703 of the National By-Laws.
- The District and all Posts in the District must have successfully completed the current year DPA inspection NLT 28 February 2026.
- The District must reach 100% +2 in membership by 30 June 2026 as posted in National MEMSTATS (or 15 April 2026 for recognition at the DPA Convention if an in-person event).
- The District must have an appointed Service Officer.
- The District and Post Service Officers in the District (as listed in the District/ Post Election Report, and GO1) must attend a mandatory DSO Training session.
- The District must conduct a minimum of 3 School of Instructions at a District meeting addressing the duties and responsibilities of District leadership positions. Report completion of training to the DPA SVC.







third month following the last month of the Audit. ALL audits must be into the DPA QM NLT 30 June 2026. Quarterly due dates are as follows:

Apr - Jun Voted on in July, Due to the DPA QM NLT 30 Sep


Jul - Sep Voted on in October and due to the DPA QM NLT 31 Dec

Oct - Dec Voted on in January and due to the DPA QM NLT 31 Mar Jan - Mar Voted on in April and due to the DPA QM NLT 30 Jun

- The District must participate in the Voice of Democracy (VOD), and Patriots Pen (PP) Programs by submitting ONE entry per program to the DPA VOD/PP Chairman for judging. In lieu of this requirement, the District may elect to send a \$125 donation per program to the VFW National Director of Programs for each program they do not participate in using the VMS Donation link from the VFW All American Dashboard. Donations will NOT be accepted by any other means. After donating, report the donation by forwarding a copy of the email receipt to the DPA VOD/PP Chairman at vodppdpa@vfwpacific.org.
- The District must donate a minimum of \$125 to the National Veterans and Military Support (VMS) Program. The donation shall be made via the VMS Donation link from the <a href="VFW All American Dashboard">VFW All American Dashboard</a>. Donations will NOT be accepted by any other means. After donating, report the donation by forwarding a copy of the email receipt to the DPA VMS Chairman at <a href="mappda@vfwpacific.org">mappda@vfwpacific.org</a>.
- Legacy Life: Each district must at a minimum add a total of New/Upgraded Members equal to the number of posts in their District with notification sent to the DPA SVC at <a href="svcdpa@vfwpacific.org">svcdpa@vfwpacific.org</a>.
- The District will participate in the Department Awards program submitting 1 district nominee to the DPA JVC for a minimum of one submission for one of the 10 categories for judging NLT 15 April 2026. District Award judging panels will include ALL Post Commanders in that District and a Post member from each post to ensure fair representation.
- The District will participate in the annual DPA fund raiser by purchasing a full page ad for \$200 in the "Year in Review" publication. Send donations to the DPA QM at <a href="mailto:qmdpa@vfwpacific.org">qmdpa@vfwpacific.org</a> and send the ad to the Year in Review chairman, PDC Larry Lyons at <a href="mailto:pdclyons935@gmail.com">pdclyons935@gmail.com</a>.

#### **All-State Post Commander Requirements**

- The Post must have Post Bylaws approved by the National Commander in Chief.
- The Post QM or any other person accountable for Post funds or property must be adequately bonded IAW SEC 703 of the National By Laws.
- The Post must have successfully completed the current year DPA Inspection NLT 28 February 2026.
- The Post must be 100% +2 in membership by 15 April 2026 for recognition at the June Department convention. If accomplished by 30 June 2026 recognition will be received at the Mid-Winter conference in December.
- The Post must have an appointed Service Officer.
- The Post Service Officer (as listed in the Post Election Report, and GO1) must attend a mandatory DSO Training session.







- The Post must conduct 3 School of Instructions at a Post meeting addressing Post Leadership Duties and Responsibilities. Report completion of training to the DPA SVC at svcdpa@vfwpacific.org.
- The Post must have submitted all quarterly Audits including March, June, September, and December to the DPA QM. Each Audit is due to the DPA QM no later than the last day of the second month following the last month of the Audit. ALL audits must be into the DPA QM NLT 1 June 2026. Quarterly due dates are as follows:

Apr - Jun Voted on in Jun and due to DPA QM NLT 31 Jul

Jul - Sep Voted on in Sep and due to DPA QM NLT 31 Oct

Oct - Dec Voted on in Dec and due to DPA QM NLT 31 Jan

Jan - Mar Voted on in Mar and due to DPA QM NLT 30 Apr

- The Post must be current in monthly DPA Community Service Reports (CSR) and must submit a minimum of 8 CSRs per quarter between 1 May 2025 and 30 April 2026. Point of contact is DPA JVC at jvcdpa@vfwpacific.org.
- The Post must participate in the Voice of Democracy (VOD), and Patriots Pen (PP) Award Programs by submitting at least one entry per program to the DISTRICT VOD/PP Chairman for judging. In lieu of this requirement, the Post may elect to send a \$125 donation per program to the VFW National Director of Programs for each program they do not participate in using the VMS Donation link from the <a href="VFW All American Dashboard">VFW All American Dashboard</a>. Donations will NOT be accepted by any other means. After donating, report the donation by forwarding a copy of the email receipt to the DPA VOD/PP Chairman at <a href="vodppd-pa@vfwpacific.org">vodppd-pa@vfwpacific.org</a>.
- The Post must donate a minimum of \$125 to the National Veterans and Military Support (VMS) Program. The donation shall be made via the VMS Donation link from the VFW All American Dashboard. Donations will NOT be accepted by any other means. After donating, report the donation by forwarding a copy of the email receipt to the DPA VMS Chairman at mapdpa@vfwpacific.org.
- Legacy Life: Each post must at a minimum add one New/Upgraded Member with notification sent to the DPA SVC at <a href="svcdpa@vfwpacific.org">svcdpa@vfwpacific.org</a>.
- The Post must participate in the Buddy Poppy program by purchasing 500 Buddy Poppies. Point of contact is DPA QM at <a href="mailto:qmdpa@vfwpacific.org">qmdpa@vfwpacific.org</a>.
- The Post will participate in the DPA Awards program submitting a minimum of one award nomination for submission for one of the ten department award categories to the District for judging NLT 30 March 2026. District Award judging panels will include ALL Post Commanders in that District and a Post member from each post to ensure fair representation.
- The Post Commander will attend ALL District meetings. If unavailable, they will send a Post representative, e.g., SVC, JVC or Post member who may attend in the Post Commanders absence and make the Commanders report.

Welcome to the 2024-2025 "*Teamwork. Together Everyone Achieves More*" term. It's an honor to serve as your Junior Vice Commander. Congratulations to all the newly elected and appointed Comrades!

This year is already in great hands with **Commander Farrell** and **Senior Vice Commander Kelley**. Let's continue our momentum and "Aim High" across all Posts and Districts.

Let's begin the year at a steady pace toward achieving All-State and All-American this year. Aim to complete requirements by the mid-winter conference to avoid the last-minute scramble.

CSRs: Please remember that the "C" in CSR stands for Community. So, let's get out and support our local Communities, Active-Duty Members, and Veterans. If it benefits the community (money out/volunteering/information out), it is a CSR; if it benefits the Post (money in/recruiting), it is not. If you need any help, please feel free to email me. CSR Best Practices.

- ALL-AMERICAN: minimum 1 CSR per quarter (1 Jul-30 Jun)
- ALL-STATE: minimum 8 CSRs per quarter (1 May-30 Apr)

**PROGRAMS**: Let's get a head start by engaging early with **Schools**, **Scouts**, **ROTC**, **CAP**, and **Emergency Services** agencies now to promote the scholarships and awards that the VFW offers.

Make it a priority to reach out to **international and DODEA schools** in your area; encourage participation in essay contests rather than just paying the donation. This boosts visibility for your Post and the VFW; it also provides meaningful opportunities for our youth.

- Action Required: Contact VOD/PP Chairman Robert Madison at <u>vodppd-pa@vfwpacific.org</u> early so he can get your online access set up early.
- Each Post/District Chairman must test their access and report any issues promptly for quicker resolution.
- Voice of Democracy/Patriot's Pen (All-State and All-American Requirement 1 entry for each or \$125 each for Post and District); Due to me by 7 Dec VoD/PP Guide
- Smart/Maher VFW National Citizenship Education Teacher Award; Due to me by 7 Dec Teacher Award Guide
- Public Servant and Safety Awards; Due to me by 1 Jan <u>Instructions</u>
- Scouting (Due to me by 1 Apr), CAP, and ROTC Awards Youth Activities Guide
- Day of Service Event in May (All-American Requirement) Must register prior to 15 May 2026 at <u>DoS Registration</u>

**Awards:** Let's not overlook the outstanding efforts of our own comrades. Recognizing excellence isn't just about ceremony—it's how we **retain and motivate members** by showing appreciation for their contributions. I feel that we do our members an injustice by not recognizing them.

- Award submissions from Districts are **due to me by 15 Apr**, along with a score sheet showing a vote from each Post commander and one additional Post member.
- All-State Requirement: nominate at least one awardee at both Post and District Levels and are due to me NLT 01 May DPA Awards Page.
- Don't forget about the Community Service Award which are due to me NLT
   01 Apr Community Service Award.

Let's make sure every deserving member gets the recognition they've earned.

Let's continue building a strong, sustainable Department by mentoring future leaders – have a backup for every position to ensure continuity and growth.

I am looking forward to an outstanding year working alongside Commander Farrell, Senior Vice Commander Kelley, and all our exceptional DPA comrades.


We are not picking on anyone, but this needs to be told!

I have yet to be turned down by any PX or BX here in Korea to do recruiting. It has been my experience that recruiting on the GI's Mid-Month paycheck works the best. They normally spend a lot of their paycheck on rent/commissary during the first of the month. Then again everyone does not live off base/post. Find out what works for you.

The National Membership Program is already online. I encourage everyone to review it. Besides the individual recruiting awards from VFW National there are cash awards to the department on reaching certain percentages. For reaching 102% the department will get \$2,000.00, for reaching 103% we would get \$4,000.00 and if we reach 105% like it looks like we will this year the Department would get \$7,500.00 in next year's program. Comrades that ain't bad!

If you recall a few months ago I stated in the Pacific Times that what Past Department Commander Dick Keeley use to say and that was 100% mean no growth. I have changed that for my saying and goal that 105% means that you are looking at the future of your post!



## MEDAL OF HONOR RECIPIENTS

Benjamin Franklin Wilson (June 2, 1921 – March 1, 1988) was a soldier in the United States Army during the Korean War. He received the Medal of Honor for his actions on June 5, 1951, during the UN May–June 1951 counteroffensive. Master Sergeant Benjamin F. Wilson, age 30, led Company I, 31st Infantry Regiment, 7th Infantry Division, in a direct assault against fortified enemy positions near Hwach'on-Myon, Korea.

Company I was ordered to take a heavily defended hill. The enemy outnumbered Wilson's unit. As the lead elements moved uphill, they came under intense automatic weapon and grenade fire. The attack stalled. Wilson took action. He moved forward alone under fire, charged the enemy machine gun nest, fired his rifle at close range, and threw grenades. He killed four enemy soldiers. He broke the enemy line.

He regrouped his men and led a bayonet charge directly into enemy trenches. In the close fighting, they killed roughly 27 enemy soldiers and drove the rest off the ridge. Wilson began organizing defenses. The enemy counterattacked almost immediately with another wave of soldiers.



Wilson moved out of cover alone again. He charged the enemy line and killed seven more enemy soldiers, wounded two others, and forced the rest to retreat. As he returned to his position, a third counterattack hit the company. Wilson directed the defense while under fire.

Company I pushed again toward the final objective. As they reached within 15 yards of the next ridge, they came under heavy fire. Wilson gave the order to withdraw. He stayed behind alone and delivered covering fire so the rest of the men could fall back without being cut down.

Then another counterattack hit. The company commander and 1st Platoon leader were both incapacitated. Wilson assumed command. He moved to the front and charged the enemy line. He killed three soldiers with his rifle. His rifle was knocked from his hands in the melee. He grabbed his entrenching tool, a small shovel, and continued fighting. He killed four more enemy soldiers in hand-to-hand combat.

With the enemy drive stopped, Wilson organized the company's defense and coordinated the evacuation of the wounded. He was hit again by enemy fire. He refused evacuation. He stayed on the line until all wounded were pulled back to safety.

His actions on June 5, 1951, resulted in at least 35 confirmed enemy dead. His aggression and control allowed Company I to hold their position and survive multiple counterattacks from a numerically superior force.

For his actions, Master Sergeant Benjamin F. Wilson was awarded the Medal of Honor.

On June 6, 1951, despite his injuries, Wilson returned to the front lines. He led another assault against enemy positions, killing 33 enemy soldiers using his rifle, bayonet, and grenades. During this engagement, he reopened his previous wounds and was finally evacuated to a hospital. For his actions on June 6, he was awarded the Distinguished Service Cross.

#### **DEPARTMENT SURGEON**

Fellow Comrades,

None of us are getting any younger and for that reason I am giving advice on how to care for our bodies so we will have a place to live when we get older. Please review the age group you fit in so you may live a longer, healthier life.

#### Female

Bone density test, discuss with provider at least once between 18 and 64. Get at least once age > 65 and discuss with provider. Breast tissue tests (Mammogram & self-care), test every 3 years ages 20 to 40 then testing every 2 years. Reproductive health PAP Test, done every 1 to 3 years if sexually active (18 to 64) then every 1 to 3 years. Pelvic Exam every year if sexually active (18 to 64) then discuss with provider.

#### Male

Prosthetic Health can be checked with a digital prostate exam (finger wave) if below 40 discuss with provider. If >/= 50 then check with provider to be tested every 5 or 10 years. Lastly for final checks men should do testicular checks.

#### Male/Female

ColoRectal exams are an all inclusive set of tests to check your colon top to bottom (sorry, couldn't resist) there is the fecal occult test to check blood in your stool, flexSig is checking one area for any issues and colonoscopy is checking another area for issues. Most times not an issue until >50 y/o so discuss with provider and adjustments will be made to test every 5 or 10 years. Discuss results with provider. Diabetes is performed as a blood test. Checked to see if there are issues with maintaining blood sugars. General Health exam is performed every 5 yrs after 35 y/o and discuss with provider along with Thyroid tests. Eyes and ears are usually tested at least once in your 20s and then every 2 to 4 years. Heart Health are usually monitored through BP testing and Cholesterol. If there are issues usually evaluated every 2 years but if no issues evaluated as normal every 5 years. Dental evaluation and treatment is evaluated twice per year. Mental Health screening is done as necessary. Examples are Anxiety, Depression, Addiction, etc. Discuss all issues with providers.

#### **Immunizations**

Flu vaccination is yearly. Pneumonia recommended for high risk patients. DPT is given every 10 years, Usually after an injury. Meningitis given per discussion with provider. HPV as discussed with providers. Shingles Vaccine >than age 60 and only 1 time after discussion with provider.


Comrades,

#### CHAIN OF COMMAND PROTOCOL

The Commander is the arbitrator of arguments and the judge in disputes. As a general rule, their decisions are considered correct until over-ruled by the Post meeting, the District, Department Commander or Commander-in-Chief. That being said, it is important to resolve issues at the lowest level possible. However, there are certain times when it is necessary to elevate your concerns to the next level.

- Local issues are not the responsibility of the District or Department Commander.
  - Try to resolve them in-house.
- Never bypass anyone in the chain of command.
- If the alleged allegations involve the Commander, immediately notify the Commander next in the chain.
- Should there be irregular identified during a routine audit, any noted discrepancies must be reported immediately to the Post/District membership.
- If you believe that the problem cannot be resolved at your level or may result in a more serious situation by all means elevate your concerns to the next appropriate level (District and/or Department) Commander so they are not blindsided.
- A written report shall be generated for every investigation.
  - The investigator or investigating committee will present their findings to the post membership,
     District Governing Body or Department Council as applicable.
- Record relevant issues in your minutes. Include the motion and the approval or disapproval as applicable.
- If the Post or District fails to act to correct noted deficiencies, immediately inform the Department Commander for further guidance.
- Issues brought before the Department Commander for action, shall be supported by all relevant documents. i.e., Investigation Report (with supporting documents), Copy of the Minutes showing approved action(s), and the Commanders recommendations.
- Educate yourself on the procedures for removing an elected officer of their duties.
  - Post Level, MOP Article II, Sec. 220
  - District Level, MOP Article IV, Sec. 420
- Educate yourself on the procedures for initiating disciplinary action and the members right to appeal.
  There is a fine line that separates the need for a simple corrective action and the need to initiate
  disciplinary action under Article IX. As an example: Misappropriation of funds is one of the offenses
  punishable by Article IX, Discipline. Do you simply remove the accused from office or Initiate
  Disciplinary action under Article IX? If initiated, it is imperative that proper procedures be followed.
  - MOP -Article IX, Sec. 902 Provides a list of offenses recognized by the VFW that may be subject to Disciplinary Action.
  - MOP Article IX, Sec. 907 Provides a list of Penalties that may be imposed for those offenses.
  - No member shall be subject to the penalties authorized in Section 907 unless such member has been advised in writing of the Charges and Specifications.
- Ensure any action taken is properly documented and withing the timelines specified in the MOP. Maintain
  a file copy of all correspondence to include receipts for certified mail (if applicable).
- Control Posts to Social-Media. Once it's posted the whole world knows. (Don't air your dirty laundry)

All Commanders are welcome to seek advice and guidance from the Department. If additional information is required or clarification is required, Department will reach out to National for assistance. We too have a Chain of Command.





#### A LITTLE BIT OF HISTORY

#### Unsung Heroes!

During the Vietnam War, the mechanics who maintained helicopters and fighter jets were vital yet often overlooked heroes, ensuring the air mobility that defined US military strategy. Working in harsh conditions at bases like Da Nang and Bien Hoa, these skilled technicians kept aircraft like the UH-1 Huey, AH-1 Cobra, and F-4 Phantom operational despite intense heat, monsoon rains, and constant enemy threats.

They performed complex repairs under tight deadlines, often salvaging damaged aircraft from rice paddies using Sikorsky Skycranes or improvising fixes with limited parts. Their expertise was critical for missions ranging from troop transport to close air support, with aircraft availability directly impacting battlefield outcomes. For instance, during the Battle of Ia Drang in 1965, mechanics worked around the clock to keep Hueys flying, enabling critical resupply and medical evacuations under heavy fire.

These mechanics, many of whom were young enlistees or draftees trained at places like Fort Wolters, Texas, faced immense pressure to maintain high operational readiness. They dealt with battle-damaged aircraft, trouble-shooting turbine engines and hydraulic systems while under the threat of mortar attacks or Viet Cong sabotage.

Their ingenuity was legendary—some fabricated tools from scrap metal or adapted civilian parts to keep aircraft aloft. Despite their critical role, few received recognition like the pilots they supported, yet their dedication saved countless lives by ensuring aircraft were ready for daring rescues and combat missions.

Their unsung efforts, often performed in grueling 12-hour shifts, were a backbone of the air war, enabling the U.S. to maintain air superiority and support ground forces across Vietnam's challenging terrain.



#### VMS/MAP CHAIRMAN

As the DPA VMS and MAP Chairman for this term, I'd like to remind everyone of a couple important requirements and opportunities.

Each Post must donate a minimum of \$125 to the National Veterans and Military Support (VMS) Program. This donation must be made via the <u>VMS Donation link</u> on the <u>VFW All American Dashboard</u>. This is an All-State requirement. To donate to any of the VFW programs, please visit the <u>VFW Programs Donations page</u>.

For Posts located near active military installations, the Military Assistance Program (MAP) offers an excellent opportunity to engage directly with service members. Hosting MAP events helps them see firsthand the work we do for veterans and our communities, which can make recruitment efforts much easier. If you're planning a MAP event, remember to apply for a MAP grant. Grants are awarded on a first-come, first-served basis, and funding often runs out before the end of the year.

#### POW/MIA CHAIRMAN

In 2024 and 2025, numerous events commemorating the 80th anniversary of the end of World War II in the Pacific Theater were held. Many of these events focused on the treatment of prisoners of war (POWs) and the issue of missing in action (MIA) personnel. Members of the Veterans of Foreign Wars (VFW) throughout the Department of Pacific Areas (DPA) actively participated in these observances, showcasing their commitment to the motto, "No One Does More for Veterans.

As my term as the DPA POW/MIA Chairman comes to an end, I would like to offer an overview of the United States personnel missing in Action (MIA) in the Pacific Theater during World War II, the Korean War, and the Cold War.

#### **American Missing in Action**

At the end of World War II, 78,750 Americans were classified as MIA, with half lost in the Indo-Pacific. The Korean War added over 8,000 MIAs. The U.S. honors fallen service members through Memorial Day (last Monday in May) and National POW/MIA Recognition Day (third Friday in September), the latter established by President Carter. The 2019 National POW/MIA Flag Act mandates displaying the POW/MIA flag at federal sites like the Capitol and White House.

Post-war recovery transitioned to the American Graves Registration Service (AGRS), now managed by the Defense POW/MIA Accounting Agency (DPAA). Ongoing efforts have reduced MIA numbers through remains identification and site investigations.

#### **Current MIA Statistics (2025):**

• World War II: 71,986 unaccounted (≈65% in Indo-Pacific)

Korean War: 7,446Vietnam War: 1,544

• Cold War: 126 (108 in Asia, 8 in Europe)

• Gulf Wars/Other: 6

Approximately 75% of unresolved cases are concentrated in the Indo-Pacific, with over 41,000 presumed lost at sea. The DPAA reports 81,137 total unaccounted personnel across all conflicts, while the American Battle Monuments Commission cites 84,768 MIAs (including 4,423 from WWI). These figures reflect the enduring legacy of U.S. military sacrifices and the persistent mission to achieve full accountability.



#### LEGISLATIVE CHAIRMAN

Comrades, it was nice to see everyone that attended the DPA Convention in Bangkok. This is just a short take of my report that I gave there. With the March 2025 Washington Conference now if the books. It was a pleasure, taking DPA CDR Lutman, National Council member Stein and Early Bird winner around the halls of congress. This year we had schedules to meet with the Legislative Assistant from the Office of Congresswoman King-Hinds, Ms. Ewing And Legislative Assistant from the office of Congressman Moylan, Mr. Lukas and Ms. Braiotta. We pitched the VFW March PRIORITIES which consist of the following issues:

**Unaddressed Toxic Exposures:** this is an extension to the PACT Act bill to have the VA report on all newly found toxic exposures to be added.

**Transition from Service:** (TAP Promotion Act) to codify VA's practice of including accredited claims representatives from national, state, and local organizations in joining TAP classes.

**UPDATE:** Congress re-introduced on 03/05/2025, bill H.R. 1845 TAP Promotion Act.

**Exploring Alternative PTSD Treatments:** Direct the Department of Defense and VA to implement innovative PTSD treatments currently used in the private sector. Direct VA to review its current mental health treatments and prescribing practices to address the possible over-reliance on pharmaceutical interventions.

Cracking Down on Predatory Claims Companies: The VFW is concerned that bad actors are preying on veterans by skimming their earned Department of Veterans Affairs (VA) benefits. Pass legislation that would prohibit the exploitation of veterans and survivors by unscrupulous Claim Sharks and strengthen the accreditation system.

**UPDATE:** Under the 119th Congress (2025-2026) re-introduced as, H.R.1732 - GUARD VA Benefits Act.

Guard and Reserve GI Bill Parity Act of 2025: To allow any day in uniform for which military pay is received to count toward Post-9/11 GI Bill eligibility, creating equity for National Guard and Reserve members

**Retirement and Military Personnel:** For more than two decades, Congress has failed to address the long-standing injustice of withholding military retirement pay from disabled veterans. Department of Defense (DOD) military retirement pay and Department of Veterans Affairs (VA) disability compensation are separate, distinct benefits earned for different reasons, yet

Congress continues to wrongly treat their concurrent receipt as "double-dipping." The VFW believes this policy is fundamentally unfair,

**UPDATE:** Congress re-introduced, bill H.R. 2102 Major Richard Star Act

As we did the briefing on the above, we asked the Congress person to take a look at the Bill and to cosponsor them on behalf of the Veterans of Foreign Wars (VFW).

#### A LITTLE BIT OF HISTORY

The Horse Manure Problem of 1894 The 15 to 30 pounds of manure produced daily by each beast multiplied by the 150,000+ horses in New York city resulted in more than three million pounds of horse manure per day that somehow needed to be disposed of. That's not to mention the daily 40,000 gallons of horse urine.

In other words, cities reeked. As Morris says, the "stench was omnipresent." Here are some fun bits from his article:

Urban streets were minefields that needed to be navigated with the greatest care. "Crossing sweepers" stood on street corners; for a fee they would clear a path through the mire for pedestrians. Wet weather turned the streets into swamps and rivers of muck, but dry weather brought little improvement; the manure turned to dust, which was then whipped up by the wind, choking pedestrians and coating buildings.

... even when it had been removed from the streets the manure piled up faster than it could be disposed of ... early in the century farmers were happy to pay good money for the manure, by the end of the 1800s stable owners had to pay to have it carted off. As a result of this glut . . . vacant lots in cities across America became piled high with manure; in New York these sometimes rose to forty and even sixty feet.

We need to remind ourselves that horse manure is an ideal breeding ground for flies, which spread disease. Morris reports that deadly outbreaks of typhoid and "infant diarrheal diseases can be traced to spikes in the fly population."

Comparing fatalities associated with horse-related accidents in 1916 Chicago versus automobile accidents in 1997, he concludes that people were killed nearly seven times more often back in the good old days. The reasons for this are straightforward:

... horse-drawn vehicles have an engine with a mind of its own. The skittishness of horses added a dangerous level of unpredictability to nineteenth-century transportation. This was particularly true in a bustling urban environment, full of surprises that could shock and spook the animals. Horses often stampeded, but a more common danger came from horses kicking, biting, or trampling bystanders. Children were particularly at risk.

Falls, injuries, and maltreatment also took a toll on the horses themselves. Data cited by Morris indicates that, in 1880, more than 3 dozen dead horses were cleared from New York streets each day (nearly 15,000 a year).

#### **SOMETHING TO PONDER**

"When 79-year-old George retired, he didn't buy a golf club or a hammock. He hung a handmade sign in his garage window: "Broken things? Bring 'em here. No charge. Just tea and talk."

His neighbors in the faded mill town of Maple Grove thought he'd lost it. "Who fixes stuff for free?" grumbled the barber. But George had a reason. His wife, Ruth, had spent decades repairing torn coats and cracked picture frames for anyone who knocked. "Waste is a habit," she'd say. "Kindness is the cure." She'd died the year before, and George's hands itched to mend what she'd left behind.

The first visitor was 8-year-old Mia, dragging a plastic toy truck with a missing wheel. "Dad says we can't afford a new one," she mumbled. George rummaged through his toolbox, humming. An hour later, the truck rolled again—this time with a bottle cap for a wheel and a stripe of sil-



ver duct tape. "Now it's custom," he winked. Mia left smiling, but her mother lingered. "Can you... fix a résumé?" she asked. "I've been stuck on the couch since the factory closed."

By noon, George's garage buzzed. A widow brought a shattered clock ("My husband wound it every Sunday"). A teen carried a leaky backpack. George fixed them all, but he didn't work alone. Retired teachers proofread résumés. A former seamstress stitched torn backpacks. Even Mia returned, handing him a jar of jam: "Mom says thanks for the job interview."

Then came the complaint.

"Unlicensed business," snapped the city inspector. "You're violating zoning laws."

Maple Grove's mayor, a man with a spreadsheet heart, demanded George shut down. The next morning, 40 townsfolk stood on George's lawn, holding broken toasters, torn quilts, and protest signs: "Fix the law, not just stuff!" A local reporter filmed a segment: "Is kindness illegal?"

The mayor caved. Sort of.

"If you want to 'fix' things, do it downtown," he said. "Rent the old firehouse. But no guarantees."

The firehouse became a hive. Volunteers gutted it, painted it sunshine yellow, and dubbed it "Ruth's Hub." Plumbers taught plumbing. Teenagers learned to darn socks. A baker swapped muffins for repaired microwaves. The town's waste dropped by 30%.

But the real magic? Conversations. A lonely widow fixed a lamp while a single dad patched a bike tire. They talked about Ruth. About loss. About hope.

Last week, George found a note in his mailbox. It was from Mia, now 16, interning at a robotics lab. "You taught me to see value in broken things. I'm building a solar-powered prosthetic arm. PS: The truck still runs!"

Today, 12 towns across the state have "Fix-It Hubs." None charge money. All serve tea.

Funny, isn't it? How a man with a screwdriver can rebuild a world."

This is the marching order to blend with Communicating.


