Nominations and Elections 2024-2025



We are now in the nomination and election season for all posts and districts in the VFW for the 2024-2025 term.

Nominations are opened at the post general membership meeting in March and remain open until elections at the post general member-ship meeting in April. Section 215 - 217 of the National Bylaws and Manual of Procedure provides guidance.

District nominations are opened at the meeting prior to the District Convention and remain open until the election during the District Convention. Section 415 - 417 of the National Bylaws & Manual of Procedure provides guidance.

In April posts will be electing those officers as well as the delegates for districts and department conventions. It is important to carefully consider your nominations and elect worthy leaders for all officer and delegate positions. Remember, you are electing the leaders of your post or district and they set the tone for your organization. It is also helpful to elect a Commander who is familiar with the chain of command within our organization and if possible, someone who is known at the Department level to be an honest, thoughtful, and dedicated comrade.

The process of electing delegates is laid out in the National Bylaws and Manual of

Procedure, as well as in your District and Department Bylaws. If you have questions or are unsure of the process, go to the District or Department JAG and they will provide answers or get you an answer as required.



NATIONAL COUNCIL MEMBER

Hello Comrades,

During the first week of March the National Council will be meeting in Washington, D.C. I will provide you with an update as to what was discussed as it relates to our organization nationally and of course specific discussion points applicable to our great Department. This information will be provided in the May/June Pacific Times.

As to current National initiatives, the VFW National Veterans Service (NVS) office in partnership with our Department Service Officer Al Fitchett, conducted a virtual benefit forum that was available to all veterans living in the Pacific Areas.

The Foreign Medical Program's (FMP) Program Management Officer Andy Szymczak presented a briefing on the FMP program. Specifically, how we arrived at the current situation, while recognizing the many challenges within the program, how those issues will be resolved, and some of the causes of those problems.

The two issues that cause the most consternation for our comrades living in the Pacific are the method of reimbursement for treatment of service connected disabilities, and the lack of response from the FMP office in a timely manner.

Andy reported a new IT system is being worked that will initially help with a better response time to veterans, and ultimately will be able to easily access the VA database.

Regarding the method of reimbursement, i.e., paper checks versus electronic fund transfer (EFT) and how we can have those reimbursements directly deposited electronically into our bank accounts, we were informed it will be resolved, but no date of when is available now.

It is well known this is a major source of financial concern to our comrades and the VA and FMP along with contractors are working towards deciding the best way to move forward and resolve this untenable situation. The new FMP IT system will be part of that solution.

Finally, FMP initially seemed to be focused on resolving payments via EFT to providers, but they were advised veterans should be the priority, or at the very least provide solutions simultaneously to veterans and providers.

The Pacific Areas continues to lead the way Nationally in membership. Bravo Zulu to Membership chair SVC Mike Lutman, and National Recruiter PDC Larry Lyons. But as you know all their hard work and leadership wouldn't mean much without the effort all of you are putting forth in retaining and recruiting. Due to your outstanding efforts our Department is poised to ensure we will grow and be able to meet the challenges of the future.

We trace our roots back to 1899 when veterans of the Spanish-American War (1898) and the Philippine Insurrection (1899-1902) founded local organizations to secure rights and benefits for their service. Many arrived home wounded or sick. There was no medical care or veterans' pension for them, and they were left to care for themselves. In their misery, some of these veterans banded together and formed organizations that would eventually band together and become known as the Veterans of Foreign Wars of the United States.

Our Mission: To foster camaraderie among United States veterans of overseas conflicts. To serve our veterans, the military and our communities. To advocate on behalf of all veterans.

MEDAL OF HONOR RECIPIENTS

William Shemin (October 14, 1896 – August 15, 1973) was a Sergeant in the U.S. Army during World War I. He was awarded the Medal of Honor for bravery in action at Vesle River, near Bazoches, France. On June 2, 2015, Elsie Shemin-Roth and her sister Ina Bass accepted the nation's highest military award for valor on behalf of their father from President Barack Obama at the White House. Shemin was assigned to Company G, 47th Infantry Regiment, 4th Division, American Expeditionary Forces.[1]

William "Bill" Shemin was born in Bayonne, New Jersey. During his teenage years, he played semi-pro baseball. He graduated from the New York State Ranger School in 1914 and went on to work as a forester in Bayonne. Shemin enlisted in the Army, October 2, 1917. Upon completion of basic training at Camp Greene, North Carolina, he was assigned as a rifleman to Company G, 47th Infantry Regiment, 4th Infantry Division, American Expeditionary Forces, in France.

While serving as a rifleman from August 7–9, 1918, Shemin left the cover of his platoon's trench and crossed open space, repeatedly exposing himself to heavy machine gun and rifle fire to rescue the wounded. After officers and senior non-commissioned officers had become casualties, Shemin took



command of the platoon and displayed great initiative under fire, until he was wounded on August 9. It was for this action that Shemin was originally awarded the Distinguished Service Cross on December 19, 1919. Some 96 years later, this Distinguished Service Cross award would be upgraded to the Medal of Honor. Shemin was hospitalized for three months as a result of the wounds he suffered in this action which included those from shrapnel and a machine gun bullet that pierced his helmet and lodged behind his left ear. Following his recovery, he served on light duty as part of the Army occupation in Germany and Belgium until he completed his tour. Shemin received the Purple Heart for his combat wounds.

Shemin was honorably discharged in August 1919, and went on to get a degree from the New York State College of Forestry at Syracuse University.[2] After graduation, he started a greenhouse and landscaping business in the Bronx, New York, where he raised three children. Shemin died in 1973.

With the most utter disregard for his own safety, (Shemin) sprang from his position in his platoon trench, dashed out across the open in full sight of the Germans, who opened and maintained a furious burst of machine gun and rifle fire.





Greetings Comrades,

Since I've been serving as your Judge Advocate every year brings the same question. How come the Post Counts (members in good standing) is different from the Memstats Counts (Paid for 2024)?

The answer is really quite simple. That old cliché "Follow the Money" If your post receives payment from National for a life or annual member that member counts towards your Memstats Counts. Dues paid for the current term.

If a member transfers out of your post and your post has received dues payment for that member this term, they too are still counted in the Memstats Counts (Paid for 2024). Because that member is no longer a member of your post. He is removed from the Post Counts (members in good standing)

If a member transfers into your post and their previous post was paid for their membership the transferred member will not count on your Memstats Counts roster until the following term.

Annual members that have not paid their dues do not appear on the Post Counts (members in good standing)

Deceased Members do not appear on the Post Counts (members in good standing)

Sec. 222 - Delegates, District Convention & Meetings, Department and National Conventions.

Delegate strength shall be one for every thirty members or fraction thereof in good standing. Delegates and alternates shall be elected in accordance with the Manual of Procedure.

Delegates and alternates for the District Convention and Meetings, Department and

National Conventions shall be elected at a regular meeting in April. Delegate strength will be based on members in good standing as of March 31st.

MIGS 245/30 = 8.16 (Rounded Up for the fraction of) = 9 Post Delegates

Delegates and alternates of each Post shall serve as delegates throughout the year provided they remain members in good standing in the respective Post within the District.

Membership Eligibility

One of the qualifying conditions for eligibility in the VFW is Hostile Fire or Imminent Danger Pay.

I have received several questions regarding qualifying conditions for VFW Membership using Hostile Fire or Imminent Danger. The only sure way to validate a member has received either of these is to look at their Military Pay records or Leave and Earnings Statements (LES)

Hostile Fire Pay (HFP) not to be confused with Hazardous Duty Pay (HDP) is determined by an Event. To receive HFP, the event, when as certified by the appropriate commander, a member is subjected to, hostile fire, explosion of hostile mines, or other hostile action (a Hostile fire event)

Imminent Danger Pay (IDP) is determined by a Threat. IDP is paid to a service member who is subject to the threat of physical harm or imminent danger on the basis of civil insurrection, civil war, terrorism, or wartime conditions in a designated foreign area. DoD 7000.14-R Volume 7A, Chapter 10 provides a table of the most current listing of the approved designated area.

Proposed Amendments and Resolutions

Now is the time to start working on any Proposed Changes to the Department Bylaws, National Bylaws, Manual of Procedure or Ritual.

PREPARING A PROPOSED AMENDMENT TO THE NATIONAL BY-LAWS, MANUAL OF PROCEDURE OR RITUAL

Bylaws: Any member in good standing, a Post, a District, or a Department, may propose an amendment to the National Bylaws; provided, however, before consideration at the National Convention, the proposed amendment must be approved by a Department Convention.

Manual of Procedure and Ritual: Any Post, District, or Department may propose an amendment to the Manual of Procedure or Ritual; provided, however, before consideration at the National Convention, the proposed amendment must have been forwarded, through channels and have been properly approved.

This is also that time of year when we hold our District Convention and changes can made to your District Bylaws. Please refer to the MOP Sec. 402

Changes to our Department Bylaws are covered in the MOP Sec. 502

PREPARING A RESOLUTION TO BE CONSIDERED BY THE NATIONAL CONVENTION

The policy of the Veterans of Foreign Wars is established by resolutions adopted by the delegates attending Department and National Conventions. Most resolutions originate at the Post level and are passed through the District and Department before being acted upon at a National Convention. Many times, an otherwise worthy idea gets nowhere merely because it is not correctly presented.

A LITTLE BIT OF HISTORY

Buffalo Bill Cody and Texas Jack Omohundro were two legendary figures of the American frontier whose exploits became the stuff of Wild West legend. Their partnership and adventures not only captivated audiences during their time but also left an indelible mark on American popular culture.

William Frederick "Buffalo Bill" Cody was born in 1846 in Iowa Territory. He earned his nickname as a young man while working as a buffalo hunter for the Kansas Pacific Railroad, where he reportedly killed thousands of buffalo to feed the railroad workers. Cody's skills as a hunter and his larger-than-life persona made him a natural showman, and he eventually found fame as the star of Buffalo Bill's Wild West, a traveling extravaganza that showcased cowboy skills, Native American performers, and reenactments of frontier life.



Texas Jack Omohundro, born John Baker Omohundro in 1846 in Virginia, was another larger-than-life character of the American West. Like Cody, Omohundro was a skilled outdoorsman and hunter. He earned the nickname "Texas Jack" during his time as a cowboy in Texas, where he became known for his expert horsemanship and marksmanship.

The paths of Buffalo Bill and Texas Jack crossed in the early 1870s when they both worked as scouts for the U.S. Army during the Indian Wars. Their shared experiences on the frontier forged a strong friendship, and they soon decided to join forces to capitalize on their fame and skills. In 1872, they formed a partnership and began touring with their own stage show, "The Scouts of the Prairie."

"The Scouts of the Prairie" was a theatrical production that featured Cody and Omohundro reenacting their adventures on the frontier. The show was a hit with audiences across the country, who were eager to hear tales of daring buffalo hunts, Indian battles, and other thrilling escapades. Cody's charisma and showmanship complemented Texas Jack's rugged charm, and together they became two of the most famous men in America.

Their partnership was not without its challenges, however. Cody and Omohundro had contrasting personalities – Cody was outgoing and gregarious, while Texas Jack was more reserved – and their egos sometimes clashed. Despite this, they remained loyal friends and business partners, and their partnership continued to flourish.

In 1873, Cody and Omohundro traveled to Europe with their show, where they performed for Queen Victoria and other European dignitaries. The tour was a resounding success and helped solidify their status as international celebrities. Upon their return to the United States, they continued to tour with their show, thrilling audiences from coast to coast.

However, by the late 1870s, tensions between Cody and Omohundro had begun to strain their partnership. Texas Jack's heavy drinking and erratic behavior put a strain on their friendship, and in 1878, the two men decided to part ways professionally. Cody continued to tour with Buffalo Bill's Wild West, while Texas Jack pursued other ventures, including a brief stint as a lawman in Texas.

Despite their eventual split, the partnership between Buffalo Bill Cody and Texas Jack Omohundro left an enduring legacy. Together, they helped shape the image of the American West in the popular imagination and inspired countless dime novels, stage productions, and Hollywood films. Today, their names are synonymous with the spirit of adventure and romance that characterized the Wild West.

DEPARTMENT SERVICE OFFICER (DSO)

Greetings Comrades.

FMP "Pre-Determination Letter"

Effective September 2023 FMP has established an office to issue individual coverage letters, guaranteeing payment of a specific service-connected condition. This is not the same as your standard benefit letter you receive from FMP.

If you require a medical procedure for a specific service-connected condition shown on your standard benefits letter, you would now request a "predetermination letter" which will state that veteran <u>John Doe</u> is entitled to all medical procedures / expenses that are related to the specific service-connected condition. **Example:** John Doe now requires dialysis for his service-connected kidney condition listed on his FMP Benefit Letter.

The Veteran can now contact their Veterans Service Officer (VSO) who can check the qualification and forward your request to the appropriate authority at FMP via a special link established specifically for issuing your "pre-determination letter".

LEGISLATIVE CHAIRMAN

Comrades, here is a run-down for this year's VFW 2024 Priority Goals.

Budget

To fully fund programs for veterans, service members, and their families, Congress must:

- Reform the dysfunctional federal budget process.
- Never reduce one veteran's benefits to pay for another.
- Authorize VA to receive reimbursements from TRICARE and Medicare.

Education, Employment, and Transition Assistance

To ensure veterans succeed after leaving military service, Congress, VA, DOD, and DOL must:

- Improve education benefits through increased online student housing allowances, childcare stipends, parity for Guard and Reserve members, and elimination of delimiting dates.
- Enhance outreach and counseling to veterans eligible for the Veteran Readiness and Employment program.
- Ensure parity of VA and DOD education programs with other federal programs.
- Expand small business, hiring preference, tax incentives, and entrepreneurship resources for veterans and military spouses.
- Increase funding for HUD-VASH vouchers, grant and per diem payments, and pilot programs to combat veteran homelessness.
- Conduct oversight of VA's Transition Assistance Program to ensure compliance with the law, and require the inclusion of accredited claims representatives.
- Eliminate red tape preventing effective use of education and employment benefits
- Provide housing relief for surviving spouses.

Disability Assistance and Memorial Affairs

To ensure veterans and their survivors have timely access to earned benefits, Congress and VA must:

- Crack down on unaccredited claims consultants known as Claim Sharks.
- Study all toxic and environmental exposures and implement programs to ensure health care and benefits are provided to all exposed service members and veterans.
- Properly oversee and update the modernized appeals process and digital claims processing.
- Increase Dependency and Indemnity Compensation benefits for survivors.
- Improve the accuracy of disability compensation claims related to military sexual trauma.
- Increase burial allowances to account for inflation.
- Ensure that earned VA benefits are never offset by the use of other federal benefits.

Health Care

To ensure service members and veterans receive timely access to high-quality health care without increasing cost shares, Congress, VA, and DOD must:

- Eliminate service member and veteran suicide by addressing both clinical and non-clinical needs.
- Strengthen care and research for mental health and traumatic brain injuries.
- Improve oversight of Vet Centers to ensure adequate staffing, resources, and funding.
- Enhance programs and services for women and underserved veterans.
- Eliminate copayment requirements for preventive health care and medications.
- Research the efficacy of medical cannabis and other alternative therapies.
- Preserve the integrity of TRICARE.
- Properly implement VA and DOD health IT systems.
- Expand nursing home eligibility and long-term care options.
- Enhance services for veterans outside of the United States.

Military Quality of Life

To maintain a quality, comprehensive benefits and retirement package that is the backbone for preserving the all-volunteer force, Congress and DOD must:

- End the military retirement pay and VA disability compensation offset.
- Protect and improve on-base quality of life and support programs.
- Eliminate sexual assault and harassment from the military.
- Increase military base pay comparability with private sector wages.
- Ensure that military housing is safe and free of toxic substances.
- Eliminate food insecurity in the military.
- Ensure equity of benefits for Reserve Component service members.

National Security, Foreign Affairs, and POW/MIA

To fully support the all-volunteer force, protect our nation's citizens, and defend American interests around the world, Congress and DOD must:

- Ensure DPAA is fully funded to perform its personnel recovery mission.
- Expand partnerships with host nations and private/public organizations to achieve the fullest possible accounting of U.S. military personnel missing from all wars.
- Deter threats to our national security by supporting our allies in Ukraine, Israel, Korea, and Taiwan.
- Ensure all service members who served in harm's way, to include foreign nationals, receive the recognition, care and benefits they have earned.
- Provide recognition and support for Afghan and Iraqi translators and allies.
- Award the Armed Forces Expeditionary Medal for operations in Eastern Europe




1 May Loyalty Day - Loyalty Day originally began as "Americanization Day" in 1921 as a counter to the Communists' May 1 celebration of the Russian Revolution. On 1 May 1930, 10,000 VFW members staged a rally at New York's Union Square to promote patriotism. Through a resolution adopted in 1949, May 1 evolved into Loyalty Day. Observances began in 1950 on April 28 and climaxed May 1 when more than five million people across the nation held rallies. In 1958 Congress enacted Public Law 529 proclaiming Loyalty Day a permanent fixture on the nation's calendar.



May 8 V-E Day - On May 8, 1945 - known as Victory in Europe Day or V-E Day - celebrations erupted around the world to mark the end of World War II in Europe. The war had been raging for almost five years when U.S. and Allied forces landed on the beaches of Normandy, France, on June 6, 1944. The invasion signaled the beginning of the end for Adolf Hitler and Nazi Germany. In less than a year, Germany would surrender, and Hitler would be dead.



31 May 2021 Memorial Day - Memorial Day is an American holiday, observed on the last Monday of May, honoring the men and women who died while serving in the U.S. military. Originally known as Decoration Day, it originated in the years following the Civil War and became an official federal holiday in 1971. Many Americans observe Memorial Day by visiting cemeteries or memorials, holding family gatherings and participating in parades. Unofficially, it marks the beginning of the summer season.



6 June 1944 D-Day - On 6 June 1944, more than 160,000 Allied troops landed along a 50-mile stretch of heavily-fortified French coastline, to fight Nazi Germany on the beaches of Normandy, France. Gen. Dwight D. Eisenhower called the operation a crusade in which, "we will accept nothing less than full victory." More than 5,000 Ships and 13,000 aircraft supported the D-Day invasion, and by day's end, the Allies gained a foot-hold in Continental Europe.



14 June Flag Day - Flag Day is celebrated by Americans on June 14 each year and commemorates the adoption of the Stars and Stripes as the official flag of the United States. Many Americans celebrate Flag Day by displaying the Red, White and Blue in front of homes and businesses. Some communities, schools and veterans' organizations hold Flag Day parades, essay contests, ceremonies and picnics.


