Several pandemic protocols will need to carry over into the new year if there's going to be any hope of slowing the spread of the virus, health experts say. Until the majority of the population is vaccinated and more information is available on the vaccines' ability to stop virus transmission, [masks](#) are still going to be needed. The same goes for [physical distancing](#), [frequent hand-washing](#) and avoiding crowded indoor areas.

"If we all work together doing that and getting vaccinated, it'll get us quicker to the end point, which is to go back to normal life," Ostrosky-Zeichner says. Another behavior that should carry into 2021: Get your [flu shot](#) if you haven't already, Vermund says. This will help the health care system from becoming overstressed. "I truly believe that if we all work together, and focus for the next three or four months, we can go back to normal life as we know it," Ostrosky-Zeichner adds.

March 5 - US Navy Seabees Birthday

Since March 5, 1942, the U.S. Navy has employed an elite cadre of construction battalion Sailors, better known as Seabees. Guided by the motto, “We Build, We Fight,” Since then the Seabees have been the Navy's construction force, building bases and airfields, conducting underwater construction, and building roads, bridges, and other support facilities. They play a crucial role in supporting the fleet and combatant commands while carrying out the Navy's maritime strategy. Seabees also play an important role in sustaining global relationships. Seabees are forward deployed around the world to provide engineering and construction support while promoting regional stability and improving lives through engineering civic action projects in many countries.

March 24 - Start of Kosovo Campaign 1999

In 1999, once all diplomatic avenues had failed, NATO launched an air campaign to halt the humanitarian catastrophe unfolding in Kosovo. Operation Allied Force started on 24 March 1999 and was suspended on 10 June, lasting a total of 78 days. On 10 June 1999, the Federal Republic of Yugoslavia accepted the withdrawal of its military, police and paramilitary forces and the deployment of an effective international civil and security presence.

March 31 - End of Operation Restore Hope—Somalia 1995

25 March 1994 Most of the American troops were out of Somalia, ending Operation Continue Hope the follow-on mission to Restore Hope. Only a few hundred marines remained offshore to assist with any noncombatant evacuation mission that might occur in the event violence broke out that necessitated the removal of the over 1,000 U.S. civilians and military advisers remaining as part of the U.S. liaison mission. All UN and U.S. personnel were finally withdrawn almost a year later in March 1995.

On Saturday, December 19th, a troop of two Boy Scouts of America Lone Scouts girls did a “Scouting for Food” project in the hills behind Clark International Airport. Lone Scouts do not have a sponsoring organization, their parents run the program and cover the costs. Their plan was to provide a package containing a full day’s meal, along with hygienic supplies, to 180 indigenous Aeta mountain tribe children.

They began taking collections in October at VFW Robert W. Zaher Post 2485, Angeles City Philippines. A donation box was set up and members began dropping off food items.

The Scouts met on a rainy morning to decide if the weather would allow the day’s program to begin as the road to the village was turned into mud in a rain-storm. They made it to the site and began setting up at 9am. Prior to handing out the packages, every child was given a mask, some hand sanitizer, then a dinner roll. At first only a few kids showed up, however an hour later they had handed out 300 food packages to the children.

There are approximately 160 children in the Foundation. The land and facility were donated from several local philanthropists. A Staff of 35 people include Physical Education and Music Teachers, Social workers and psychologists, Cooks Maids and Drivers. Income comes solely from donations from individuals, businesses, government offices and organizations. It was an honor and privilege for our Post to make a contribution and to see amazing people do fantastic work for their community.

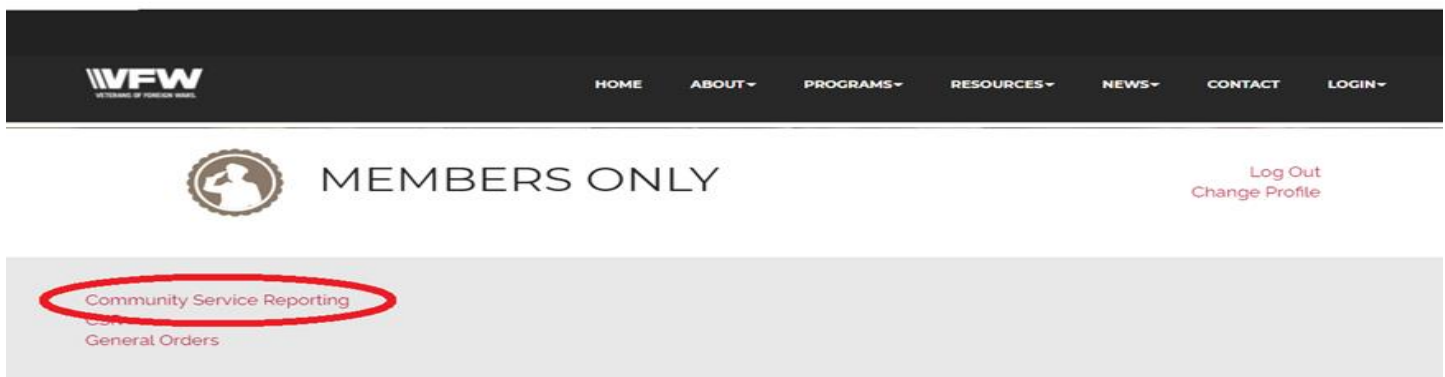

WANTED

FOR ROBBERY OF VETERANS

There are many companies & individuals who are breaking the law by charging veterans to file claims for benefits.

The law only authorizes the following individuals to assist in the preparation of claims for benefits:

- VA Accredited Attorneys
- VA Accredited Agents
- VA Accredited Vet Service Organization Representatives
- VA Accredited State / County Representatives
- VA Regional Office Representatives
- A private individual with one-time permission granted by the VA to assist one claimant

No One including those above can charge or financially gain for providing assistance to veterans to file a claim

The only time a fee may be charged is after a claim for benefits has been denied and then only by Accredited Attorneys or Agents!

If you see a situation like this, file a report with the Office of the General Counsel for the Department of Veterans Affairs. 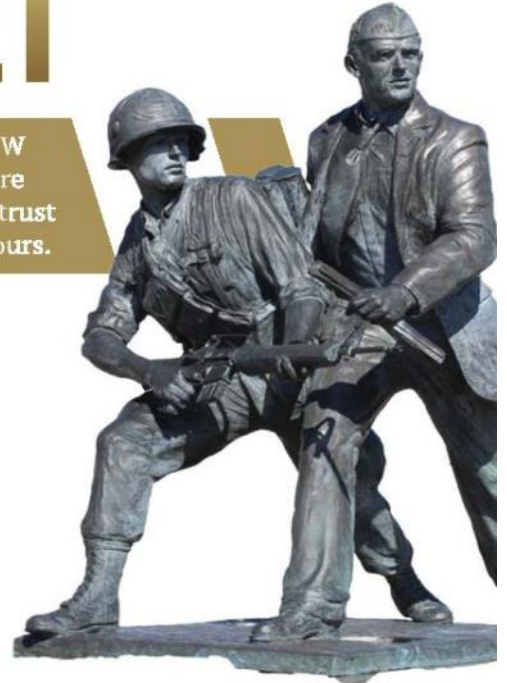

DPA JUDGE ADVOCATE

Greetings Comrades,

2020 Has certainly been a year we would all like to forget. I've washed my hands so much my exam notes from 1969 are starting to show through. Hopefully, everyone had a safe **Holiday Season** and the **New Year** will bring you and your families much joy and happiness.

National Senior Vice Commander-in-Chief Matthew M. "Fritz" Mihelcic was in attendance at the DPA C-of-A and informed us that there will be a National Convention next year even if we can't meet in person and that there will be major changes to the National Bylaws and Manual of Procedures next year, to include a complete re-write of Article IX.

If anyone is planning to recommending a change, here are the general guidelines for submitting a change to the VFW Bylaws or Manual of Procedures.

PREPARING A PROPOSED AMENDMENT

TO THE NATIONAL BYLAWS, MANUAL OF PROCEDURE OR RITUAL

Bylaws: Any member in good standing, a Post, a District, or a Department, may propose an amendment to the National Bylaws; provided, however, before consideration at the National Convention, the proposed amendment must be approved by a Department Convention. Immediately following a Department Convention, the proposed amendment(s) must be forwarded to National Headquarters.

Manual of Procedure and Ritual: Any Post, District, or Department may propose an amendment to the Manual of Procedure or Ritual; provided, however, before consideration at the National Convention, the proposed amendment must have been forwarded, through channels and have been properly approved.

In order to meet National Bylaw/Manual of Procedure Article XIV requirements, to provide fifteen (15) day notice to all Posts of all amendments, the Adjutant General requests all amendments be forwarded to National Headquarters no later than five (5) working days following the close of the Department Convention.

Bylaw, Manual of Procedure or Ritual changes not in proper form, unclear as to meaning, or concerning matters clearly not within the scope and purpose of the Veterans of Foreign Wars cannot be considered by the National Convention.

A proposed change to the National Bylaws, Manual of Procedure or Ritual must be submitted as such, not as a resolution. Proposed amendments must be definite and specific as to the verbiage to be deleted or added. Use of the most recent amended copy of the National Bylaws, Manual of Procedure and Ritual is encouraged, as proposed changes considered by Convention delegates cannot be amended on the floor.

The current copy of the National Bylaws, Manual of Procedures and Rituals was amended July 24, 2020, Effective August 23, 2020.

I hope you all had a Merry Christmas and a Happy New Year!!

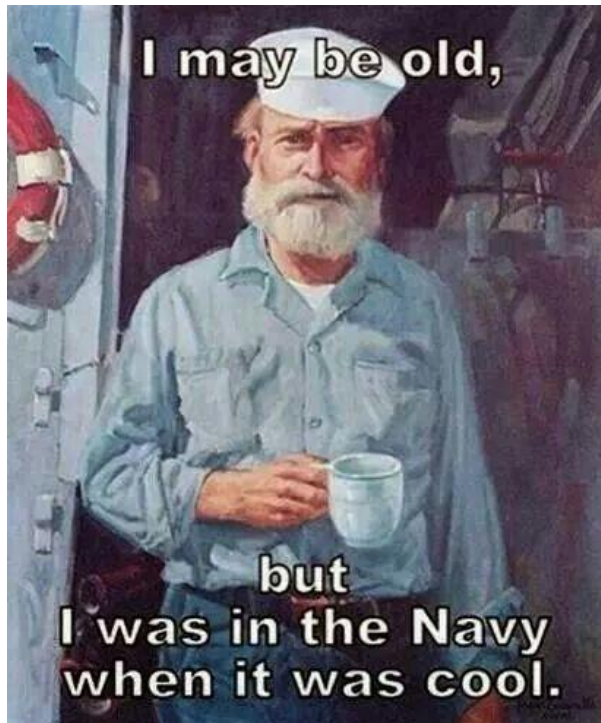
